4 Abstract

5 *Objective*

6 To evaluate whether gestational age was associated with the severe maternal morbidity7 (SMM) of preterm cesarean delivery between 22 and 34 weeks of gestation (weeks).

8 Material and Methods

9 We performed an observational retrospective cohort study in two tertiary university hospitals 10 in 2018. We included all mothers of preterm infants born by caesarean delivery between 22 11 and 34 weeks, excluding mothers with multiple births greater than two, with pregnancy 12 terminations or stillbirths, and who died unrelated to obstetrical causes. The principal 13 endpoint, SMM, was a composite outcome (classical uterine incision, postpartum hemorrhage 14 defined by blood loss \geq 500 mL, blood transfusion, any injury to adjacent organs, unplanned 15 procedure/need for reintervention, Intensive Care Unit (ICU) stay longer than 24 hours, 16 postpartum fever, and/or death).

17 Results

Among the 252 women, SMM occurred in 89 (35.3%) cases. After multivariate analysis, 18 19 gestational age was independently associated with SMM (adjusted Odds Ratio [aOR] 0.87; 20 95% Confidence Interval [CI] 0.78-0.97). The other variables statistically associated with 21 SMM were type of pregnancy with a negative association with twin pregnancy (aOR, 0.44; 22 95% CI, 0.20-0.93) and a positive association with general anesthesia (aOR, 2.52; 95% CI, 23 1.25-5.13). A sensitivity analysis was performed and found an association, at the limit of 24 significance, between gestational age < 28 weeks and SMM (aOR, 1.80; 95% CI, 0.99-3.27, p 25 = 0.05).

26 Conclusion

- 27 Lower gestational age was associated with the risk of SMM for preterm cesarean delivery
- between 22 and 34 weeks. Obstetricians should integrate this knowledge into their shared
- 29 decision-making processes with parents.

33 Introduction

The survival of preterm infants born between 22 and 28 weeks of gestation (weeks) has
increased worldwide in the past few decades.^{1–3} In France, a national population-based cohort
study "EPIPAGE 2" reported a 14.4% increase in global neonatal survival without adverse
outcomes between 1997 and 2011.⁴

38 The improvement in the survival of these extremely preterm infants is related to the 39 development of neonatal proactive management as well as active antenatal care, such as caesarean delivery in the case of fetal indications.^{5,6} Preterm caesarean delivery rates have 40 regularly increased, particularly before 26 weeks.^{1,2,7,8} However, European and American 41 cohorts of preterm infants reported variable rates of caesarean delivery before 26 weeks.^{1,2,4,6,7} 42 These heterogeneous care practices can be observed across and within countries⁵ and can be 43 associated with disagreements in team care.⁹ A shared decision-making process is essential in 44 situations at risk of extremely preterm delivery and should take into account available data 45 46 regarding neonatal and maternal morbidity. Many studies have reported on neonatal morbidity 47 in relation to the mode of delivery, but there is currently a paucity of data regarding maternal morbidity in relation to preterm caesarean delivery.^{10–13} In the case of term delivery, a severe 48 49 maternal morbidity (SMM) associated with caesarean delivery is higher compared to SMM after vaginal delivery.^{14–16} Few studies have assessed the SMM of extremely preterm 50 caesarean delivery as well as the association between gestational age and SMM.^{17,18} We have 51 52 recently reported a secondary analysis of a population-based cohort study, demonstrating that 53 mothers undergoing a caesarean delivery before 26 weeks experienced more than a two-fold 54 increase in the risk of SMM compared with those undergoing a caesarean delivery between 26 and 34 weeks.¹⁹ The strength of this previous study was its specific prospective population-55 56 based cohort design, with its main limitation being the evaluation of SMM (defined as the 57 occurrence of severe postpartum hemorrhage defined by the use of a blood transfusion,

- 58 intensive care unit admission, or death) using available maternal variables from this cohort of
- 59 preterm infants.
- 60 To confirm the hypothesis that lower gestational age is associated with a greater risk of SMM
- 61 of preterm caesarean delivery, we performed as a sensitivity analysis, a recent retrospective
- 62 cohort study in local tertiary care centers.

63	Material	and	Methods

64 *Study population and setting*

We performed an observational retrospective cohort study in two tertiary university hospitalsin Marseille, France between January and December 2018.

67 We included all the mothers of preterm infants born by caesarean delivery between 22 and 34

68 weeks, excluding mothers with multiple births greater than two, mothers with a history of

69 pregnancy terminations or stillbirths, and case of maternal death unrelated to an obstetrical

70 cause.

72 Data collection

Maternal, obstetrical, and neonatal data were collected retrospectively from each mother'sand infants' electronic medical files.

77 *Outcomes and studied factors*

78 The principal endpoint, Severe Maternal Morbidity (SMM), was a composite outcome

79 defined as the occurrence of at least one of the following complications:

80 - classical uterine incision (referring to an incision in the upper uterine segment and

81 because classical incision leads to a caesarean delivery upon the next pregnancy and

82 therefore increases the global maternal morbidity rate);

83 - postpartum hemorrhage defined as blood loss \geq 500 mL (as defined by the World

Health Organization and French clinical guidelines ²⁰);

85 - blood transfusion;

e any injury of adjacent organs (gastrointestinal, urological, or vascular),

87 - unplanned procedure/need for reintervention;

88

- Intensive Care Unit (ICU) stay longer than 24 hours in duration;

89 - postpartum fever;

90 - and/or death.

91 This composite endpoint was chosen as a synthesis of prior definitions of severe maternal
92 morbidity in these clinical situations literature and depending on available data during the stay
93 of the mother.^{18,19,21-23}

94 The main studied factor was gestational age at caesarean delivery. As a sensitivity analysis, 95 gestational age was also studied as a binary variable with the threshold of 26 and 28 weeks, 96 the usual thresholds defining extreme and very high prematurity, respectively. Gestational age 97 was routinely determined by the first trimester ultrasound and verified before any extremely 98 early caesarean delivery. If the first trimester ultrasound was not performed (less than 5% of 99 the women), gestational age was best estimated based on the last menstrual period and its 100 consistency with the measured head circumference of the earliest prenatal ultrasound. 101 The other studied factors were as follows: maternal age, parity, scarred uterus, Body Mass 102 Index (BMI) (calculated based on pre-pregnancy weight), active smoking during pregnancy, 103 pregestational diabetes, notable maternal pathologies, previous preterm delivery, known 104 uterine malformations, type of pregnancy (singleton or twin), type of prematurity 105 (spontaneous or induced), type of anesthesia, uterine injury during extraction, any difficulty 106 during fetal extraction, and a five-minute Apgar score. Indications of caesarean delivery were 107 also collected depending on the principal identified cause reported in the medical files and divided into six mutually exclusive groups, as previously published in cohort EPIPAGE 2:²⁴ 108 109 preterm labor without preterm premature rupture of membranes, preterm premature rupture of 110 membranes, hypertensive disorders without suspected fetal growth restriction, hypertensive 111 disorders with suspected fetal growth restriction, placental abruption after an uncomplicated 112 pregnancy, and suspected fetal growth restriction without hypertensive disorders. Suspected

fetal growth restriction was defined by an estimated fetal weight in less than the 5th centile on
 customized birth weight curves.²⁵

The Data Protection Authority (*General Data Protection Regulation / AP-HM no. 2018-89*) approved this study. According to French regulations, this study is exempt from institutional board review, because it is an observational and retrospective investigation using anonymized data from medical records. The mothers were informed that their records would be used for the evaluation of medical practices and that they could opt out of these studies.

121 Statistical analysis

We first described the principal characteristics of our study population. Categorical variables
were presented as effectives, percentages, and continuous variables, were shown as mean ±
standard deviation (SD).

We then performed a univariate analysis to compare maternal, obstetrical, and neonatal characteristics depending on the occurrence of SMM. Categorical variables were compared with a χ^2 test or Fisher exact test when appropriate. For the continuous variables, the data were analyzed using *t* tests or a Mann-Whitney test when appropriate.

129 We performed a multivariate logistic regression model to quantify the association between 130 gestational age and SMM with an adjusted odds ratio (aOR) and a 95% confidence interval 131 (95% CI). The variables included in the multivariate model were (i) gestational age (main 132 factor studied); (ii) notable maternal pathologies and type of prematurity (forced variables due 133 to known prognostic interest in the literature); and (iii) variables with p values < 0.20 in the 134 univariate analysis (candidate variable). A stepwise backward regression was applied in order 135 to keep only statistically significant variables and forced adjusting variables in the final model. Firth correction was applied to take into account the small number of events.²⁶ There 136 137 were no missing data concerning the main studied factors and the principal endpoint. Data

- 138 was analyzed using R studio V.1.2.1335, and the R package logistf was used. All tests were
- 139 two-sided, with statistical significance defined as p < 0.05.

140 **Results**

141 *Population*

142 Among the 5401 women who delivered at the two tertiary centers, 1400 mothers had a

143 caesarean delivery, 797 (56.9%) in Conception hospital and 603 (43.1%) in North hospital

between January and December 2018, and 262 (18.7%) women had a caesarean delivery

between 22 and 34 weeks. More precisely, 262 women had a cesarean delivery between 24

and 34 weeks since no cesarean delivery was perform before 24 weeks during the study

147 period. After the application of the exclusion criteria, 252 women were included in the study

148 (Figure 1).

149 The maternal, obstetrical, and neonatal characteristics of the study population are described in

150 Table 1. We couldn't present the results of umbilical arterial pH since we had missing data.

151 Among the 34 (13.5%) mothers presenting notable maternal pathology, eight with chronic

152 hypertension, three with cardiac pathology (e.g., dilated cardiomyopathy with cardiac

transplantation, restrictive cardiomyopathy, or rhythm troubles), three with nephropathy, two

154 with infectious chronic diseases (e.g., VIH, VHC), three with thrombophilia, two with

155 hemoglobin S disease, four with neurologic pathology (e.g., multiple sclerosis, epilepsy, or

156 brachycephalic trunk hypoplasia), two with antiphospholipid syndrome or lupus, one with

157 hematologic pathology (e.g., Willebrand), one with Crohn's disease, two with pulmonary

158 pathology (e.g., cystic fibrosis with pulmonary transplantation), and two with venous

thromboembolism were identified.

160 SMM occurred in 89 (35.3%) of the cases: 30 (12%) mothers had postpartum hemorrhage, 19

161 (7.5%) needed blood transfusions, three (1.2%) had injuries to adjacent organs (urological or

162 vascular), five (2%) had unplanned procedures/return to theatre (because of abscess or

hematoma of abdominal wall), 11 (4.4%) were admitted to the ICU, 15 (6%) presented

- 164 postpartum fever, and one mother died. The death of this mother occurred during caesarean
- 165 delivery performed for severe preeclampsia and was due to pulmonary embolism.
- 166 The cesarean delivery was performed in 67 (26.6%) cases in the context of spontaneous
- 167 prematurity. In these cases, the indications of the cesarean delivery were mostly: breech
- 168 presentation in 41 (61.2%), non-reassuring fetal hearth rate in 7 (10.4%) and suspected intra-
- 169 uterine infection in 7 (10.4%).
- 170 Univariate analysis
- 171 The following factors were positively associated with SMM: gestational age (29.2 ± 2.6)
- 172 weeks vs 30.1 ± 2.5 weeks; p=0.01), known uterine malformations (3(3.4%) vs 0; p=0.03),
- 173 general anesthesia (21 (23.6%) vs 18 (11.0%); p=0.01), and uterine injury during extraction
- 174 (6 (6.7%) vs 2 (1.2%); p=0.02). Twin pregnancy was negatively associated with SMM (11
- 175 (12.4%) vs 37 (22.7%); p=0.04) (Table 2).

177 Multivariate analysis

After multivariate analysis, gestational age was independently associated with SMM (adjusted
Odds Ratio [aOR] 0.87; 95% Confidence Interval [CI] 0.78-0.97; *p*=0.01) (Table 3). The

180 other variables statistically associated with SMM were type of pregnancy with a negative

- 181 association with twin pregnancy (aOR, 0.44; 95% CI, 0.20-0.93; p=0.03) and with general
- anesthesia (aOR, 2.52; 95% CI, 1.25-5.13; *p*=0.01). The other variables included in the
- 183 multivariate analysis (e.g., notable maternal pathology and type of prematurity) were not
- 184 independently associated with SMM.
- 185 Two sensitivity analyses were then performed with the same variables and with a gestational
- age according to two modalities (< 26 weeks and \geq 26 weeks; < 28 weeks and \geq 28 weeks).
- 187 This analysis failed to find a significant association between gestational age < 26 weeks and
- 188 SMM (aOR, 2.01; 95% CI, 0.77-5.31, p = 0.15). It did, however, find an association (at the

- 189 limit of significance) between gestational age < 28 weeks and SMM (aOR, 1.80; 95% CI,
- 190 0.99-3.27, *p* = 0.05).

191 **Discussion**

192 Our study showed that gestational age was independently and negatively associated with

193 SMM in the case of preterm caesarean delivery between 22 and 34 weeks. More precisely,

194 gestational age between 24 and 34 weeks was negatively associated with SMM since no

195 cesarean delivery was performed before 24 weeks.

196 These results confirm our findings from a national population-based cohort study, EPIPAGE

197 2.¹⁹ Whereas previous articles reported a higher rate of SMM for caesarean delivery than

198 vaginal delivery regardless of gestational age^{14,27–29} or an association between prematurity and

199 maternal morbidity regardless of the mode of delivery,^{21,30} our study confirmed the

association between gestational age and SMM in the case of preterm caesarean delivery.

Twin pregnancy, which has a high incidence within the population of preterm deliveries (19%

in our study), was independently and negatively associated with SMM for preterm caesarean

203 delivery. This result is consistent with the hypothesis that the SMM of extremely preterm

204 caesarean delivery is related to the incision of a deepen myometrium. In fact, in the case of

205 extremely preterm singleton delivery, the lower uterine segment is usually not yet formed. In

contrast, in the case of extremely preterm twin delivery, the lower uterine segment forms
earlier, and the incision takes place in a thinner myometrium. This is consistent with previous
published results about the increased risk of intraoperative adverse events in the case of

singleton pregnancy.¹⁸

We did not find an independent association between SMM and notable maternal pathology, even if highly heterogeneous, or between SMM and the type of prematurity (spontaneous or induced). This is an additional concept to consider that the SMM of preterm caesarean delivery is related to the surgical act itself. General anesthesia was significantly associated with SMM. This could be explained because of the maternal indication of general anesthesia in most cases (hellp syndrome for example).

216 We reported SMM in 89 (35.3%) of the cases in our cohort, which is substantial. This finding 217 should be included in shared decision-making process between parents, neonatologists, and 218 obstetricians, particularly if vaginal delivery could be considered as an option (e.g., 219 spontaneous preterm labor without abnormal fetal heart rate). In accordance with a patientcentered approach,³¹ shared decision-making aims to enable patients "to take an active role in 220 221 deciding about and planning their health care". The shared decision-making process, and 222 particularly the agreement between obstetricians and neonatologists, is essential, as previously 223 reported by Guinsburg et al..⁹ In fact, disagreement in the proactive management of extreme 224 prematurity has been associated with an increased risk of death of 2.39 times in the first day of the neonates.⁹ In ten European regions between 2003 and 2012, the lowest gestational age 225 226 at which maternity units reported performing a caesarean delivery for the acute distress of a 227 singleton non-malformed fetus significantly decreased when parents were in favor of active 228 management (from an average of 24.7 weeks in 2003 to 24.1 weeks in 2012) and when 229 parents were against of active management (from an average of 26.1 weeks in 2003 to 25.2 weeks in 2012).³² The shared decision-making process should take into account these practice 230 evolutions, the wishes of parents, and available data.³³ As recently suggested by Sandall et al., 231 232 the key message of the information delivered to the parents could be "a caesarean section is a 233 life-saving intervention for specific complications during pregnancy and childbirth that should 234 be available for all women in need" and "a caesarean section also confers an increased risk of 235 maternal morbidity, severe acute morbidity, and adverse outcomes in subsequent pregnancies when compared with vaginal delivery".³⁴ 236

The strength of our study was its evaluation of SMM. Despite the retrospective design of the study, the prospective filling of each electronic medical file allowed us to obtain reliable data and define a composite outcome with consistent variables. In the literature, the definition of SMM is not standardized, but we chose to generate a "synthesis" of each identified definition.

241 In fact, SMM is sometimes defined as a blood transfusion and/or hysterectomy to define 242 severe postpartum hemorrhage, ICU admission, death, and length of hospitalization exceeding 243 seven days.³⁵ Other studies have defined SMM as the occurrence of an infection, surgical injury, endometritis, readmission, or reopening or an unexpected procedure.^{21,23} The threshold 244 245 of 500 mL and not 1000 mL was chosen to define postpartum hemorrhage in our cohort of 246 cesarean deliveries and could be discussed. We chose to follow French and international 247 definition²⁰ and think that this is not a limit since we only compared women having cesarean 248 deliveries and not women having vaginal delivery versus cesarean delivery. We did not 249 choose maternal hospital stays exceeding seven days in our composite outcome, because, in 250 this case, the length of stay could be related to neonatal hospitalization. 251 The main limitation of our study was its small size. Although our study took place in only two 252 centers, the recency of the collection of data (2018) optimizes the external validity of our 253 results. Furthermore, the short duration of the inclusion period allowed us to avoid bias 254 related to the evolution of practices over time, as it was in previous published retrospective studies.¹⁸ The aOR of the gestational age < 26 weeks is close to the aOR we reported in our 255 256 previous study.¹⁹ Due to a lack of power, we failed to find a significant association between 257 gestational age < 26 weeks and SMM in the present analysis. 258 Our study suggests that lower gestational age is related to a greater risk of SMM for preterm 259 caesarean delivery between 22 and 34 weeks. These results should encourage reflection,

260 research, and teamwork between neonatologists and obstetricians to improve agreement and

shared decision-making processes with parents.

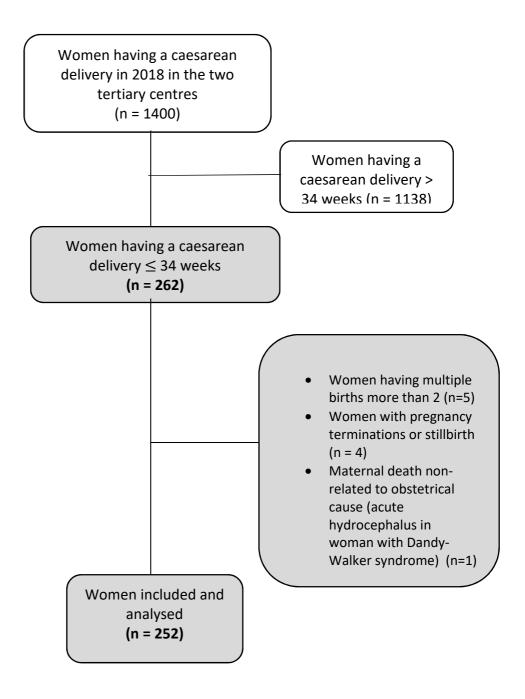


Figure 1 Flow chart of the study population
