67 **Abstract**8 Unlike most cancers, adrenocortical carcinomas (ACC) are more frequent in women than men, but  
9 the underlying mechanisms of this sexual dimorphism remain elusive. Here, we show that  
0 inactivation of *Znrf3* in the mouse adrenal cortex, recapitulating the most frequent alteration in  
1 ACC patients, is associated with sexually dimorphic tumour progression. Although female  
2 knockouts develop metastatic carcinomas at 18 months, adrenal hyperplasia regresses in male  
3 knockouts. This male-specific phenotype is associated with androgen-dependent induction of  
4 senescence, recruitment and differentiation of highly phagocytic macrophages that clear-out  
5 senescent cells. In contrast, in females, macrophage recruitment is delayed and dampened, which  
6 allows for aggressive tumour progression. Consistently, analysis of TCGA-ACC data shows that  
7 phagocytic macrophages are more prominent in men and associated with better prognosis.  
8 Altogether, these data show that phagocytic macrophages are key players in the sexual dimorphism  
9 of ACC that could be novel allies in the fight against this devastating cancer.  
01 **Teaser:** Androgen-dependent senescence induces recruitment of phagocytic macrophages,  
2 preventing adrenocortical carcinoma development.

## 4 MAIN TEXT

### 6 Introduction

8 Apart from reproductive tissues, cancer incidence and mortality are higher in males than females  
9 (1, 2). Together with thyroid cancer (3), adrenocortical carcinoma (ACC), which arises from  
0 steroidogenic cells of the adrenal cortex is one of the rare exceptions to this rule. Indeed, ACC  
1 female-to-male ratios range from 1.5 to 2.5:1 and women are generally diagnosed at a younger age  
2 (Fig S1A) (4–7). Although the higher rate of steady state proliferation and more efficient adrenal  
3 cortex renewal in females (6, 8, 9) may play a role in sexually dimorphic tumorigenesis, the  
4 mechanisms underlying female prevalence of ACC remain elusive.

6 ACC is an aggressive cancer, with about 35% of patients presenting with metastatic disease at  
7 diagnosis. Overall, 5 year survival rates range between 16% and 47% and decrease to around 10%  
8 for metastatic patients (10). In line with the steroidogenic activity of the adrenal cortex, ACC is  
9 associated with hormonal hypersecretion in more than 50% of patients (11). The vast majority of  
0 secreting ACC produce excess glucocorticoids, but some tumours also produce sex steroids or in  
1 some rare instances, aldosterone (12).

3 Radical surgical resection of ACC is the most effective therapeutic strategy for localized tumours,  
4 but the risk of recurrence remains high (12). In patients with advanced inoperable or metastatic  
5 ACC, the adrenolytic compound mitotane, a derivate of the insecticide DDT (Dichloro-Diphenyl-  
6 Trichloroethane), remains the standard of care, used as a single agent or in combination with an  
7 etoposide-doxorubicin-platin polychemotherapy, depending on prognostic factors (13–16).  
8 Although these treatments can improve recurrence free survival, their benefit on overall survival is  
9 still debated (12, 13, 17–19). Several phase I/II clinical trials of immune checkpoint inhibitors  
0 targeting PD-1 and PD-L1, have also been conducted in ACC patients (20–23). Unfortunately, these  
1 were associated with low response rates and have failed to improve patient outcome significantly.  
2 One potential reason for these modest results is the low level of lymphocyte infiltration in ACC  
3 (24), which appears to be associated with local production of glucocorticoids (25).

5 Understanding the molecular underpinnings of ACC pathogenesis is thus of utmost importance to  
6 develop novel therapeutic approaches. Large scale pan-genomic studies have identified  
7 homozygous deletion of *ZNRF3* as the most frequent genetic alteration in ACC (26, 27). This gene  
8 encodes a membrane E3 ubiquitin-ligase that inhibits WNT signalling by inducing ubiquitination

9 and degradation of Frizzled receptors (28, 29). We previously showed that conditional ablation of  
0 *Znrf3* within steroidogenic cells of the adrenal cortex, resulted in moderate WNT pathway  
1 activation and adrenal zona fasciculata hyperplasia up to 6 weeks, suggesting that ZNRF3 was a  
2 potential tumour suppressor in the adrenal cortex (30). However, we did not evaluate later stages  
3 of tumour progression.

4  
5 Here, we show that tumour progression following ablation of *Znrf3* within steroidogenic cells of  
6 the adrenal cortex is sexually dimorphic. Whereas most female mice develop full-fledged metastatic  
7 carcinomas over an 18 month-time course, adrenal hyperplasia gradually regresses in male  
8 knockout mice. We show that male-specific regression of hyperplasia is associated with induction  
9 of senescence, recruitment of macrophages and differentiation of active phagocytes that clear out  
0 senescent steroidogenic cells. Although some degree of macrophage recruitment is observed in  
1 female mice, it is delayed and dampened compared to males, which allows for tumour progression.  
2 This phenomenon is dependent on androgens and can be triggered by testosterone treatment in  
3 females. Interestingly, even though macrophages are present within adrenal tumours at 18 months,  
4 active phagocytes, characterised by expression of the TAM receptor MERTK are mostly found in  
5 males but not females. Consistent with our observations in mice, analysis of RNA sequencing data  
6 from the TCGA cohort of ACC shows that phagocytic macrophages are more prominent in men  
7 than women and associated with better prognosis. Altogether, these data establish that phagocytic  
8 macrophages prevent aggressive ACC development in male mice and suggest that they may play a  
9 key role in the unusual sexual dimorphism of ACC in patients.

## 0 **Results**

### 3 **Sexually dimorphic tumour progression in *Znrf3* cKO adrenals**

4 We previously showed that adrenal targeted ablation of *Znrf3* resulted in strong zona fasciculata  
5 hyperplasia at 6 weeks of age, but we did not evaluate the phenotype at later stages (30). To gain  
6 further insight into the potential tumour suppressor function of ZNRF3 in the adrenal cortex, we  
7 conducted a kinetic analysis from 4 to 78 weeks (Fig 1). In female *Znrf3* cKO mice (ZKO, Fig  
8 S1B), adrenal weight increased progressively from 4 to 6 weeks and remained higher from 9 to 52  
9 weeks. At 78 weeks, a majority of female *Znrf3* cKO adrenals showed a more than 7-fold increase  
0 in weight compared to controls (ZKO median 35.3 mg, vs 4.6 mg for control Fig 1A). This  
1 suggested malignant transformation of adrenals over time. Consistent with this idea, introduction  
2 of the mTmG reporter in the breeding scheme (Fig S1B) allowed identification of multiple micro  
3 and macro-metastases in the local lymph nodes, peritoneal cavity, liver and lungs of 75% of female



4 *Znrf3 cKO* mice at 78 weeks (Fig 1B and Fig S1C). Histological analysis of adrenals that were  
5 associated with metastatic development (Fig 1C) showed complete disorganisation of the cortex  
6 that was mostly composed of densely packed small basophilic cells. This was associated with a  
7 significant increase in Ki67 labelling index (Fig 1C & D), although proliferation was rather  
8 heterogeneous throughout the tumour with areas showing up to 25% Ki67 labelling (Fig S1D). In  
9 contrast, in the few mutant mice where no metastases were found at 78 weeks (indolent ZKO),  
0 adrenals were largely hyperplastic, but cells retained a relatively normal morphology and Ki67  
1 labelling was similar to control (Fig 1C). Altogether, these data suggested that ZNRF3 behaved as  
2 a classical tumour suppressor in female mice, its ablation resulting in a high frequency of aggressive  
3 ACC formation at 78 weeks. In sharp contrast, although male *Znrf3 cKO* adrenals were also larger  
4 at 4 and 6 weeks, adrenal weight steadily declined thereafter, almost returning to normal at 78  
5 weeks (Fig 1E). This was associated with lack of metastatic progression (Fig 1F), benign histology  
6 and low Ki67 labelling index (Fig 1G & H), although some patches of higher proliferation could  
7 be detected in some adrenals (Fig S1D). This suggested that overall tumour development was  
8 rapidly blunted in males, although the initial hyperplastic phase was equivalent to females.  
9 To further gain insight into this sexually dimorphic phenotype, we evaluated proliferation from 4  
0 to 52 weeks. Analysis of Ki67 labelling index showed that following an early significant increase,  
1 both males and females had a rapid arrest in proliferation from 6 weeks onwards (Fig 1I & Fig  
2 S1E). The steady decline in adrenal weight, despite comparable proliferation in male knockout  
3 adrenals and controls after 4 weeks, suggested that an active mechanism counteracted tumour  
4 progression in males. Surprisingly though, there was no increase in apoptosis, measured by cleaved  
5 caspase 3 staining, in either female or male adrenals at 6 and 12 weeks (Fig S1F). To try to further  
6 understand the sexually dimorphic phenotype, we conducted a careful kinetic evaluation of adrenal  
7 histology. This showed a similar hyperplastic phenotype in males and females at 4 and 6 weeks  
8 (Fig 1J). Hyperplasia progressed in females with accumulation of small basophilic cells that  
9 composed most of the gland by 52 weeks (Fig 1J). Strikingly, starting at 12 weeks, we observed  
0 progressive thinning of the cortex (eosinophilic cells) and concomitant appearance and expansion  
1 of multinucleated giant cells (MGCs containing up to 12 nuclei per cell) that progressively took  
2 over a large proportion of the male *Znrf3 cKO* gland (up to 40%) (Fig 1J). In females some MGCs  
3 were also observed. However, they were first visible at 24 weeks and only represented a small  
4 proportion of the gland, even at 52 weeks (Fig 1J). Interestingly, MGCs were reminiscent of fused  
5 macrophages that are observed in granulomatous inflammatory diseases, which suggested a  
6 potential involvement of innate immune cells in preventing tumour progression in male *Znrf3 cKO*  
7 adrenals.

## 9 **Regression in male *Znrf3* cKO adrenals is correlated with macrophage infiltration and fusion**

0 To further gain insight into the underpinnings of the regression phenomenon, we analysed global  
1 gene expression by bulk RNA sequencing of control and *Znrf3* cKO male adrenals at 4, 6 and 12  
2 weeks. Gene set enrichment analysis (GSEA) of the RNA sequencing data using the C5 Gene  
3 Ontology database (MSigDB) showed that at 12 weeks, the 34 most significantly enriched gene  
4 sets were all related with immune response and inflammation (Fig 2A). Most of these gene sets  
5 were either not (FDR >0.05) or negatively enriched at 4 weeks and showed an intermediate  
6 enrichment score at 6 weeks. This suggested that ablation of *Znrf3* resulted in the progressive  
7 establishment of a proinflammatory environment. Consistent with this idea, a large number of  
8 proinflammatory cytokines and chemokines genes were progressively upregulated at 6 and 12  
9 weeks (Fig 2B and Fig S2A). Establishment of an inflammatory environment was further evaluated  
0 by immunohistochemistry for the pan leukocyte marker CD45. In control male adrenals, a few  
1 CD45<sup>+</sup> cells were found scattered throughout the cortex. Four-week-old male *Znrf3* cKO adrenals  
2 were similar to controls, although more mononucleated leukocytes were present in the inner cortex.  
3 At 12 weeks, the number of CD45 positive cells dramatically increased in KO adrenals (Fig 2C and  
4 Fig S2B). These comprised both mononuclear cells (stars) and the multinucleated giant cells  
5 (arrowheads) that accumulated in the inner cortex (Fig 2C). To further identify the immune cell  
6 types that composed the infiltrate, we deconvoluted RNA sequencing data with CIBERSORTx (31)  
7 using immune cell signatures from ImmuCC (32) (Fig 2D) and mMCP (33) (Fig S2C). Both  
8 approaches showed a significant increase in macrophages populations, which represented 63% of  
9 all immune populations at 12 weeks. This was further confirmed by GSEA, showing a highly  
0 significant positive enrichment of multiple macrophage signatures at 12 weeks (Fig 2E) and by  
1 RTqPCR showing a progressive accumulation of the macrophage marker transcripts *Cd68*, *Adgre1*  
2 and *Cd11b* (Fig S2D). Altogether, these data strongly suggested that regression of adrenal cortex  
3 hyperplasia in *Znrf3* cKO males was associated with establishment of a proinflammatory  
4 environment and abundant recruitment of macrophages.

5 To further confirm the nature of infiltrating cells, adrenals from control and *Znrf3* cKO males were  
6 dissociated and analysed by flow cytometry (Fig 2F and Fig S2E). This showed that absolute  
7 numbers of CD45<sup>+</sup>/CD64<sup>+</sup>/F4/80<sup>+</sup> macrophages were dramatically increased in *Znrf3* cKO adrenals  
8 at 4 and 6 weeks (Fig 2F). Increased infiltration of macrophages in *Znrf3* cKO male adrenals was  
9 further confirmed when macrophages were evaluated as a percentage of CD45<sup>+</sup> cells (Fig S2F).  
0 Flow cytometry analyses further showed that at 4 weeks, almost 80% of CD45<sup>+</sup>/CD64<sup>+</sup>  
1 macrophages co-expressed the M1 markers CD38 and MHC-II, together with the M2 marker

2 CD206, both in wild-type and *Znrf3* cKO adrenals (Fig S3A). Although there was a very mild but  
3 significant increase in both MHC-II<sup>+</sup>/CD206<sup>+</sup> and CD38<sup>+</sup>/CD206<sup>+</sup> double-positive macrophages in  
4 6-week *Znrf3* cKO adrenals, there was no significant difference in either M1 or M2 macrophages  
5 proportions, following ablation of *Znrf3* at the two analysed stages (Fig S3A). RTqPCR (Fig S3B)  
6 and RNA sequencing analyses (Fig S3C-D) further confirmed deregulation of both M1 and M2  
7 markers in *Znrf3* cKO adrenals, indicating that infiltrating macrophages had mixed M1 and M2  
8 characteristics at 4 and 6 weeks.

9 Unfortunately, the majority of CD45<sup>+</sup> MGCs that accumulated from 12 weeks onward, had a cell  
0 diameter larger than 40 μm, which precluded their characterisation by flow cytometry (Fig S4A).

1 To further characterise immune infiltration during the regression period, we thus resorted to  
2 immunohistochemical analysis. Staining with pan-macrophages markers IBA-1 and F4/80  
3 confirmed progressive infiltration from 4 to 12 weeks (Fig 2G & Fig S4B). Interestingly, although  
4 mononuclear cells appeared equivalently labelled by both IBA-1 and F4/80, IBA-1 staining of  
5 MGCs was weak compared to F4/80 (Fig 2G). However, MGCs displayed high levels of  
6 cytoplasmic CD68 staining, suggesting that they were derived from the fusion of mononuclear  
7 macrophages (Fig 2G & Fig S4B). Macrophage fusion has been shown to rely on TREM2, an  
8 activating receptor of the Ig-superfamily and on TYROBP/DAP12, its transmembrane signalling  
9 adaptor (34, 35). Interestingly, expression of *Trem2* and *Tyrobp/Dap12* was strongly increased in  
0 RTqPCR at 12 weeks (Fig S4C) and IHC analyses showed a strong up-regulation of both TREM2  
1 and TYROBP protein accumulation in MGCs (Fig 2H & Fig S4D). High magnification images  
2 further showed TREM2/TYROBP-positive mononuclear macrophages actively fusing with MGCs  
3 (Fig 2I, arrowheads).

4 Altogether, this suggested that *Znrf3* ablation in adrenocortical cells resulted in macrophage  
5 infiltration and fusion to form MGCs in male adrenals.

### 7 **Infiltrating macrophages actively phagocytose steroidogenic cells**

8 Macrophages have been suggested to play a role in the early response to oncogenic insult, by  
9 clearing out preneoplastic cells (36, 37). Interestingly, GSEA of RNA sequencing data showed a  
0 progressive significant enrichment of gene sets associated with phagocytosis and clearance of  
1 apoptotic cells in male *Znrf3* cKO adrenals, suggesting a potential role of phagocytosis in regression  
2 of hyperplasia (Fig 3A). Phagocytosis involves chemotaxis of macrophages towards target cells  
3 that express “find-me” signals and recognition of target cells through “eat-me” signals that can be  
4 received directly by phagocytic receptors, or indirectly after opsonization. Detailed analysis of  
5 RNA sequencing data showed significant up-regulation of genes coding the potential “find-me”

6 chemokine CX3CL1 (38), and of the GPR132/G2A and P2RY2/P2RY6 metabotropic receptors that  
7 recognize lysophosphatidylcholine (GPR132) (39) and nucleotides (P2RY2/P2RY6) (40), released  
8 by target cells (Fig 3B). Among potential “eat-me” signals, we found significant overexpression of  
9 C1Q complement components *Clqa*, *Clqb* and *Clqc* which have been shown to decorate the  
0 surface of apoptotic cells to target them for phagocytosis (40, 41) (Fig 3B), and of *Slamf7*, which  
1 is involved in phagocytosis of hematopoietic tumour cells (42). There was also upregulation of the  
2 gene coding MFGE8, which opsonizes apoptotic cells and is recognised by the integrin receptors  
3  $\alpha_v\beta_3$  and  $\alpha_v\beta_5$  at the membrane of macrophages (43, 44) (Fig 3B & 3C). Interestingly, TREM2 and  
4 TYROBP, which we found overexpressed both at the mRNA and protein level (Fig 2H, Fig 3B &  
5 Fig S4C), can also be involved in the phagocytic process through recognition of lipids and ApoE-  
6 opsonized cells (43, 45, 46). Among the three TAM receptor tyrosine kinases, which play a central  
7 role in phagocytosis (TYRO3, MERTK, AXL) (40, 47), *Mertk* was expressed at high levels and  
8 showed the most significant upregulation in *Znrf3 cKO* adrenals (Fig 3B & C). Although there was  
9 no upregulation of *Gas6* and *Pros1*, the natural TAM receptors ligands (40), there was a strong  
0 overexpression of *Lgals3* (27-fold), which encodes Galectin-3, a phosphatidylserine-independent  
1 MERTK-specific opsonin (43, 48) (Fig 3B). This was further confirmed by RTqPCR (Fig 3C),  
2 suggesting that engagement of MERTK by Galectin-3 may trigger phagocytosis of *Znrf3 cKO*  
3 hyperplastic steroidogenic cells.

4 To further gain insight into a potential phagocytic process in *Znrf3 cKO* adrenals, we analysed  
5 expression of the TAM receptor MERTK by IHC. Although some positive cells were found in wild-  
6 type adrenals, they were rather scarce and expressed low levels of MERTK (Fig 3D). In contrast,  
7 increased numbers of mononuclear MERTK<sup>high</sup> cells were found in *Znrf3 cKO* adrenals as early as  
8 6 weeks (Fig 3D). Most of these cells also stained for IBA-1, confirming their macrophage identity  
9 (Fig S4E). At 6 and 12 weeks, the number of mononuclear MERTK-high cells dramatically  
0 increased in *Znrf3 cKO* (Fig3D & Fig S4E). Interestingly, multinucleated fused macrophages  
1 expressed very high levels of MERTK (Fig 3D), which was associated with reduced IBA-1  
2 expression (Fig S4E). MERTK<sup>high</sup> and in particular, fused macrophages, were also positive for  
3 TREM2 (Fig S4F). However, TREM2 was expressed in a larger number of macrophages, including  
4 mononucleated MERTK<sup>-</sup> macrophages (Fig S4F). Altogether, this suggested that macrophages  
5 infiltration in *Znrf3 cKO* male adrenals was associated with differentiation into active phagocytes.  
6 To test this hypothesis, we evaluated phagocytosis by confocal microscopy. For this, we colocalised  
7 expression of 3 $\beta$ HSD and SF-1, two markers of steroidogenic cells with IBA-1 (from 4 to 9 weeks)  
8 and MERTK (at 12 weeks). We then counted 3 $\beta$ HSD and SF-1 positive cells that were found within  
9 the boundaries of IBA-1<sup>+</sup> or MERTK<sup>high</sup> macrophages throughout the confocal Z-stack (Fig 3E). A

0 few IBA-1<sup>+</sup> macrophages contained 3 $\beta$ HSD positive cells in control adrenals at 4, 6 and 9 weeks,  
1 indicating that phagocytosis of steroidogenic cells was taking place at homeostasis in the adrenal  
2 (Fig 3E). Interestingly, the number of phagocytic IBA-1<sup>+</sup> cells was markedly increased in *Znrf3*  
3 *cKO* adrenals at these three timepoints (Fig 3E), indicating that mononuclear IBA-1<sup>+</sup> macrophages  
4 were actively involved in phagocytosis of *Znrf3 cKO* steroidogenic cells. Increased phagocytosis  
5 was also observed for MERTK<sup>high</sup> macrophages at 12 weeks (Fig 3F).

6 Altogether, these data show that both IBA-1<sup>+</sup> and MERTK<sup>high</sup> macrophages are involved in a  
7 dramatic increase in phagocytosis of mutant steroidogenic cells in male *Znrf3 cKO* adrenals.

8 To further confirm the key role of macrophages in regression of adrenal hyperplasia, we depleted  
9 macrophages using a diet enriched with 290mg/kg Pexidartinib, a pharmacological inhibitor of  
0 CSF1R. This tyrosine kinase receptor plays a central role for survival of macrophages within their  
1 tissue niches, through stimulation by CSF1 and/or IL-34. Consistent with the key function of  
2 CSF1R, flow cytometry analyses showed that 1 week of Pexidartinib chow was sufficient to deplete  
3 almost all CD45<sup>+</sup>/CD64<sup>+</sup>/F4/80<sup>+</sup> macrophages within the adrenal cortex of control male mice (Fig  
4 S4G). We then evaluated the impact of macrophages depletion in male *Znrf3 cKO* mice by feeding  
5 them with standard chow or Pexidartinib chow from 3 to 12 weeks (Fig 3G). This resulted in a very  
6 strong decrease in the number of IBA-1<sup>+</sup>, F4/80<sup>+</sup>, CD68<sup>+</sup> (Fig S4H-I) and MERTK<sup>high</sup> macrophages  
7 (Fig 3G) in IHC analyses, which was confirmed by RTqPCR for *Adgre1*, *Cd68* and *Cd11b* (Fig  
8 S4J). Consistent with these findings, although adrenal weight remained equivalent to control *Znrf3*  
9 *cKO* males (Fig S4K), H&E staining showed a remarkable decrease in the number of fused  
0 macrophages and concomitant expansion of presumptive eosinophilic steroidogenic cells,  
1 following pexidartinib treatment (Fig 3G). This was further confirmed by a significant increase in  
2 SF-1 positive cells in the cortices of Pexidartinib-treated mice (Fig 3G) and an inverse correlation  
3 between MERTK<sup>high</sup> and SF-1-positive cells (Fig S4L).

4 Altogether, these data show that *Znrf3* ablation induces sustained recruitment of IBA1<sup>+</sup> and  
5 MERTK<sup>high</sup> macrophages, which results in phagocytic clearance of preneoplastic steroidogenic  
6 cells and regression of adrenal hyperplasia in male mice.

### 8 **Recruitment of phagocytic macrophages is delayed in females**

9 In contrast with males, female *Znrf3 cKO* adrenals progress from hyperplasia at 4 weeks to  
0 development of full-fledged metastatic carcinomas at 78 weeks (Fig 1). Interestingly, analysis of  
1 the overall mononuclear macrophage population by IHC for IBA-1, showed increased recruitment  
2 of IBA-1-positive macrophages in *Znrf3 cKO* females from 4 to 52 weeks (Fig 4A). However,  
3 counting of IBA-1-positive cells suggested that macrophages recruitment was milder than in males

4 from 4 to 12 weeks (Fig 4A&B). This was confirmed by GSEA (Fig 4C), showing a robust  
5 enrichment in macrophages signatures in male knockouts compared with female knockouts at 12  
6 weeks and RTqPCR analyses of *Cd68*, *Adgre1* and *Cd11b* (Fig S5A). CIBERSORTx analysis also  
7 failed to show macrophage enrichment, although there was upregulation of monocytes at 12 weeks  
8 (Fig S5B). Consistent with observations in male adrenals, flow cytometry analyses showed that a  
9 majority of macrophages that were present in both control and *Znrf3 cKO* females displayed mixed  
0 M1 and M2 features at 6 weeks (Fig S5C). Milder inflammatory response in female knockouts was  
1 also confirmed by the absence of cytokine signature enrichment at 12 weeks, compared with male  
2 knockouts (Fig 4D). By 24 and up to 52 weeks, the number of IBA-1-positive cells significantly  
3 increased in female *Znrf3 cKO* adrenals, which was accompanied by a mild but significant increase  
4 in mRNA accumulation of *Adgre1* at 24 weeks and *Cd68* at 52 weeks (Fig 4A-B & Fig S5A).  
5 However, this was still not associated with enrichment of cytokines (Fig S5D). Altogether, this  
6 showed that macrophage recruitment was delayed in female *Znrf3 cKO* adrenals and was not  
7 associated with robust inflammation. In males, regression of hyperplasia is associated with fusion  
8 of mononuclear macrophages to form MGCs (Fig 3). Whereas fused macrophages were already  
9 present in large numbers in 12 weeks *Znrf3 cKO* males, they did not appear before 24 weeks in  
0 females (Fig 4E). Consistent with delayed fusion, fused macrophages harboured less nuclei (Fig  
1 S5E) and were smaller than in males at this stage (Fig S5F). In male *Znrf3 cKO* adrenals, acquisition  
2 of high phagocytic capacities is associated with infiltration of MERTK<sup>high</sup> macrophages as early as  
3 6 weeks (Fig 3D & Fig 4G). In contrast, these were scarce until 24 weeks in female *Znrf3 cKO*  
4 adrenals (Fig 4F-G). They mostly represented fused macrophages (Fig 4F) and were only  
5 significantly increased in numbers at 52 weeks (Fig 4G). This suggested that phagocytosis of  
6 hyperplastic mutant cells may be impaired in female knockouts. Indeed, although there was trend  
7 for increased phagocytosis by IBA-1<sup>+</sup> macrophages, it only reached significance, at 9 weeks (Fig  
8 4H). Furthermore, the rate of phagocytosis was much lower than in males, barely reaching 10 events  
9 per high power field in female knockouts, compared with over 40 in male knockouts (Fig 3E). The  
0 low phagocytic capacity in females was even more evident when analysed within MERTK<sup>high</sup>  
1 macrophages at 12 weeks (Fig 4H). This was supported by the lack of enrichment of phagocytosis-  
2 related gene signatures at any time point (Fig 4I), which was further confirmed by RTqPCR at 12  
3 weeks (Fig 4J).  
4 Altogether, these data strongly suggest that delayed recruitment and impaired function of  
5 phagocytic macrophages allow progression of hyperplasia in *Znrf3 cKO* females.  
6

## **Androgens are sufficient to trigger early recruitment of phagocytic macrophages and regression of hyperplasia**

Sexually dimorphic phenotypic differences in phagocytic macrophage recruitment and regression of hyperplasia occur between 6 and 12 weeks, which coincides with onset of puberty in mice. To evaluate a potential contribution of androgens to this phenomenon, *Znrf3 cKO* females were implanted with placebo or testosterone pellets from 4 to 12 weeks and their adrenals were then harvested (Fig 5A). As expected, placebo treated female adrenals were almost completely devoid of MERTK<sup>high</sup> macrophages (Fig 5B-C). In sharp contrast, testosterone-treated females displayed abundant infiltration of both mononuclear and fused MERTK<sup>high</sup> macrophages, which was almost equivalent to 12-week-old males (Fig 5B-C). Infiltration of macrophages was further confirmed by RTqPCR showing increased expression of *Cd68* and *Adgre1*, following androgen treatment (Fig 5D). Interestingly, RTqPCR analysis of phagocytosis-associated gene expression also showed increased accumulation of *Axl*, *Mertk*, *Mfge8*, *Trem2*, *Tyrobp* and *Lgals3*, suggesting that testosterone treatment stimulated recruitment of phagocytic macrophages (Fig 5E). Consistent with this hypothesis, testosterone treatment was associated with a marked decrease in *Znrf3 cKO* female adrenal weight, which returned to control levels (Fig 5F). Altogether, these experiments show that androgens are sufficient to induce recruitment of phagocytic macrophages, which results in regression of hyperplasia.

## **Recruitment of phagocytic macrophages in male *Znrf3 cKO* mice is associated with sexually dimorphic induction of senescence**

Recruitment of myeloid cells to preneoplastic lesions has been associated with induction of senescence (36, 37). To evaluate a potential role of senescence in the sexually dimorphic recruitment of phagocytes in the adrenal cortex of *Znrf3 cKO* mice, we evaluated enrichment of senescence-associated signatures in males and females from 4 to 12 weeks. Whereas most of these signatures were significantly enriched in *Znrf3 cKO* males at 6 and 12 weeks, there was no or negative enrichment in females (Fig 6A). This suggested that ablation of *Znrf3* resulted in male-specific induction of senescence. To further evaluate this hypothesis, we first analysed expression of the cell-cycle inhibitor P21. In these experiments, steroidogenic cells were labelled by GFP, which was expressed by the mTmG locus following SF-1:Cre-mediated recombination. Consistent with induction of senescence, there was a significant increase in p21 labelling-index within GFP<sup>+</sup> steroidogenic cells in *Znrf3 cKO* males at 4 weeks (Fig 6B and S6A-B). Levels of P21<sup>+</sup> cells accumulation returned to normal at 6 weeks in *Znrf3 cKO* males and were significantly reduced at 12 weeks, consistent with phagocytosis of senescent cells (Fig 6B). Surprisingly, a significant

1 increase in P21 labelling was also observed in *Znrf3 cKO* females at 4 weeks and maintained up to  
2 12 weeks (Fig 6B and S6B), suggesting that cell cycle was arrested in both males and females,  
3 following *Znrf3* ablation. To further assess induction of senescence, we analysed activity of the  
4 prototypic senescence-associated acidic  $\beta$ -galactosidase (SA- $\beta$ Gal). This showed a few cells were  
5 found in the subcapsular area and at the cortical-medullary junction in control males and females,  
6 which was further increased in control females at 12 weeks. This suggested that spontaneous  
7 senescence was taking place in these regions (Fig 6C). Strikingly, SA- $\beta$ Gal staining was increased  
8 within the inner cortex of male *Znrf3 cKO* mice at 6 weeks and to a lesser extent at 12 weeks,  
9 consistent with phagocytic clearance of senescent cells in male adrenals (Fig 6C). In contrast, there  
0 was no increase in SA- $\beta$ Gal staining in *Znrf3 cKO* females, which displayed a similar pattern to  
1 controls (Fig 6C). This suggested that although proliferation was arrested in both males and  
2 females, senescence was only induced in male *Znrf3 cKO* adrenals. To further confirm this, we  
3 evaluated expression of a senescence associated secretory phenotype (SASP) in our RNA  
4 sequencing data. This analysis showed that the 26 SASP-coding genes that were significantly  
5 deregulated in 12-week-old *Znrf3 cKO* male adrenals were not deregulated in females (Fig 6D),  
6 suggesting that establishment of a SASP was male-specific. This was further confirmed by male-  
7 specific enrichment of gene sets for NF $\kappa$ B signalling, which plays a key role in SASP induction  
8 (49, 50) (Fig S6C). RTqPCR analyses confirmed significant up-regulation of *Mmp12* and *Il1a* at 6  
9 weeks and of *Cxcl2*, *Mmp12*, *Il1a*, *Tnfrsf1b* at 12 weeks in male, but not female adrenals (Fig 6E  
0 & Fig S6D). Among SASP factors, the three monocyte/macrophage chemoattractants *Ccl2*, *Csf1*  
1 and *Cx3cl1* were up-regulated in male adrenals and not deregulated (*Csf1*), undetectable (*Ccl2*), or  
2 even down-regulated in females (*Cx3cl1*) (Fig 6E and Fig S6D). Interestingly, *Znrf3 cKO* female  
3 mice that received testosterone (Fig 5) also showed induction of senescence-associated  $\beta$ -  
4 galactosidase after 1 week of treatment (from 4 to 5 weeks, Fig 6F). This was associated with up-  
5 regulation of *Mmp12*, *Il1a* and of the chemoattractant *Cx3cl1*, but not *Ccl2* (undetectable) or *Csf1*  
6 (Fig 6G). This suggested that testosterone played a key role in senescence induction, which in turn,  
7 allowed recruitment of macrophages through SASP factors, including CX3CL1. Consistent with  
8 this hypothesis, F4/80-positive macrophages were found in very close proximity to SA-  
9  $\beta$ Galactosidase- and GFP-positive steroidogenic cells in the adrenal cortex of male *Znrf3 cKO* mice  
0 at 6 weeks (Fig 6H). In situ RNA hybridization analyses further showed increased accumulation of  
1 *Cx3cl1* transcripts in cells surrounding fused macrophages in male *Znrf3 cKO* and androgen-  
2 treated, but not placebo-treated female *Znrf3 cKO* adrenals at 12 weeks (Fig S6E). Altogether, these  
3 data strongly suggest that male-specific androgen-driven induction of senescence and SASP, results



4 in recruitment, activation and fusion of highly efficient phagocytes that prevent tumour progression  
5 in male *Znrf3 cKO* mice.

## 7 **Aggressive tumourigenesis is associated with infiltration of non-phagocytic macrophages in** 8 **female adrenals**

9 To further gain insight into the role of macrophages at late stages of tumourigenesis, we evaluated  
0 infiltration of macrophages in 78-week-old adrenal lesions in both male and female mice. At this  
1 stage, male *Znrf3 cKO* adrenals were still infiltrated by IBA-1-positive macrophages that were  
2 scattered throughout the cortex (Fig 7A). However, quantification of the IBA-1 index showed that  
3 in contrast with earlier stages, infiltration was equivalent to control males (Fig 7B). In female *Znrf3*  
4 *cKO*, IBA-1-positive infiltration was somewhat heterogenous within the tissue, with areas of high  
5 infiltration and zones that were almost devoid of macrophages (Fig 7A). There was also  
6 interindividual heterogeneity. Indeed, some tumours were still infiltrated at levels comparable to  
7 controls, whereas others showed much less IBA-1<sup>+</sup> cells or virtually no macrophages (Fig 7A &  
8 B). There was no overall difference between indolent and aggressive (metastatic) tumours with  
9 respect to IBA-1<sup>+</sup> index (Fig 7B). However, macrophages exclusion was observed in a subset of  
0 2/10 aggressive tumours (Fig 7A & B). Consistent with IHC analyses, accumulation of mRNA  
1 encoding macrophages markers were unaltered (*Cd68*, *Adgre1*) or decreased (*Cd11b*) in female  
2 *Znrf3 cKO* compared to controls (Fig 7C). Interestingly, although accumulation of *Adgre1* and  
3 *Cd11b* mRNA was unaltered, *Cd68* was still strongly accumulated in male *Znrf3 cKO* adrenals (Fig  
4 7C). Since we showed high expression of CD68 in fused macrophages at earlier stages (Fig 2G),  
5 this suggested that active phagocytes may still be accumulating in male KO adrenals at 78 weeks.  
6 Consistent with this idea, there were still large numbers of MERTK<sup>high</sup> fused macrophages in 78-  
7 week-old *Znrf3 cKO* male adrenals (Fig 7A & B), which was correlated with overexpression of  
8 *Mfge8*, *Trem2* and *Tyrobp* in RTqPCR (Fig 7D). In contrast, female *Znrf3 cKO* adrenals showed  
9 scarce infiltration of MERTK<sup>high</sup> fused macrophages, although a few of them could still be observed  
0 in indolent tumours (Fig 7A & B). Consistent, with these observations, there was no deregulation  
1 of phagocytosis/fusion markers in *Znrf3 cKO* female adrenals at this stage (Fig 7D). Interestingly,  
2 GSEA showed strong enrichment of phagocytosis-associated signatures, but no enrichment of DNA  
3 proliferation / cell-cycle pathways in male *Znrf3 cKO* RNA sequencing data at 78 weeks (Fig 7E).  
4 In contrast, female knockouts showed high enrichment of proliferation signatures, but no  
5 enrichment of phagocytosis (Fig 7E).

6 Altogether, these data strongly suggest that even though macrophages are still present within  
7 tumour tissues at 78 weeks in both males and females, the lack of phagocytic activity is associated  
8 with aggressive tumour progression in females.

9

## 0 **Phagocytic macrophages signatures are prominent in male ACC patients and associated with** 1 **better prognosis**

2 To further evaluate the role of macrophages in ACC progression, we evaluated their infiltration  
3 within human ACC. For this, we used RNA sequencing data from the TCGA consortium (79  
4 sequenced ACCs) and evaluated expression of a 10-gene signature (based on single cell RNA  
5 sequencing data from mouse adrenals (51)) as a proxy to general macrophage infiltration.  
6 Interestingly, tumours of the good prognosis group, defined as C1B (27), had significantly higher  
7 expression of the macrophages signature than tumours of the bad prognosis C1A group (Fig 8A).  
8 Consistent with our data showing similar infiltration of IBA-1<sup>+</sup> macrophages in male and female  
9 *Znrf3 cKO* adrenals at 78 weeks (Fig 7B), there was no difference in the general macrophage  
0 signature expression between ACC in men (n=31) and women (n=48) (Fig 8B). However, a three  
1 gene phagocytic macrophage signature (*CD68*, *TREM2*, *TYROBP*) was significantly expressed at  
2 higher levels in men (Fig 8C), and in the C1B group of ACC with favourable prognosis (Fig 8D).  
3 In contrast with the global macrophage signature (Fig S7A), high expression of the phagocytic  
4 signature (above median) was associated with better survival, compared with low expression  
5 (below median) in Kaplan-Meier analysis (Fig 8E). Of note, the two signatures were not associated  
6 with hormonal status of patients (Fig S7B). Altogether, this suggested that infiltration with  
7 phagocytic macrophages was more frequent in men than in women and associated with better  
8 prognosis.

9 Detailed analysis of RNA sequencing data identified 365 genes that were significantly deregulated  
0 (FDR <0.01, abs(Log2FC>2)) between the groups of high and low expression of the phagocytic  
1 signature (Fig 8F). As expected, macrophages-associated genes such as *CD68*, *CSF1R*, *ITGAM*,  
2 *LAPTM5*, *CYBB* and *SIGLEC9* were up-regulated in phagocytic-high patients (Fig 8F). GSEA  
3 confirmed enrichment of macrophages (Fig S7C) and phagocytosis signatures (Fig 8G). Consistent  
4 with data in our mouse models, phagocytic signatures were also associated with enrichment of  
5 senescence and NFκB signalling gene sets (Fig 8G), suggesting that these pathways may also play  
6 a role in phagocytic macrophages recruitment in ACC patients. Gene ontology analysis using the  
7 C5 GO database (MsigDB) showed that the top 35 positively enriched gene sets were all related  
8 with immune response and inflammation in patients with high expression of the phagocytic  
9 signature, suggesting that this subgroup was mounting a more profound immune response than

0 patients with low expression of the signature (Fig S7D). Deconvolution of RNAseq data using  
1 CIBERSORTx showed that macrophages were the most prominent immune cell population in the  
2 two groups of patients, consistent with mouse adrenals (Fig 8H). Interestingly, it also showed that  
3 enrichment of macrophages signatures in the phagocytic-high subgroup of patients was associated  
4 with increased cytotoxic CD8<sup>+</sup> T lymphocytes signatures (Fig 8H). However, this was also  
5 correlated with lower B cells, plasma cells and NK cells and higher T regulatory cells infiltration  
6 (Fig 8H), suggesting that the phagocytic-high subgroup of patients had a broad alteration of the  
7 immune tumour microenvironment.

8  
9 Altogether, these observations suggest that phagocytic macrophages, which are more prominent in  
0 male than female ACC patients, are associated with senescence, global innate and adaptive immune  
1 response and better prognosis.

## 2 **Discussion**

3  
4 Apart from reproductive tissues, cancers are generally more frequent and aggressive in men than in  
5 women, even after adjusting for known risk factors (1, 2). Although ACC is one of the rare  
6 exceptions to this rule, the mechanisms underlying the higher incidence and aggressiveness in  
7 women remain elusive. Here, we show that conditional deletion of *Znrf3* within steroidogenic cells  
8 of the adrenal cortex, results in sexually dimorphic development of full-fledged metastatic ACC in  
9 female mice over an 18-month time course, whereas the initial hyperplasia gradually regresses in  
0 males (Fig 9). By a combination of RNA sequencing, flow cytometry and immunohistochemical  
1 analyses, we show that *Znrf3 cKO* males efficiently recruit macrophages from early stages of  
2 preneoplastic transformation, following induction of senescence. We further show that these  
3 macrophages, which differentiate as potent phagocytes are required for clearance of preneoplastic  
4 cells. Although females also mount an innate immune response to preneoplastic transformation, it  
5 is delayed compared to males and never achieves efficient clearance of preneoplastic cells. This  
6 phenomenon is maintained up to 78 weeks, when indolent lesions in male *Znrf3 cKO* adrenals are  
7 still infiltrated with large amounts of phagocytic macrophages, as opposed to aggressive female  
8 tumours (Fig 9). Consistent with our findings in mice, we show that a phagocytic macrophage  
9 signature is more prominent in male than in female ACC patients, where it is associated with better  
0 prognosis (Fig 9). This strongly suggests that the sexual dimorphism of ACC may result from  
1 differential recruitment and activation of phagocytic tumour associated macrophages (TAMs),  
2 which prevent both tumour initiation and progression in the adrenal cortex.  
3  
4

5 This is in contrast with most data of the literature showing that TAMs are generally associated with  
6 tumour progression and poor prognosis in many cancers, even though they may initially prevent  
7 tumour initiation (36, 37, 52–54). Plasticity and diversity of TAMs explain their divergent  
8 functions. The standard dual classification of macrophages postulates that M1 macrophages that  
9 differentiate in response to proinflammatory cytokines (*e.g.* interferons and tumour necrosis  
0 factors) are involved in anti-tumour activities, whereas M2 macrophages that differentiate in  
1 response to immunomodulatory signals (*e.g.* IL-4, IL-10 and TGF- $\beta$ ) are associated with tumour  
2 promotion (55). However, recent single cell RNA sequencing analyses of tumour infiltrating  
3 myeloid cells showed that M1 and M2 gene signatures were co-expressed in macrophage subsets  
4 from almost all cancer types (53). Consistent with this idea, our RNA sequencing and flow  
5 cytometry analyses suggested that macrophages that accumulate in the adrenals of *Znrf3 cKO* males  
6 had mixed characteristics of the M1 and M2 phenotypes. Furthermore, we did not find evidence of  
7 overexpression of canonical tumoricidal macrophages markers such as the pro-inflammatory  
8 cytokines IL-1 $\beta$ , IL-2, IL-6, IL-12 and IL-23 (Fig 2B) or iNOS, which metabolizes arginine into  
9 the killer molecule nitric oxide (not shown). This suggests that the tumoricidal function of adrenal  
0 macrophages relies on alternative activities. Consistent with this idea, we show a very strong  
1 increase in the phagocytic activity of macrophages in *Znrf3 cKO* male adrenals compared with their  
2 wild-type littermates and *Znrf3 cKO* females. This activity is associated with cytoplasmic  
3 accumulation of CD68 and high membrane expression of MERTK, TYROBP and TREM2, which  
4 play a central role in the phagocytic process (40, 43, 45–47). Although *MERTK* expression did not  
5 correlate with the presence of macrophages in ACC patients (not shown), we show that increased  
6 expression of the phagocytic *CD68/TREM2/TYROBP* signature is correlated with better prognosis,  
7 within the TCGA cohort. This strongly suggests that phagocytosis plays a central role in the  
8 tumoricidal activity of macrophages in ACC. Interestingly, scRNA sequencing in human and mouse  
9 colorectal cancer identified a population of C1QC<sup>+</sup> TAMs, characterised by high levels of  
0 *C1QA/B/C*, *TREM2* and *MERTK* expression, which were associated with potential recruitment and  
1 activation of T cells, phagocytosis and better prognosis (53, 56). Although we did not analyse  
2 macrophages by single cell RNA sequencing in *Znrf3 cKO* adrenals, our bulk RNA sequencing data  
3 show strong up-regulation of all these markers (Fig 3B), which are mostly expressed by  
4 macrophages in scRNA seq datasets from wild-type mouse adrenals (Fig S8A). This strongly  
5 suggests that tumoricidal TAMs found in ACC may be related with the phagocytic C1QC<sup>+</sup> TAMs  
6 identified in other cancers (53, 56).

7

8 A very striking feature of the phenotype is the strong sexual dimorphism in immune response to  
9 neoplasia, due to early recruitment of tumoricidal phagocytic macrophages, specifically in male  
0 mice. We further show that testosterone treatment of females from 4 to 12 weeks is sufficient to  
1 trigger a response which is comparable to males and results in regression of hyperplasia (Fig 5).  
2 This strongly suggests a role of male hormones in this phenomenon and raises the question of the  
3 underlying mechanisms. One possibility is an intrinsic sexual dimorphism of macrophages within  
4 the adrenal, which would result in differential responses to oncogenic transformation of  
5 steroidogenic cells. Indeed, recruitment, replenishment and activation mechanisms of macrophages  
6 and other immune cell types have been shown to diverge between males and females, resulting in  
7 sexually dimorphic responses to infection and proinflammatory stimuli. However, in most  
8 instances, female macrophages are more responsive to stimuli, mount a more robust response and  
9 have higher phagocytic capacities than male macrophages (57–63). This suggests that the stronger  
0 inflammatory response observed in male *Znrf3 cKO* adrenals may result from indirect effects of  
1 sex hormones. Consistent with this, single cell sequencing data suggest that the androgen receptor  
2 *Ar* is only expressed in a small subset of adrenal macrophages, characterised by lower expression  
3 of *Trem2* and *Mertk*, which is unlikely to represent the major population of macrophages in *Znrf3*  
4 *cKO* adrenals (Fig S8A). Our data showing a strong association between induction of SASP and  
5 recruitment of macrophages suggest that androgens may stimulate the tumoricidal response by  
6 inducing release of senescence associated cytokines by *Znrf3 cKO* cells (Fig 6). In line with this  
7 hypothesis, AR activation was shown to induce p53-independent senescence in prostate cancer cells  
8 (64, 65) and a short-term testosterone treatment was sufficient to induce SA- $\beta$ galactosidase activity  
9 in female *Znrf3 cKO* adrenals (Fig 6). This raises the question of the links between *Znrf3*  
0 inactivation, AR signalling and senescence induction. One may speculate that the recently  
1 documented sexual dimorphism in cortical cell proliferation, renewal and progenitor populations  
2 (8, 9) may result in sexually dimorphic response to *Znrf3* inactivation. In this context, the  
3 hyperproliferation observed in both male and female *Znrf3 cKO* adrenals may result in faster  
4 exhaustion of progenitor pools in males and subsequent induction of senescence. However, the  
5 rapid induction of SA- $\beta$ galactosidase in testosterone-treated *Znrf3 cKO* females suggests that this  
6 is an unlikely scenario. Alternatively, these findings may reflect a novel function of ZNRF3 in the  
7 control of cellular homeostasis. Interestingly, although we were able to show a mild induction of  
8 *Axin2* accumulation in *Znrf3 cKO* adrenals by RNA in-situ hybridization (30), analysis of our RNA  
9 sequencing data did not show evidence of canonical WNT signalling induction in either male or  
0 female knockouts (Fig S8B), when compared with a previously published model of constitutive  $\beta$ -

1 catenin activation (66). This suggests that the impact of *Znrf3* inactivation on senescence induction  
2 may involve WNT-independent mechanisms.

3  
4 Interestingly, we could find large numbers of IBA-1<sup>+</sup> macrophages (up to 15% of total cells in the  
5 tumour) in aggressive tumours in 78-week-old *Znrf3* cKO female mice (Fig 7B), even though they  
6 were not differentiated as MERTK<sup>high</sup> active phagocytes. The presence of macrophages was further  
7 confirmed in ACC patients, where CIBERSORTx deconvolution suggested that they represented  
8 31% of all immune cells, even in the tumours expressing low levels of the phagocytic signature  
9 (40% in phagocytic high tumours, Fig 8H). These data suggest that even in aggressive phagocytic-  
0 low lesions, macrophages may be reprogrammed to stimulate their tumoricidal potential. Although  
1 most current macrophage related therapies aim to deplete this cell type in tumours, more recent  
2 strategies that stimulate tumoricidal activity and particularly phagocytosis of tumour cells by  
3 macrophages are currently being investigated (55). These include approaches that aim at inhibiting  
4 the CD47 “don’t-eat-me” signal produced by cancer cells and/or the SIRP $\alpha$  receptor for CD47 on  
5 macrophages, as well as stimulation of Toll-Like Receptor signalling (TLR) with TLR agonists  
6 (55). One important factor that these therapeutic approaches will have to consider in the context of  
7 ACC, is the presence of high levels of glucocorticoids produced by adrenal steroidogenic cells, in  
8 particular within hormonally active tumours. Although glucocorticoids do not have the same  
9 detrimental impact on macrophages that they have on lymphocytes, they are generally associated  
0 with M2-like tolerogenic differentiation (67). Therefore, therapeutics targeting macrophages in  
1 ACC, should probably consider combining macrophage activation with inhibition of glucocorticoid  
2 production or signalling, which would also favour recruitment of adaptive immune cells to the  
3 lesion. Availability of our clinically relevant mouse model will allow evaluation of these novel  
4 options.

5  
6 Interestingly, a recently posted BioRxiv preprint reports similar findings in a mouse model of *Znrf3*  
7 inactivation (68). Although differences in genetic backgrounds resulted in a more pronounced  
8 immune response in females in their model than in ours, Warde and colleagues also showed that  
9 male *Znrf3* KO adrenals mounted a profound macrophage-dependent anti-tumour response, further  
0 strengthening the findings reported here.

1  
2 In conclusion, we describe a novel interaction between tumour suppressor inactivation, senescence  
3 induction and recruitment of tumoricidal macrophages, which results in sexually dimorphic adrenal

4 cancer development. This provides novel insight into the strong gender bias of this particularly  
5 aggressive cancer and may help develop novel macrophage-centric therapeutic approaches.

## 6 **Materials and Methods**

### 9 **Mice**

0 All experiments with mice were in accordance with protocols approved by the Auvergne Ethics  
1 Committee (CEMEEA, APAFIS#27623-2021021611362535 v1). They were conducted in  
2 agreement with international standards for animal welfare in order to minimize animal suffering.  
3 *Znrf3 cKO* mice (ZKO) were generated by mating *Znrf3<sup>fl/fl</sup>* mice (28) with *SF1-Cre<sup>high</sup>* mice (69).  
4 In experiments that did not involve flow cytometry, the mTmG reporter gene was also included in  
5 the breeding scheme (70). Mice were bred and maintained on a C57Bl/6 genetic background. Mice  
6 were euthanized by decapitation at the end of experiments and blood collected in vacuum blood  
7 collection tubes (VFD053STK, Terumo). Adrenals were extracted, cleaned of excess fat, weighed  
8 and immediately fixed in 4% paraformaldehyde or stored at – 80 °C. Littermate control animals  
9 were used in all experiments.

### 1 **Immunohistology**

2 Adrenals were fixed in 4% paraformaldehyde overnight at 4°C, then washed two times in PBS. For  
3 the paraffin embedding, adrenals were dehydrated through an ethanol gradient. Then they were  
4 incubated for 2 h in HistoClear (HS200; National Diagnostics, Fisher Scientific, Illkirch, France)  
5 and embedded in paraffin. For frozen sections, adrenals were successively placed into 10% and  
6 15% PBS-sucrose solutions for 20 minutes, then 20% PBS-sucrose solution for 1 hour, and in 50/50  
7 OCT-Sucrose 20% solution overnight. Lastly, they were embedded in pure OCT solution and stored  
8 at -80°C. Paraffin and OCT samples were cut into 5 & 10µm sections, respectively.  
9 Haematoxylin/eosin staining was performed with a Microm HMS70 automated processor (Microm  
0 Microtech, Francheville, France), according to standard procedures. Antibody information,  
1 dilutions and unmasking conditions are listed in Supplementary Table 1. Notably, the TREM2  
2 antibody (71), was supplied from the Haass Lab at Ludwig Maximilians University Munich. After  
3 deparaffinization with HistoClear and rehydration in decreasing ethanol gradients, unmasking was  
4 performed by boiling slides for 20 min in the appropriate unmasking solution. Next, endogenous  
5 peroxidases were inactivated by incubating slides with 0.3% hydrogen peroxide for 30 min at room  
6 temperature (RT). After blocking for 1h, slides were incubated overnight at RT with primary

7 antibodies at the indicated concentrations (Supplementary Table 1). Primary antibodies were  
8 detected with appropriate species polymers (ImmPress Polymer Detection Kit, Vector  
9 Laboratories). Polymer-coupled horse radish peroxidase (HRP) activity was then detected with  
0 either Novared (SK-4800, Vector Laboratories) for brightfield images or TSA-Alexa-coupled  
1 fluorochromes for fluorescence (Thermo Fisher, Alexa\_488 B40953, Alexa\_555 B40955,  
2 Alexa\_647 B40958). For double-immunohistochemistry experiments, HRP was inactivated by  
3 incubation with 0.02% HCl for 20 min after detection of the first antibody to avoid cross-reaction.  
4 Nuclei were counterstained with Haematoxylin for brightfield images or Hoechst for fluorescence  
5 (Thermo Fisher 33342). Slides were mounted using a 50/50 PBS-Glycerol solution. Images were  
6 acquired with a Zeiss AxioImager with Apotome2 or Zeiss Axioscan Z1 slide scanner. Images were  
7 minimally processed for global levels and white balance using Affinity Photo® and Affinity  
8 Designer®. Image settings and processing were identical across genotypes.

9 Quantifications were performed on scanned whole adrenals (Axio Scan Zeiss scanner, 20× images)  
0 using the QuPath software version 0.3.1 (Bankhead et al 2017). Briefly, annotations were made of  
1 whole adrenals or just the adrenal cortex, and the positive cell detection feature was used to identify  
2 positive cells. The threshold for identifying positive cells was set to avoid quantification of  
3 background on each image.

4 For quantification of phagocytosis, confocal images were acquired on a Zeiss LSM 800 Airyscan  
5 confocal microscope with 40X magnification. Phagocytic events were identified and counted as the  
6 presence of steroidogenic cell markers (3βHSD or SF-1) within the boundaries of macrophages,  
7 defined by IBA-1 or MERTK staining. This was evaluated by a single operator, by manually  
8 scanning through Z-stacks of ten 40X images per adrenal. The operator was blinded to the genotype.

### 9 **Senescence-associated beta-galactosidase (SA-β-galactosidase) staining**

1 SA-β-galactosidase staining was conducted following the protocol of Debacq et al (4) on frozen  
2 adrenal 10µm-sections. After drying for 15 min under a vacuum, the sections were rehydrated with  
3 PBS and then incubated overnight at 37°C in a humid atmosphere in a pH 6.0 staining solution  
4 composed of 7.4mM citric acid, 25.3mM dibasic sodium phosphate, 5mM K<sub>4</sub>[Fe(CN)<sub>6</sub>], 5mM  
5 K<sub>3</sub>[Fe(CN)<sub>6</sub>], 150mM sodium chloride, 2mM MgCl<sub>2</sub> and 1mg/mL X-gal. Slides were mounted  
6 using a 50/50 PBS-Glycerol solution and imaged on a Zeiss ApoTome microscope with an  
7 AxioCam MRm camera and/or a Axio Scan Zeiss scanner.

### 9 **RNAScope™ RNA in situ hybridisation**



0 RNA *in situ* hybridisations were conducted on 5 µm paraffin sections using an RNAScope™ probe  
1 detecting *mus musculus Cx3cl1* (#426211) with the RNAScope 2.5 HD Detection Kit (Brown),  
2 according to manufacturer's instructions (ACD Biotechne).

### 4 **Testosterone supplementation experiment**

5 Testosterone or placebo implants were placed under gas anaesthesia, in the interscapular region of  
6 4-week-old *Znrf3 cKO* female mice for 60 days. These testosterone implants (T-M/60, Belma) are  
7 designed to release daily doses of testosterone (from 51.9 to 154.5 µg/24hr for plasma  
8 concentrations of 0.9-3.7 ng/ml) to produce physiological plasma concentrations in mice.

### 0 **Pexidartinib experiment**

1 Chow was purchased from SAFE Nutrition Services (Augy, France). Male Control & ZKO mice  
2 were fed either control chow (E8220A01R 00000 v0025 A04 Pur) or pexidartinib chow  
3 (E8220A01R 00000 v0398 A04 +0.29g/kg Pexidartinib) from 3-12 weeks of age. Pexidartinib  
4 (HY16749) was purchased from MedChemExpress and incorporated in the chow by SAFE  
5 Nutrition Services. Chow was replaced every 3-4 days, renewed weekly and stored at 4°C when  
6 not in use.

### 8 **FACS**

9 Adrenals were harvested and excess fat was removed under a dissecting microscope. Adrenals were  
0 immediately placed into 900µL of digestion medium (Supplementary Table 2) and placed on ice  
1 until the end of the harvest. Adrenals were digested by incubating with a thermomixer set at 37°C  
2 -900 rpm- for 37 min, stopping to pipette up and down at 10, 20, 30, 35, & 37min. Digested samples  
3 were filtered through 100µm nylon mesh and centrifuged at 400g for 5 min at 4°C. Cells were  
4 resuspended in wash buffer (PBS – EDTA 2.5mM – DNase 100µg/ml – BSA 0.5%) and stained  
5 appropriately. Cells were stained with Fixable Near-IR live/dead stain (L34975, Invitrogen) for  
6 30min at room temperature (RT), blocked with CD16/CD32 & TrueStain (426102, BioLegend) for  
7 15 min at RT, and stained with the appropriate antibody panel for 20 min at RT (Supplementary  
8 Table 3). All staining/blocking steps were preceded and followed by wash steps which included  
9 centrifugation at 200g for 4 min, followed by resuspension of the pellet with either wash buffer or  
0 the appropriate solution. Cells were immediately analysed on the Attune NxT Flow Cytometer  
1 (Reference: A24858). Detailed analyses of the results were done using FlowJo® software.

### 3 **Reverse-transcription quantitative PCR**

4 Adrenals were flash-frozen and stored at -80°C post-harvest. RNAs were extracted using the  
5 Macherey-Nagel Nucleospin RNA kit (REF #740955.250). After reverse transcription of 500ng of  
6 total RNAs, cDNAs were diluted 1/10 and PCR reactions were conducted using SYBR qPCR  
7 Premix Ex Taq II Tli RNase H+ (TAKRR820W, Takara). Primers can be found in Supplementary  
8 Table 4. Relative expression was calculated using the  $2^{-\Delta\Delta CT}$  method.

## 0 **RNA sequencing for gene expression analysis**

### 1 **Library preparation and sequencing**

2 RNA sequencing was performed by the GenomEast platform, a member of the 'France Genomique'  
3 consortium (ANR-10-INBS-0009). Library preparation was performed using TruSeq Stranded  
4 mRNA Reference Guide - PN 1000000040498. RNA-Seq libraries were generated from 300 ng of  
5 total RNA using TruSeq Stranded mRNA Library Prep Kit and IDT for Illumina - TruSeq RNA  
6 UD Indexes (96 Indexes, 96 Samples) (Illumina, San Diego, USA), according to manufacturer's  
7 instructions. Briefly, following purification with poly-T oligo attached magnetic beads, the mRNA  
8 was fragmented using divalent cations at 94°C for 2 minutes. The cleaved RNA fragments were  
9 copied into first strand cDNA using reverse transcriptase and random primers. Strand specificity  
0 was achieved by replacing dTTP with dUTP during second strand cDNA synthesis using DNA  
1 Polymerase I and RNase H. Following addition of a single 'A' base and subsequent ligation of the  
2 adapter on double stranded cDNA fragments, the products were purified and enriched with PCR  
3 (30 sec at 98°C; [10 sec at 98°C, 30 sec at 60°C, 30 sec at 72°C] x 12 cycles; 5 min at 72°C) to  
4 create the cDNA library. Surplus PCR primers were further removed by purification using SPRI  
5 select beads (Beckman-Coulter, Villepinte, France) and the final cDNA libraries were checked for  
6 quality and quantified using capillary electrophoresis. Libraries were sequenced on an Illumina  
7 HiSeq 4000 sequencer as single read 50 base reads. Image analysis and base calling were performed  
8 using RTA version 2.7.7 and bcl2fastq version 2.20.0.422.

### 9 **Genome mapping and differential gene expression analyses**

0 Reads were filtered and trimmed to remove adapter-derived or low-quality bases using cutadapt v  
1 3.2 and checked again with FASTQC v 0.11.7. Illumina reads were aligned to mouse reference  
2 genome (mm10) with Hisat2 v 2.2.1. Read counts were generated for each annotated gene using R  
3 function "SummarizeOverlaps()" and RPKM were calculated for each gene. Differential expression  
4 analysis with multiple testing correction was conducted using the R Bioconductor DESeq2 package  
5 v 1.34.0. Raw (fastq) and processed data were deposited on Gene Expression Omnibus under  
6 accession # GSE202940.

### 7 **Generation of heatmaps**

8 Heatmaps to represent differential gene expression were generated with the *Biobase* and *gplots*  
9 packages in R. They represent median centred RPKM levels. Genes are either sorted by Log2 fold-  
0 change or by unsupervised clustering.

1

## 2 **Reanalysis of single cell sequencing of adult mouse adrenals**

3 The Seurat R package (72) was used to perform clustering analysis of single-cell data from Lopez  
4 et al. (51), available in the Gene Expression Omnibus GSE161751 (control adrenals from 10 week-  
5 old male mice). Raw sequencing data and annotated gene–barcode matrices were used for the input.  
6 Cells with more than 20 genes and genes expressed in more than 3 cells were selected for further  
7 analysis. After studying the distribution of count depth, number of genes, and mitochondrial read  
8 fraction, low-quality cells with less than 1000 counts, less than 400 genes detected, and percentage  
9 of mitochondrial gene counts higher than 25% were removed. Gene expression in each cell was  
0 then normalized by the total number of counts in the cell, multiplied by 10000 to get counts per  
1 10000 (TP10K) and log-transformed to report gene expression as  $E = \log(\text{TP10K} + 1)$ .

2 The top 2,000 highly variable genes with a z-score cut-off of 0.5 were then centred and scaled to  
3 have a mean of zero and standard deviation of one, and used as inputs for initial principal  
4 component analysis (PCA). The number of principal components (PCs) was chosen according to  
5 the PCElbowPlot function and JackStrawPlot function. Next, the Louvain algorithm implemented  
6 in Seurat was used to iteratively group cells together, with the goal of optimizing the standard  
7 modularity function. The resolution parameter for clustering was set at  $r = 1$ . The default Wilcoxon  
8 rank-sum test was used by running FindAllMarkers function in Seurat to find differentially  
9 expressed markers in each cluster. Finally, each cell type was annotated after extensive literature  
0 reading and searching for specific gene expression patterns. Violin plot representations were used  
1 for visualizing expression of the different markers.

2

## 3 **TCGA adrenocortical carcinoma data**

4 TCGA gene expression and clinical ACC data were extracted from the TCGA database (The Cancer  
5 Genome Atlas). Distribution in the good (C1B) and poor prognosis (C1A) groups were previously  
6 defined, based on unsupervised clustering (27). Expression data were standardized by the Relative  
7 Standard Error of the Mean (RSEM) algorithm and transformed into log2 in order to refocus and  
8 symmetrize values' distribution. The macrophage signature was defined as the mean expression (Z-  
9 score) of *CD74*, *CXCL2*, *CCL4*, *APOE*, *CCL3*, *CTSS*, *C1QA*, *C1QB*, *C1QC* and *AIF1*. These were  
0 found as highly up-regulated genes in macrophages in single cell RNA sequencing analyses of adult  
1 mouse adrenals (51) (see above). For gene set enrichment analyses, TCGA ACC patients were

2 dichotomized based on the expression of a phagocytic signature (mean expression (Z-score) of  
3 *TYROBP*, *TREM2* and *CD68*) with patients classified as high (expression above median) or low  
4 (expression below median). Differential gene expression between patients from the phagocytic high  
5 and phagocytic low groups was computed using the *limma* R package. The volcano plot  
6 representing differential expression between these two groups was generated in R with the *calibrate*  
7 library. Kaplan Meier analysis was conducted in GraphPad prism after dichotomization of patients  
8 according to expression of the phagocytic signature.

9

## 0 **Gene Set enrichment analyses**

1 Gene set enrichment analyses were conducted on gene expression data from mouse models and  
2 TCGA ACC patients, using GSEA 4.1.0 with gene sets from the MsigDB and MGI Gene Ontology  
3 databases and with custom curated gene sets (Supplementary Table 5). Permutations were set to  
4 1000 and were performed on gene sets. Phagocytosis gene sets were curated from an extensive  
5 search of the literature, including papers by Park et al. (73), Lecoultre et al. (74) and Janda et al  
6 (75) and extracted from the MGI gene ontology database. Senescence gene sets were extracted from  
7 papers by Eggert et al. (37), Kuilman et al. (76), özcan et al. (77), Acosta et al. (78), Fridman et al.  
8 (79), Coppé et al. (80, 81), Buhl et al. (82) and Saul et al. (83). LM22 and ImmuCC gene sets were  
9 derived from gene expression signatures published in Newman et al. (84) and Chen et al. (32). To  
0 reduce the gene expression matrix into simple gene identifier lists for GSEA, genes in each of the  
1 lists were attributed to their cognate immune cell type based on their maximum of expression across  
2 all cell types. This resulted in gene signatures for each immune cell type that were then used in  
3 GSEA (Table). M0, M1 and M2 macrophages gene sets were further concatenated to result in global  
4 LM22 and ImmuCC macrophages gene sets. The mouse adrenal macrophages gene set was defined  
5 as the 100 most significantly upregulated genes within the two macrophages clusters (compared to  
6 all other clusters) in our reanalysis of the single-cell sequencing study of adult mouse adrenals by  
7 Lopez et al. (51). The cytokine gene set was curated from an extensive search of the literature.  
8 NFκB and DNA replication gene sets were extracted from MsigDB C2, Hallmarks and C5 datasets.  
9 GSEA output was either displayed as dot plots or enrichment curves. Dot plots represent the  
0 normalized enrichment score (NES) and FDR (size of dots defined as  $-\log_{10}(\text{FDR})$ ) and were drawn  
1 using the *ggplot2* library in R. Enrichment curves were drawn by feeding GSEA output to the  
2 *GSEA\_replot* R function, developed by Thomas Kuilman  
3 (<https://github.com/PeeperLab/Rtoolbox/blob/master/R/ReplotGSEA.R>). Dot plots and enrichment  
4 curves were further processed in Affinity Designer® for colour matching and superimposition.

5

## **CIBERSORTx and mMCP analyses**

CIBERSORTx (31) analyses were run on the CIBERSORTx server (<https://cibersortx.stanford.edu>) using the LM22 matrix and a mixture file representing gene expression data in control and *Znrf3* *cKO* adrenals at 4, 6 and 12 weeks or TCGA ACC patients' data, dichotomized on the basis of high or low expression of the phagocytic signature (see TCGA adrenocortical carcinoma data). Output of CIBERSORTx was then processed in R to concatenate subpopulations of macrophages, B cells, CD4 T cells, NK cells, DCs and mast cells. *Ggplot2* was then used to generate stacked bar plots representing the percentage of each immune cell population. Statistical analyses between genotypes or patients' groups were computed using the Mann-Whitney test.

mMCP analyses were run in R using the mMCP counter package (<https://github.com/cit-bioinfo/mMCP-counter>), following instructions in Petitprez et al. (33) Stacked bar plots were generated by *ggplot2* and statistical analyses conducted as above.

## **Statistical analyses**

Minimal sample size was set at  $n=3$  allowing for detection of 40% increases/decreases with  $\alpha=0.05$ ,  $\delta=0.4$  and  $SD=1.0$ . Statistical analyses were conducted with R and GraphPad Prism 9. Normality of data was assessed using D'Agostino & Pearson normality test. Statistical analyses were performed by two-tailed Student's *t*-test (two groups with normal distribution) or two-tailed Mann & Whitney test (two groups without normal distribution). Multiple comparisons were analysed by two-way ANOVA, followed by Sidak's multiple comparisons test. All bars represent the mean  $\pm$  SEM.

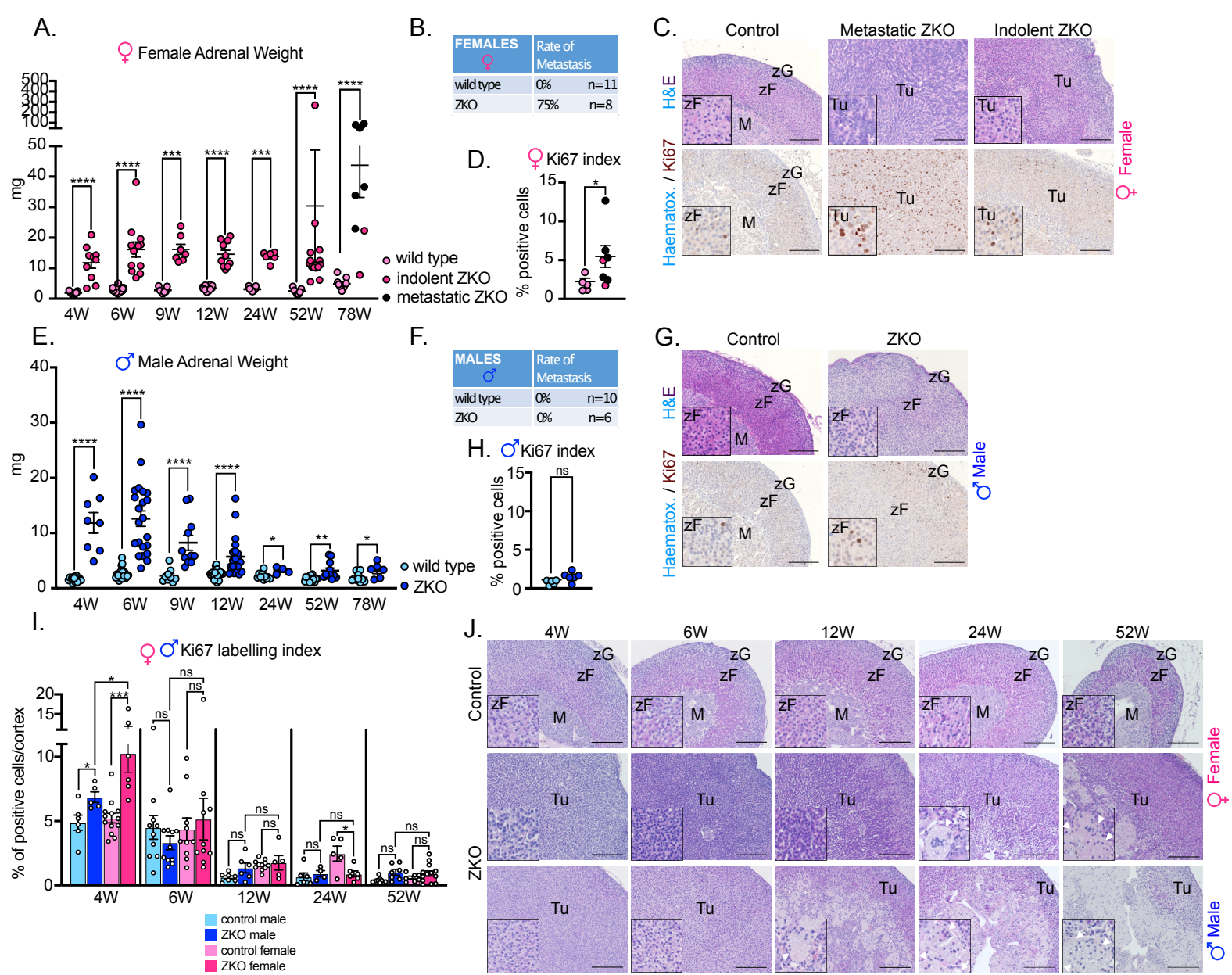
4 **Figure 8. Phagocytic macrophages signatures are prominent in male ACC patients and**

3 **Figure 9. Graphical abstract.** Inactivation of *Znrf3* in steroidogenic cells of the mouse adrenal  
4 cortex is associated with sexually dimorphic tumour progression. Although female knockouts  
5 develop metastatic carcinomas at 18 months, adrenal hyperplasia regresses in male knockouts. This  
6 male-specific phenotype is associated with androgen-dependent induction of senescence,  
7 recruitment and differentiation of highly phagocytic macrophages that clear-out senescent cells. In  
8 contrast, in females, macrophage recruitment is delayed and dampened, which allows for aggressive  
9 tumour progression. Analysis of TCGA-ACC data shows that phagocytic macrophages are more  
0 prominent in men and associated with better prognosis. Altogether, these data show that phagocytic

1 macrophages are key players in the sexual dimorphism of ACC and establish them as novel  
2 potential allies in the fight against this cancer.

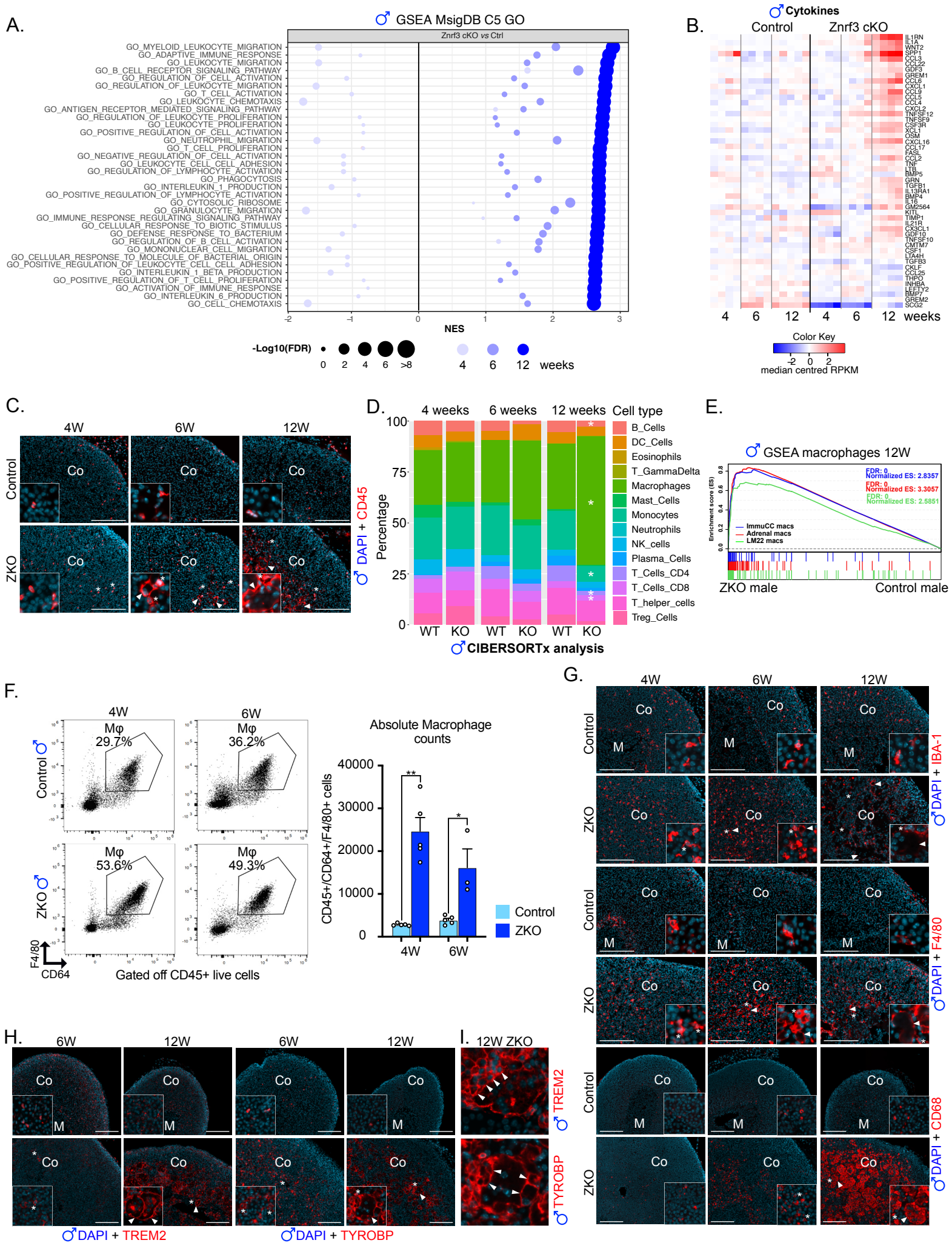
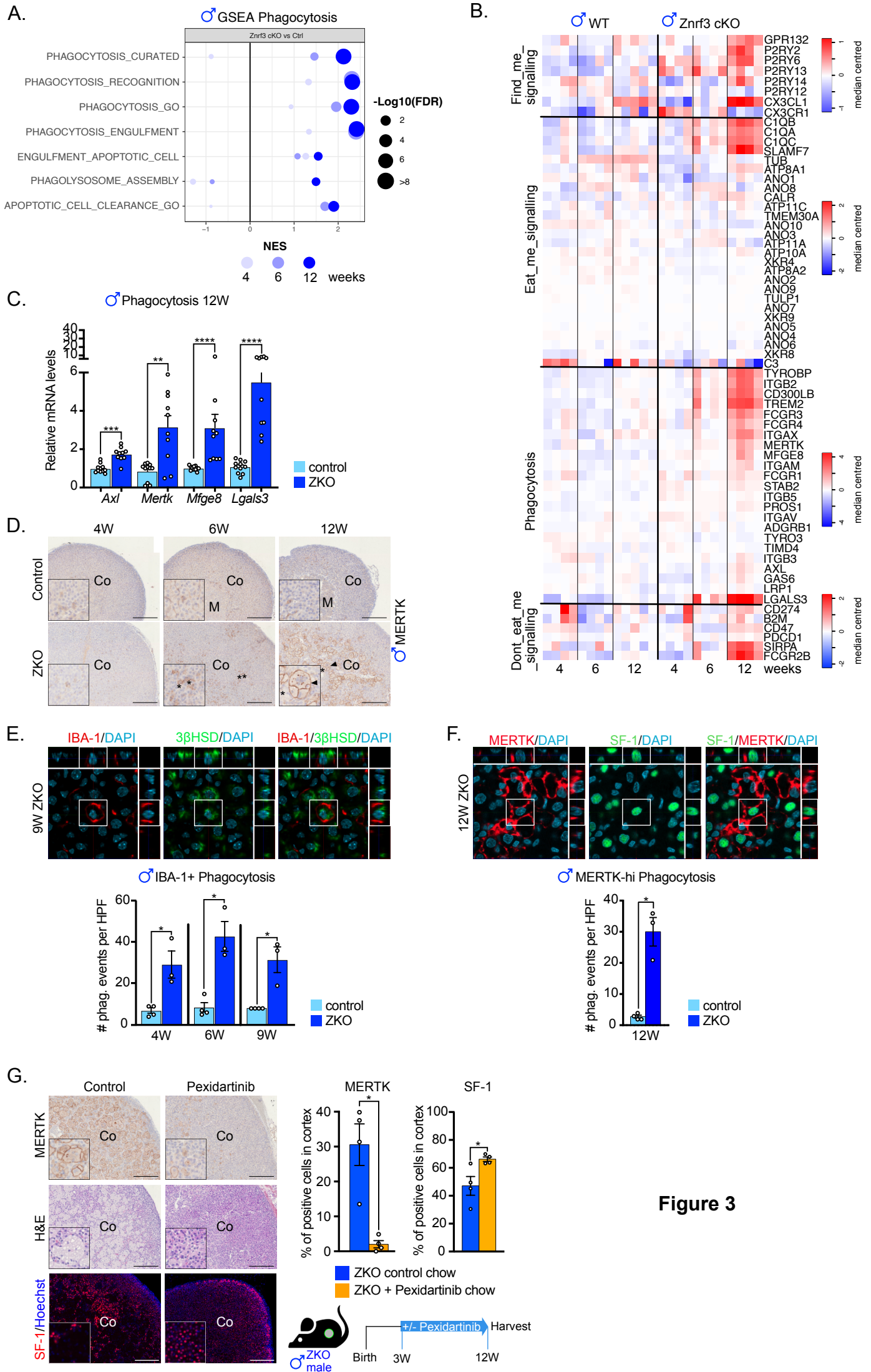
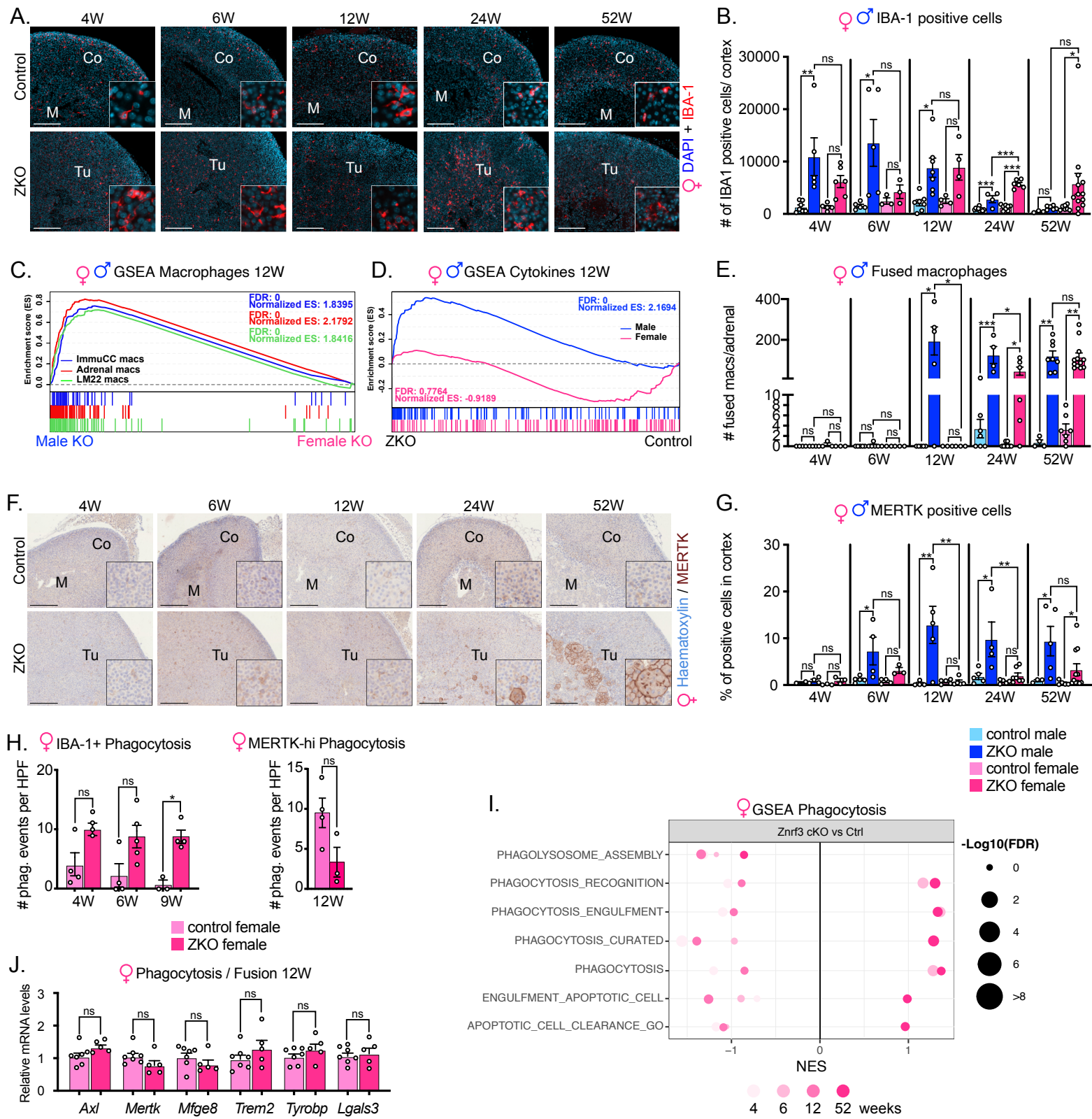


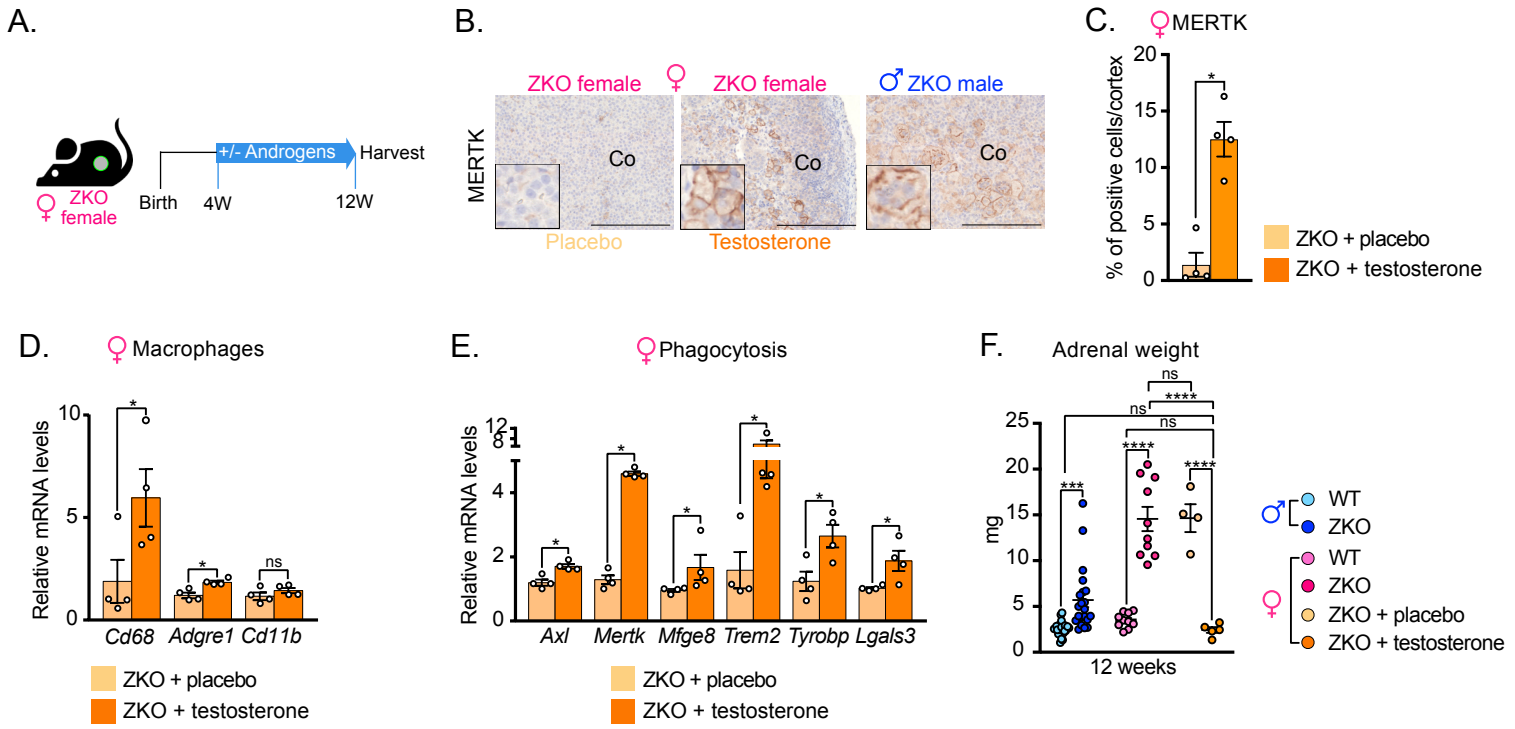

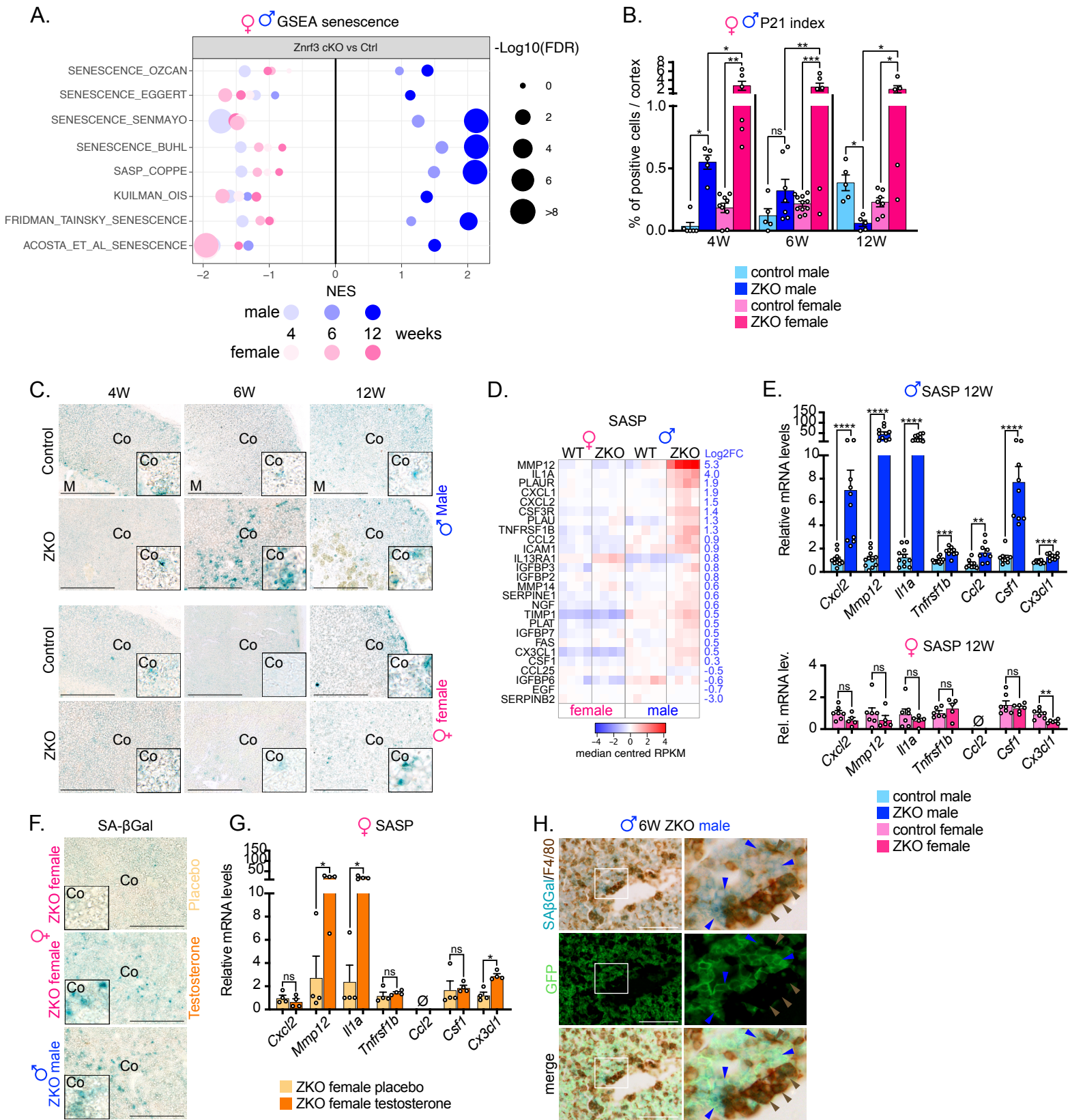

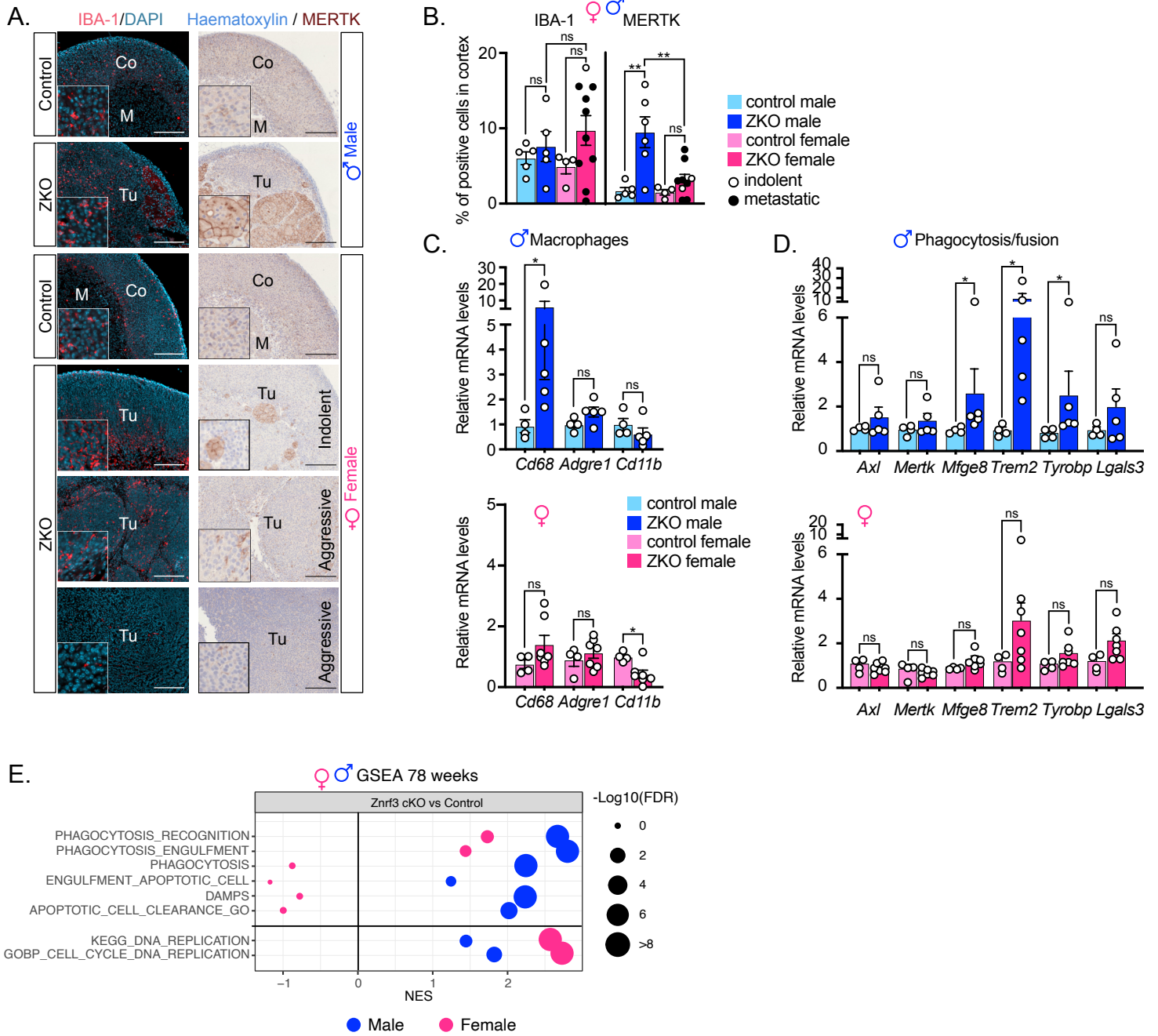

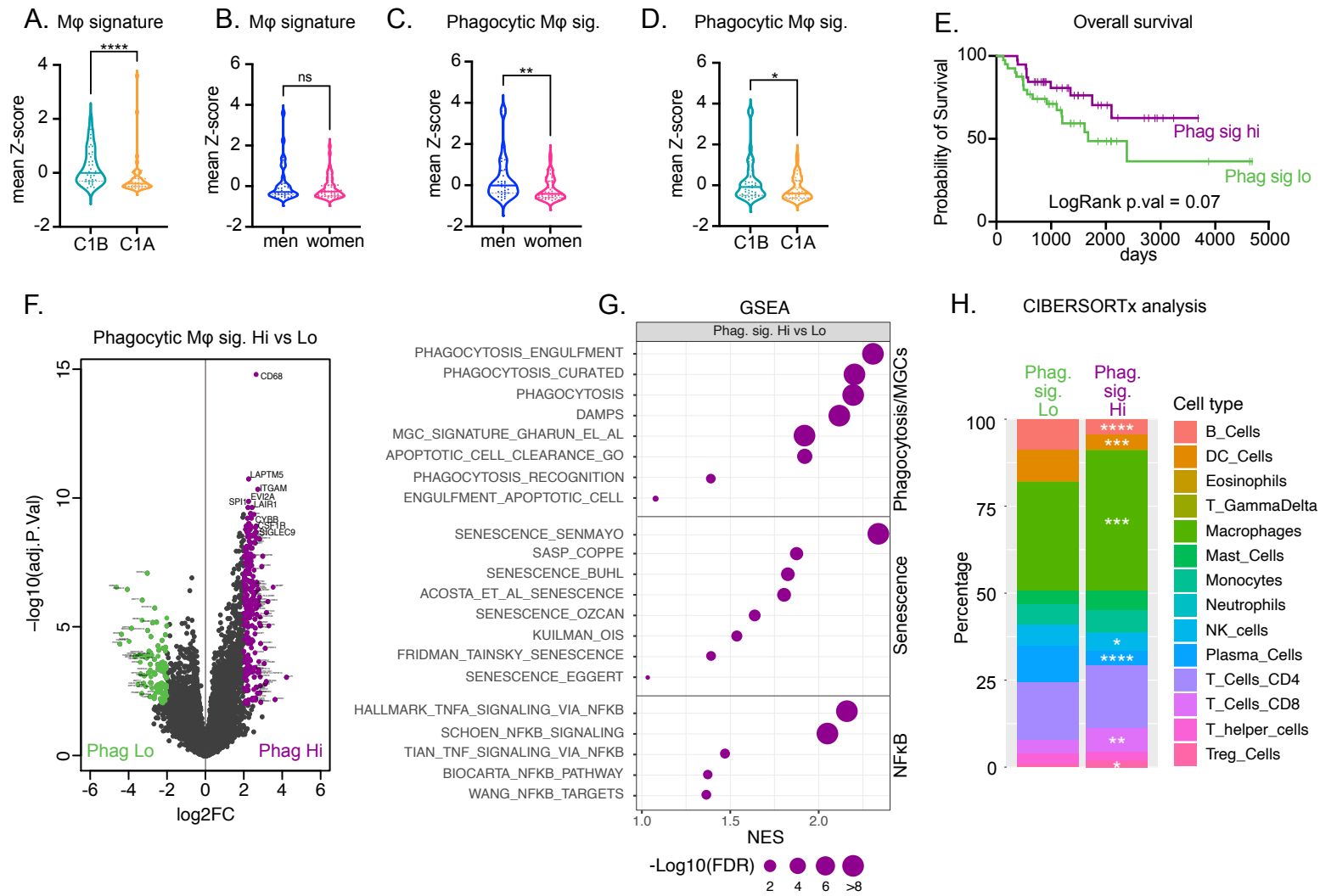




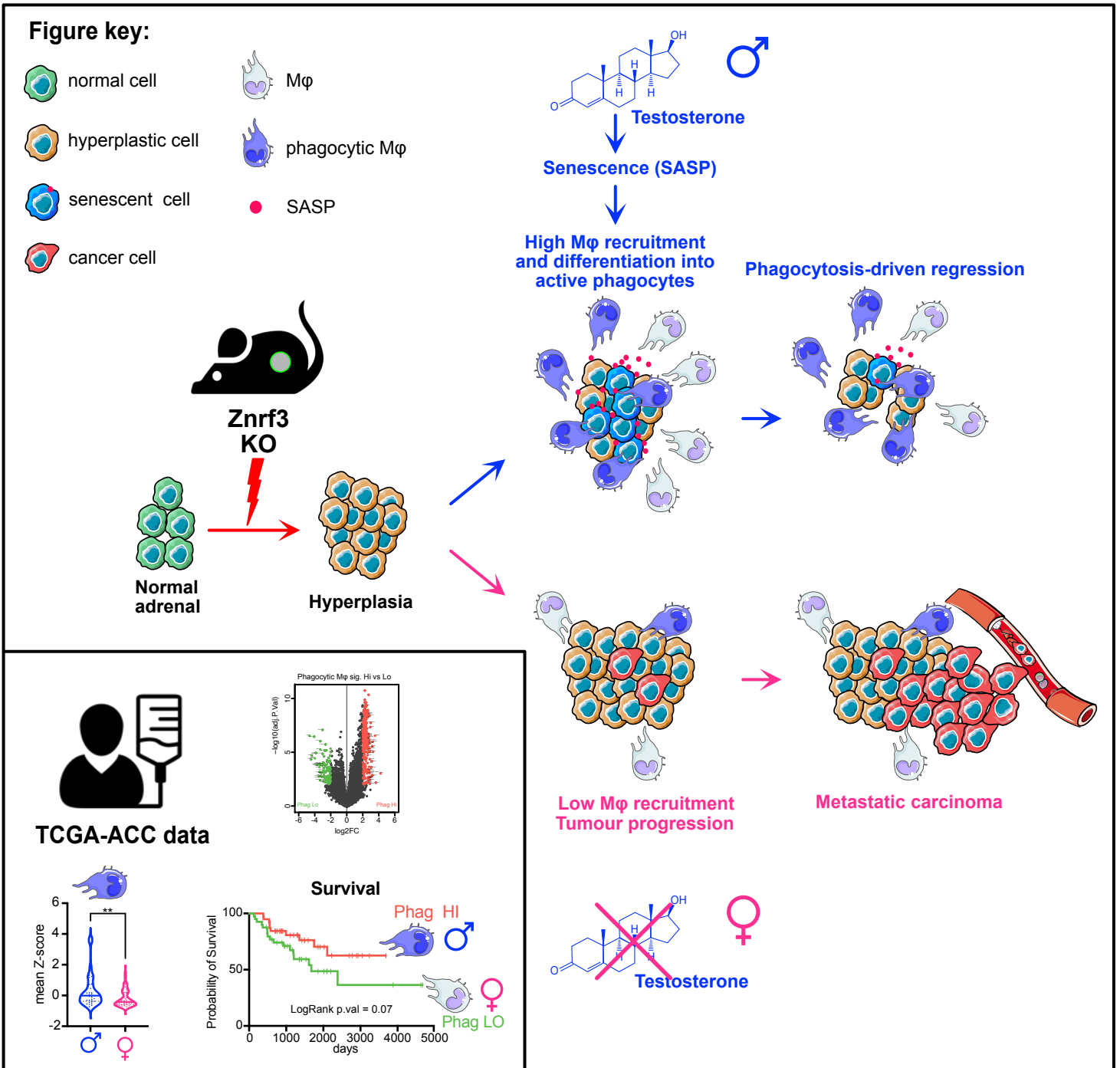
