## FRAMING THE AREA FOR AVOIDING VISUAL INTERFERENCE AND **OPTIMIZING VISUAL SEARCH IN ADOLESCENTS AND ADULTS**

Visual distractions as a key factor during visual search Because of our limited attentional capacity (Desimone & Duncan, 1995), searching for relevant information frequently induces attentional competition between

Handling with visual distractors plays a key role during effective visual search and depends, at least in part, on the target and distractors attributes (e.g., Duncan &

Ignoring visual distractors is critical to ensure optimal working memory performance through lifespan (e.g., Zanto & Gazzaley, 2009).

The use of compound stimuli has proven helpful in teasing apart the effects of global and local properties of visual stimuli on both object recognition (Gerlach & Poirel, 2018) and visual search tasks (Kimchi et al., 2005).

Searching for details in our visual environment frequently requires cognitive resources (Poirel et al., 2014; see also Navon, 2003; Poirel et al., 2008).

During visual search task, participants require more time to identify a target at the local level as the number of distractors increases (e.g., Krakowski et

al., 2015). **AIMS OF THE STUDY** We investigated the developmental impact of a frame that delimits a portion of a screen during visual search, and how the frame can prevent the processing of irrelevant stimuli located outside of it during a demanding detail-local oriented attentional task - Adolescents: n=41 (M = 12.4 years, SD = 0.6) with normal or corrected-to-normal visual acuity. Sample Target : - Frame group : n=21 (M= 12.6 years, SD = 0.5) - No-frame group : n=20 (M= 12.3 years, SD = 0.7) Local-oriented trial - Adults: - Frame group : n=46 (M = 22.5 years, SD = 5.0) with normal or corrected-to-normal visual acuity. Stimuli All the stimuli were hierarchical Navon-like figures (Navon, 1977). Target stimuli contained a square at the target level (local Inside-frame and outsideor global level) and circles at the irrelevant level frame distractor conditions Frame group procedure The frame appeared at one of five possible positions on the screen (upper right, upper left, lower right, × 1 × 3 × 5 lower left, or center) x 3 x 9 - Target-present trials (50%) : The target was located inside a gray frame with one or more inside and outside distractors. - Target-absent trials (50%) : Trials were matched with each target-present trial by replacing the target stimulus with a non-target. No-frame group procedure: The exact same items were used, except that the frame was absent. These results suggest that a frame presented on a visual display can prevent attentional resources from being caught by irrelevant stimuli presented outside of the frame (Bouhassoun et al., 2021). The present results suggest that: (1) Using a frame that delimits a topographical visual area is a concrete and efficient approach for optimizing the allocation of attention during visual search in DISCUSSI

both middle-school adolescents and adults.

(2) This effect of physical framing on visual search performance is found in both adults and adolescents, although adults are faster, which probably reflects a better executive control with age related to the maturation of the prefrontal cortex (e.g., Gogtay et al., 2004).

Our findings also provide evidence that local details processing can be improved without modifying the structure of the stimulus (Bouhassoun et al., 2021).

These findings afford a better understanding of the deployment of attention during visual search and hold implications for daily real-world situations such as academic/learning situations that require visual attention to be maintained over long periods of time.

#### TAKE HOME MESSAGE

When a frame delimits a restricted topographical visual area, it refrains the influence of an increasing number of outside-frame distractors for both adolescents and adults.
