# The Navier-Stokes equations in mixed-norm time-space parabolic Morrey spaces.

#### Abstract

We discuss the Navier-Stokes equations with forces in the mixednorm time-space parabolic Morrey spaces of Krylov.


Keywords : Navier-Stokes equations, heat equation, parabolic Morrey spaces, mild solutions.

AMS classification : 35K55, 35Q30, 76D05.

## 1 Introduction

In this paper, we consider global mild solutions of the Cauchy problem for the incompressible Navier-Stokes equations on the whole space $\mathbb{R}^{3}$. More precisely, the Navier-Stokes equations we study are

$$
\left\{\begin{array}{l}
\partial_{t} \vec{u}=\Delta \vec{u}-\vec{\nabla} p-\vec{u} \cdot \vec{\nabla} \vec{u}+\vec{f}+\operatorname{div} \mathbb{F}  \tag{1}\\
\operatorname{div} \vec{u}=0 \\
\vec{u}(0, .)=0
\end{array}\right.
$$

where $\vec{f}$ and $\mathbb{F}$ are small enough in some critical (homogeneous) mixed-norm time-space parabolic Morrey spaces of Krylov.
(Following Krylov [Kryl23]), let us recall the definition of mixed-norm time-space parabolic Morrey spaces on $\mathbb{R} \times \mathbb{R}^{d}$ :

[^0]Definition 1. Let $1<p, q<+\infty$ and $\beta \in\left(0, \frac{2}{p}+\frac{d}{q}\right)$. The parabolic Morrey spaces $E_{p, q, \beta}$ and $F_{p, q, \beta}$ are the spaces of locally integrable functions $f(t, x)$ on $\mathbb{R} \times \mathbb{R}^{d}$ such that $\|f\|_{E_{p, q, \beta}}<+\infty$ or $\|f\|_{F_{p, q, \beta}}<+\infty$, where

$$
\|f\|_{E_{p, q, \beta}}=\sup _{\rho>0, t \in \mathbb{R}, x \in \mathbb{R}^{d}} \rho^{\beta-\frac{2}{p}-\frac{d}{q}}\left(\int_{|t-s|<\rho^{2}}\left(\int_{|x-y|<\rho}|f(s, y)|^{q} d y\right)^{\frac{p}{q}} d s\right)^{\frac{1}{p}}
$$

and

$$
\|f\|_{F_{p, q, \beta}}=\sup _{\rho>0, t \in \mathbb{R}, x \in \mathbb{R}^{d}} \rho^{\beta-\frac{2}{p}-\frac{d}{q}}\left(\int_{|x-y|<\rho}\left(\int_{|t-s|<\rho^{2}}|f(s, y)|^{p} d s\right)^{\frac{q}{p}} d y\right)^{\frac{1}{q}} .
$$

Remark: when $p=q$, writing $r=\frac{d+2}{\beta}$ (so that $p<r<+\infty$ ), we see that $E_{p, p, \beta}=F_{p, p, \beta}=\mathcal{M}_{2}^{p, r}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$, where $\mathcal{M}_{2}^{p, r}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$ is the parabolic Morrey space studied in [Lema16] in the context of Navier-Stokes equations.

Krylov [Kryl23] developed a theory of Itô stochastic equations with as singular a drift as possible. Following an observation of Kinzebulatov [Kinz23], he considered a drift in parabolic Morrey spaces. We will show that his results can be easily applied to the Navier-Stokes problem. More precisely, we consider the initial value problem (on $(0,+\infty) \times \mathbb{R}^{3}$ ) with initial value $u(0,)=$.0 , that we transform as a problem on $\mathbb{R} \times \mathbb{R}^{3}$ by extending the Navier-Stokes solution by $\vec{u}(t,)=$.0 for $t<0$.

For a function defined on $(0,+\infty) \times \mathbb{R}^{d}$, we say that $f \in E_{p, q, \beta}$ or $f \in F_{p, q, \beta}$ if the function $f^{\#}$ defined by $f^{\#}=f$ for $t>0$ and $f^{\#}=0$ for $t<0$ is such that $f^{\#} \in E_{p, q, \beta}$ or $f^{\#} \in F_{p, q, \beta}$.

Our main theorem is the following one:
Theorem 1. Let $p, q \in(3, \infty)$ with $\frac{2}{p}+\frac{3}{q}>1$.
a) There exists $\epsilon_{0}=\epsilon_{0}(p, q)>0$ and $C_{0}=C_{0}(p, q)>0$ such that, if $\vec{f} \in$ $E_{p / 3, q / 3,3}$ with $\operatorname{div} \vec{f}=0$ and $\mathbb{F} \in E_{p / 2, q / 2,2}$ and if

$$
\|\vec{f}\|_{E_{p / 3, q / 3,3}}+\|\mathbb{F}\|_{E_{p / 2, q / 2,2}}<\epsilon_{0}
$$

then the Navier-Stokes equations (1) have a global mild solution $\vec{u} \in E_{p, q, 1}$ and $\vec{\nabla} \otimes \vec{u} \in E_{p / 2, q / 2,2}$ with

$$
\|\vec{u}\|_{E_{p, q, 1}}+\|\vec{\nabla} \otimes \vec{u}\|_{E_{p / 2, q / 2,2}} \leq C_{0}\left(\|\vec{f}\|_{E_{p / 3, q / 3,3}}+\|\mathbb{F}\|_{E_{p / 2, q / 2,2}}\right) .
$$

b) There exists $\epsilon_{0}=\epsilon_{0}(p, q)>0$ and $C_{0}=C_{0}(p, q)>0$ such that, if $\vec{f} \in$ $F_{p / 3, q / 3,3}$ with $\operatorname{div} \vec{f}=0$ and $\mathbb{F} \in F_{p / 2, q / 2,2}$ and if

$$
\|\vec{f}\|_{F_{p / 3, q / 3,3}}+\|\mathbb{F}\|_{F_{p / 2, q / 2,2}}<\epsilon_{0}
$$

then the Navier-Stokes equations (1) have a global mild solution $\vec{u} \in F_{p, q, 1}$ and $\vec{\nabla} \otimes \vec{u} \in F_{p / 2, q / 2,2}$ with

$$
\|\vec{u}\|_{F_{p, q, 1}}+\|\vec{\nabla} \otimes \vec{u}\|_{F_{p / 2, q / 2,2}} \leq C_{0}\left(\|\vec{f}\|_{F_{p / 3, q / 3,3}}+\|\mathbb{F}\|_{F_{p / 2, q / 2,2}}\right) .
$$

When the force $\vec{f}$ is equal to 0 , we may lower the values of $p$ and $q$ :
Theorem 2. Let $p, q \in(2, \infty)$ with $\frac{2}{p}+\frac{3}{q}>1$.
a) There exists $\epsilon_{0}=\epsilon_{0}(p, q)>0$ and $C_{0}=C_{0}(p, q)>0$ such that, if $\mathbb{F} \in$ $E_{p / 2, q / 2,2}$ and

$$
\|\mathbb{F}\|_{E_{p / 2, q / 2,2}}<\epsilon_{0}
$$

then the Navier-Stokes equations (1) (with $\vec{f}=0$ ) have a global mild solution $\vec{u} \in E_{p, q, 1}$ and $\vec{\nabla} \otimes \vec{u} \in E_{p / 2, q / 2,2}$ with

$$
\|\vec{u}\|_{E_{p, q, 1}}+\|\vec{\nabla} \otimes \vec{u}\|_{E_{p / 2, q / 2,2}} \leq C_{0}\|\mathbb{F}\|_{E_{p / 2, q / 2,2}}
$$

b) There exists $\epsilon_{0}=\epsilon_{0}(p, q)>0$ and $C_{0}=C_{0}(p, q)>0$ such that, if $\mathbb{F} \in$ $F_{p / 2, q / 2,2}$ and if

$$
\|\mathbb{F}\|_{F_{p / 2, q / 2,2}}<\epsilon_{0},
$$

then the Navier-Stokes equations (1) (with $\vec{f}=0$ ) have a global mild solution $\vec{u} \in F_{p, q, 1}$ and $\vec{\nabla} \otimes \vec{u} \in F_{p / 2, q / 2,2}$ with

$$
\|\vec{u}\|_{F_{p, q, 1}}+\|\vec{\nabla} \otimes \vec{u}\|_{F_{p / 2, q / 2,2}} \leq C_{0}\|\mathbb{F}\|_{F_{p / 2, q / 2,2}}
$$

As usual, the mild solution $\vec{u}$ will be searched as a fixed point of the transform

$$
\vec{u} \mapsto \vec{T}(\vec{f})+\vec{T}(\mathbb{P} \operatorname{div} \mathbb{F})-\vec{T}(\mathbb{P} \operatorname{div}(\vec{u} \otimes \vec{u}))
$$

where $\vec{T}(\vec{f})=\int_{0}^{t} e^{(t-s) \Delta} \vec{f}(s,) d$.$s . Let us remark that, if X=E_{p, q, 1}$ or $X=F_{p, q, 1}$, then $X$ is a critical space with respect to the scaling of the Navier-Stokes equations: for $\lambda>0,\left\|\lambda \vec{u}\left(\lambda^{2} t, \lambda x\right)\right\|_{X}=\|\vec{u}\|_{X} . E_{p, q, 1}$ is easily compared to other classical spaces; for instance, we have, for Serrin spaces with $\frac{2}{p}+\frac{3}{q}=1, L_{t}^{p}\left((0,+\infty), L_{x}^{q}\left(\mathbb{R}^{3}\right)\right) \subset E_{p, q, 1}$, while $E_{p, q, \beta} \subset \mathcal{M}_{2}^{\min (p, q), 5}($ a critical space discussed in [Lema16]).

## 2 Heat equation

The proof of theorems 1 and 2 will rely on the theory of the heat equation $\partial_{t} u-\Delta u=f$ on $\mathbb{R} \times \mathbb{R}^{d}$ with the boundary condition $u=0$ at infinity. This condition will be defined as follows:

Definition 2. Let $u$ be a tempered distribution on $\mathbb{R} \times \mathbb{R}^{d}$. Then $u=$ 0 at infinity if for every $\theta>0$ one has $e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u \in L^{\infty}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$ and $\lim _{\theta \rightarrow+\infty}\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right\|_{\infty}=0$.

Easy examples of $u$ with $u=0$ at infinity are $u \in L_{t}^{p} L_{x}^{q}$ with $1 \leq p, q \leq$ $\infty,(p, q) \neq(\infty, \infty)$ or $u=\partial_{t} v_{0}+\sum_{j=1}^{d} v_{j}$ where $v_{j} \in L^{\infty}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$ for $0 \leq j \leq d$ : in the first case, we have $\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right\|_{\infty} \leq C\|u\|_{L^{p} L^{q}} \theta^{-\left(\frac{1}{p}+\frac{d}{2 q}\right)}$ and, in the second case, $\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right\|_{\infty} \leq C\left(\theta^{-1}\left\|v_{0}\right\|_{\infty}+\sum_{j=1}^{d} \theta^{-\frac{1}{2}}\left\|v_{j}\right\|_{\infty}\right)$. Easy examples of bounded functions $u$ with $u \neq 0$ at infinity are $u=1$, $u=\mathbb{1}_{t>0}$, or $u=\mathbb{1}_{x_{d}>0}$ : we have $\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right\|_{\infty}=1$, as $\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right\|_{\infty} \leq 1$ and $\lim _{\left(t, x_{d}\right) \rightarrow(+\infty,+\infty)} e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u(t, x)=1$.

Lemma 1. Let $u$ be a tempered distribution on $\mathbb{R} \times \mathbb{R}^{d}$ such that $u=0$ at infinity. If $\partial_{t} u-\Delta u=0$, then $u=0$.

Proof. Take the Fourier transform (in time and space variables) of the heat equation. We find

$$
\left(i \tau+|\xi|^{2}\right) \hat{u}(\tau, \xi)=0
$$

Thus, $\hat{u}$ is supported in $\{(0,0)\}$, hence is a sum of derivatives of the Dirac mass, and $u$ is a polynomial. As $e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u$ is then a polynomial, and as $e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u \in L^{\infty}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$, we find that $u$ is a constant; in that case, $e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u=u$. As $u=0$ at infinity, we have $u=0$.

Lemma 2. Let $1<p, q<+\infty$ and $\beta \in\left(0, \frac{2}{p}+\frac{d}{q}\right)$. If $u \in E_{p, q, \beta}$ or $u \in F_{p, q, \beta}$, then $u=0$ at infinity.

Proof. We give the proof for $u \in E_{p, q, \beta}$ (the case $u \in F_{p, q, \beta}$ is proved in a similar way). Let $W(t, x)$ be the inverse Fourier transform of $e^{-\tau^{2}-|\xi|^{4}}$. $W$ is in the Schwartz class of smooth functions with rapid decay. In particular, $(\sqrt{|t|}+|x|)^{d+2}|W(t, x)| \in L^{\infty}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$. Writing

$$
\begin{gathered}
\iint|W(t, x)||u(t, x)| d t d x \\
=\iint_{\sqrt{|t|}|+|x|<1}|W(t, x)||u(t, x)| d t d x+\sum_{j=0}^{+\infty} \iint_{2^{j}<\sqrt{|t|+|x|<2^{j+1}}}|W(t, x)||u(t, x)| d t d x \\
\leq C\|u\|_{E_{p, q, \beta}}\left(\left\|\mathbb{1}_{\sqrt{|t|+|x|<1}} W\right\|_{L_{t}^{\frac{p}{p-1}} L_{x}^{\frac{q}{q-1}}}+\sum_{j=0}^{+\infty} 2^{j\left(\frac{2}{p}+\frac{d}{q}-\beta\right)}\left\|\mathbb{1}_{2^{j}<\sqrt{|t|+|x|<2^{j+1}}} W\right\|_{L_{t}^{\frac{p}{p-1}} \frac{L_{x}^{q}}{q-1}}\right) \\
\leq C^{\prime}\|u\|_{E_{p, q, \beta}}\left(1+\sum_{j=0}^{+\infty} 2^{-j \beta}\right)=C_{1}\|u\|_{E_{p, q, \beta}},
\end{gathered}
$$

we get

$$
\begin{aligned}
\left|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u(t, x)\right| & \leq \iint W(s, y)\left|u\left(t+\theta^{2} s, x+\theta y\right)\right| d s d y \\
& \leq C_{1}\|u(t+\theta ., x+\sqrt{\theta} \cdot)\|_{E_{p, q, \beta}} \\
& =C_{1}\|u(\theta ., \sqrt{\theta} \cdot)\|_{E_{p, q, \beta}} \\
& =C_{1}\|u\|_{E_{p, q, \beta}} \theta^{-\beta / 2} .
\end{aligned}
$$

Thus, $\lim _{\theta \rightarrow+\infty}\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right\|_{\infty}=0$.
The proof of Theorems 1 and 2 will be based on the following results on the linear heat equation:
Theorem 3. Let $p, q \in(3, \infty)$ and $\beta>0$ with $\frac{2}{p}+\frac{3}{q}>\beta$.
a) If $f \in E_{p / 3, q / 3, \beta+2}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$, then the heat equation

$$
\begin{equation*}
\partial_{t} u=\Delta u+f \tag{2}
\end{equation*}
$$

has a unique solution such that $u=0$ at infinity. Moreover, there exists $C_{0}=C_{0}(p, q, \beta)>0$ such that, if denoting by $D_{x} u$ the gradient of $u$ and by $D_{x}^{2} u$ the Hessian of $u$ (with respect to the space variable), we have
$\|u\|_{E_{p, q, \beta}}+\left\|D_{x} u\right\|_{E_{p / 2, q / 2, \beta+1}}+\left\|D_{x}^{2} u\right\|_{E_{p / 3 / q / 3, \beta+2}}+\left\|\partial_{t} u\right\|_{E_{p / 3, q / 3, \beta+2}} \leq C_{0}\|f\|_{E_{p / 3, q / 3, \beta+2}}$.
b) If $\in F_{p / 3, q / 3, \beta+2}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$, then the heat equation (2) has a unique solution such that $u=0$ at infinity. Moreover, there exists $C_{0}=C_{0}(p, q, \beta)>0$ such that we have
$\|u\|_{F_{p, q, \beta}}+\left\|D_{x} u\right\|_{F_{p / 2, q / 2, \beta+1}}+\left\|D_{x}^{2} u\right\|_{F_{p / 3, q / 3, \beta+2}}+\left\|\partial_{t} u\right\|_{F_{p / 3, q / 3, \beta+2}} \leq C_{0}\|f\|_{F_{p / 3, q / 3, \beta+2}}$.
Theorem 4. Let $p, q \in(2, \infty)$ and $\beta>0$ with $\frac{2}{p}+\frac{3}{q}>\beta$. Let $\sigma(D)$ be a Fourier multiplier (in the space variable) such that $\sigma(\xi)=\sigma_{0}\left(\frac{\xi}{|\xi|}\right)$ where $\sigma_{0}$ is a smooth function on the sphere $\mathcal{S}^{d-1}$.
a) If $\mathbb{F} \in E_{p / 2, q / 2, \beta+1}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$, then the heat equation

$$
\begin{equation*}
\partial_{t} u=\Delta u+\sigma(D) \operatorname{div} \mathbb{F} \tag{3}
\end{equation*}
$$

has a unique solution such that $u=0$ at infinity. Moreover, there exists $C_{0}=C_{0}(p, q, \beta, \sigma)>0$ such that we have

$$
\|u\|_{E_{p, q, \beta}}+\left\|D_{x} u\right\|_{E_{p / 2, q / 2, \beta+1}} \leq C_{0}\|\mathbb{F}\|_{E_{p / 2, q / 2, \beta+1}} .
$$

b) If $\mathbb{F} \in F_{p / 2, q / 2, \beta+1}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$, then the heat equation (3) has a unique solution such that $u=0$ at infinity. Moreover, there exists $C_{0}=C_{0}(p, q, \beta, \sigma)>0$ such that we have

$$
\|u\|_{F_{p, q, \beta}}+\left\|D_{x} u\right\|_{F_{p / 2, q / 2, \beta+1}} \leq C_{0}\|\mathbb{F}\|_{F_{p / 2, q / 2, \beta+1}} .
$$

Theorem 3 has the following corollary on Sobolev-Morrey inequalities:
Corollary 1. Let $p, q \in(3, \infty)$ and $\beta>0$ with $\frac{2}{p}+\frac{3}{q}>\beta$. Let $u=0$ at infinity. Then there exists $C_{0}=C_{0}(p, q, \beta)>0$ such that we have
$\|u\|_{E_{p, q, \beta}}+\left\|D_{x} u\right\|_{E_{p / 2, q / 2, \beta+1}}+\left\|D_{x}^{2} u\right\|_{E_{p / 3, q / 3, \beta+2}} \leq C_{0}\left(\left\|\partial_{t} u\right\|_{E_{p / 3, q / 3, \beta+2}}+\|\Delta u\|_{E_{p / 3, q / 3, \beta+2}}\right)$ and
$\|u\|_{F_{p, q, \beta}}+\left\|D_{x} u\right\|_{F_{p / 2, q / 2, \beta+1}}+\left\|D_{x}^{2} u\right\|_{F_{p / 3, q / 3, \beta+2}} \leq C_{0}\left(\left\|\partial_{t} u\right\|_{F_{p / 3, q / 3, \beta+2}}+\|\Delta u\|_{F_{p / 3, q / 3, \beta+2}}\right)$.
Another corollary is the following variation on the theorem of Krylov [Kryl23]:
Proposition 1. Let $p, q \in(3, \infty)$ and $\beta>0$ with $\frac{2}{p}+\frac{3}{q}>\max (\beta, 1)$. There exists $\epsilon_{0}=\epsilon_{0}(p, q, \beta)>0$ and $C_{0}=C_{0}(p, q, \beta)>0$ such that
a) If $f \in E_{p / 3, q / 3, \beta+2}\left(\mathbb{R} \times \mathbb{R}^{d}\right), \vec{b} \in E_{p, q, 1}, c \in E_{p / 2, q / 2,2}$, and if $\|\vec{b}\|_{E_{p, q, 1}}+$ $\|c\|_{E_{p / 2, q / 2,2}}<\epsilon_{0}$, then the heat equation

$$
\begin{equation*}
\partial_{t} u=\Delta u+\vec{b} \cdot \vec{\nabla} u+c u+f \tag{4}
\end{equation*}
$$

has a unique solution such that $u=0$ at infinity. Moreover, we have

$$
\begin{aligned}
& \|u\|_{E_{p, q, \beta}}+\left\|D_{x} u\right\|_{E_{p / 2, q / 2, \beta+1}}+\left\|D_{x}^{2} u\right\|_{E_{p / 3, q / 3, \beta+2}} \\
& \quad \leq C_{0}\left(\|f\|_{E_{p / 3, q / 3, \beta+2}}+\|\vec{b}\|_{E_{p, q, 1}}+\|c\|_{E_{p / 2, q / 2,2}}\right)
\end{aligned}
$$

b) If $f \in F_{p / 3, q / 3, \beta+2}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$, $\vec{b} \in F_{p, q, 1}, c \in F_{p / 2, q / 2,2}$, and if $\|\vec{b}\|_{F_{p, q, 1}}+$ $\|c\|_{F_{p / 2, q / 2,2}}<\epsilon_{0}$, then the heat equation (4) has a unique solution such that $u=0$ at infinity. Moreover, we have

$$
\begin{aligned}
& \|u\|_{F_{p, q, \beta}}+\left\|D_{x} u\right\|_{F_{p / 2, q / 2, \beta+1}}+\left\|D_{x}^{2} u\right\|_{F_{p / 3, q / 3, \beta+2}} \\
& \quad \leq C_{0}\left(\|f\|_{F_{p / 3,3 / 3 /, \beta+2}}+\|\vec{b}\|_{F_{p, q, q}}+\|c\|_{F_{p / 2, q / 2,2}}\right) .
\end{aligned}
$$

## 3 Anisotropic Hardy-Littlewood maximal function on mixed norm Lebesgue spaces

Let $\vec{p}=\left(p_{1}, \ldots, p_{n}\right) \in(1,+\infty)^{n}$. The mixed-norm Lebesgue spaces $L^{\vec{p}}\left(\mathbb{R}^{n}\right)$ is the space of measurable functions on $\mathbb{R}^{n}$ such that

$$
\|f\|_{L \vec{p}}=\left(\int \ldots\left[\int\left\{\int\left|f\left(x_{1}, \ldots, x_{n}\right)\right|^{p_{1}} d x_{1}\right\}^{\frac{p_{2}}{p_{1}}}\right]^{\frac{p_{3}}{p_{2}}} \ldots d x_{n}\right)^{\frac{1}{p_{n}}}<+\infty
$$

For $\vec{a}=\left(a_{1}, \ldots, a_{n}\right) \in[1,+\infty)^{n}$, the anisotropic cylinders $Q_{\vec{a}}(x, r)$ are defined as

$$
Q_{\vec{a}}(x, r)=\left(x_{1}-r^{a_{1}}, x_{1}+r^{a_{1}}\right) \times \ldots\left(x_{n}-r^{a_{n}}, x_{n}+r^{a_{n}}\right)
$$

and the anisotropic Hardy-Littlewood maximal function is defined as

$$
\mathcal{M}_{\vec{a}} f(x)=\sup _{r>0} \frac{1}{\left|Q_{\vec{a}}(x, r)\right|} \int_{Q_{\vec{a}}(x, r)}|f(y)| d y
$$

We then have the following boundedness result for the anisotropic HardyLittlewood maximal function on mixed norm Lebesgue spaces [Huan19, Huan21]:

Proposition 2. For $\vec{p}=\left(p_{1}, \ldots, p_{n}\right) \in(1,+\infty)^{n}$ and $\vec{a}=\left(a_{1}, \ldots, a_{n}\right) \in$ $[1,+\infty)^{n}$, there exists a constant $C=C(\vec{p}, \vec{a})$ such that

$$
\left\|\mathcal{M}_{\vec{a}} f\right\|_{L^{\vec{p}}} \leq C\|f\|_{L^{\vec{p}}} .
$$

## 4 Harmonic analysis on the parabolic space

We endow $X=\mathbb{R} \times \mathbb{R}^{d}$ with the Lebesgue measure $d \mu(t, x)=d t d x$ and the parabolic metric $\rho((t, x),(s, y))=\sqrt{|t-s|}+|x-y|$. The parabolic ball $B_{r}(t, x)$ and the parabolic cylinder $C_{r}(t, x)$ are defined as
$B_{r}(t, x)=\{(s, y) / \rho((t, x),(s, y))<r\}$ and $C_{r}(t, x)=\left(t-r^{2}, t+r^{2}\right) \times B(x, r)$.
We have

$$
B_{r}(t, x) \subset C_{r}(t, x) \subset B_{2 r}(t, x)
$$

( $X, \rho, \mu$ ) is a space of homogeneous type [Coif71] of homogeneous dimension $Q=d+2:$

$$
\mu\left(B_{r}(t, x)\right)=\mu\left(B_{1}(0,0)\right) r^{Q} .
$$

We associate to this space three useful operators on (non-negative) functions: the Hardy-Littlewood maximal function $\mathcal{M}_{f}$ and the Riesz potentials $\mathcal{I}_{\alpha} f$ (where $0<\alpha<Q$ ) defined by

$$
\mathcal{M}_{f}(t, x)=\sup _{r>0} \frac{1}{\mu\left(B_{r}(t, x)\right)} \int_{B_{r}(t, x)}|f(s, y)| d \mu(s, y)
$$

and

$$
\mathcal{I}_{\alpha} f(t, x)=\int_{X} \frac{1}{\rho((t, x),(s, y))^{Q-\alpha}} f(s, y) d \mu(s, y) .
$$

For $1<p \leq q$, we define the Morrey space $\mathcal{M}_{2}^{p, q}$ by the space of measurable functions such that

$$
\|f\|_{\mathcal{M}_{2}^{p, q}}=\sup _{r>0,(t, x) \in X} \mu\left(B_{r}(t, x)\right)^{\frac{1}{q}-\frac{1}{p}}\left\|\mathbb{1}_{B_{r}(t, x)} f\right\|_{p}<+\infty .
$$

We have $L^{q}\left(\mathbb{R} \times \mathbb{R}^{d}\right) \subset \mathcal{M}_{2}^{p, q}, E_{p, p, \beta}=\mathcal{M}_{2}^{p, \frac{d+2}{\beta}}$ and $E_{p, q, \beta} \subset \mathcal{M}_{2}^{\min (p, q), \frac{d+2}{\beta}}$.
The main tool we shall use is Hedberg's inequality [Hedb72]:
Proposition 3. Let $1<p \leq q<+\infty$ and $0<\alpha<\frac{Q}{q}$. Then there exists a constant $C=C(d, p, q, \alpha)$ such that, for every $f \in \mathcal{M}_{2}^{p, q}$, we have

$$
\mathcal{I}_{\alpha} f(t, x) \leq C\left(\mathcal{M}_{f}(t, x)\right)^{1-\frac{\alpha q}{Q}}\|f\|_{\mathcal{M}_{2}^{p, q}}^{\frac{\alpha q}{Q}}
$$

Proof. We easily check that, for every $R>0$, we have

$$
\int_{B_{R}(t, x)} \frac{1}{\rho((t, x),(s, y))^{Q-\alpha}}|f(s, y)| d \mu(s, y) \leq C R^{\alpha} \mathcal{M}_{f}(t, x)
$$

and

$$
\int_{X \backslash B_{R}(t, x)} \frac{1}{\rho((t, x),(s, y))^{Q-\alpha}}|f(s, y)| d \mu(s, y) \leq C R^{\alpha-\frac{Q}{q}}\|f\|_{\mathcal{M}_{2}^{p, q} .}
$$

We then take

$$
R^{\frac{Q}{q}}=\frac{\|f\|_{\mathcal{M}_{2}^{p, q}}}{\mathcal{M}_{f}(t, x)}
$$

Applying Proposition 3 to Krylov spaces, we obtain:
Proposition 4. Let $1<p, q<+\infty$ and $0<\beta<\frac{2}{p}+\frac{d}{q}$. Then
a) $f \mapsto \mathcal{M}_{f}$ is bounded from $E_{p, q, \beta}$ to $E_{p, q, \beta}$ and from $F_{p, q, \beta}$ to $F_{p, q, \beta}$.
b) If $\beta>1$, $f \mapsto \mathcal{I}_{1} f$ is bounded from $E_{p, q, \beta}$ to $E_{\frac{\beta}{\beta-1} p, \frac{\beta}{\beta-1} q, \beta-1}$ and from $F_{p, q, \beta}$ to $F_{\frac{\beta}{\beta-1} p, \frac{\beta}{\beta-1} q, \beta-1}$.
c) If $\beta>2$, $f \mapsto \mathcal{I}_{2} f$ is bounded from $E_{p, q, \beta}$ to $E_{\frac{\beta}{\beta-2} p, \frac{\beta}{\beta-2} q, \beta-2}$ and from $F_{p, q, \beta}$ to $F_{\frac{\beta}{\beta-2} p, \frac{\beta}{\beta-2} q, \beta-2}$

Proof. We consider only the case of $E_{p, q, \beta}$, as the proof for $F_{p, q, \beta}$ is similar. Let us estimate $\mathcal{M}_{f}$ on a cylinder $C_{r}(t, x)$. We have $\mathcal{M}_{f} \leq \mathcal{M}_{f_{1}}+\mathcal{M}_{f_{2}}$, where $f_{1}=\mathbb{1}_{C_{4 r}(t, x)} f$ and $f_{2}=f-f_{1}$. By Proposition 2, we know that

$$
\left\|\mathcal{M}_{f_{1}}\right\|_{L_{t}^{p} L_{x}^{q}} \leq C\left\|f_{1}\right\|_{L_{t}^{p} L_{x}^{q}} \leq C^{\prime}\|f\|_{E_{p, q, \beta}} r^{r^{\frac{2}{p}+\frac{d}{q}-\beta}} .
$$

On the other hand, for $(s, z) \in C_{r}(t, x) \subset B_{2 r}(t, x)$, since $B_{4 r}(t, x) \subset$ $C_{4 r}(t, x)$,

$$
\mathcal{M}_{f_{2}}(s, z) \leq \sup _{\rho>2 r} \frac{1}{\left|B_{\rho}(s, z)\right|} \iint_{B_{\rho}(s, z)}|f(\sigma, y)| d \sigma d y \leq C^{\prime}\|f\|_{E_{p, q, \beta}} r^{-\beta}
$$

so that

$$
\left\|\mathbb{1}_{C_{r}(t, x)} \mathcal{M}_{f_{2}}\right\|_{L_{t}^{p} L_{x}^{q}} \leq C\|f\|_{E_{p, q, \beta}} r^{\frac{2}{p}+\frac{d}{q}-\beta}
$$

a) is proved. b) and c) are then direct consequences of Hedberg's inequality (Proposition 3).

## 5 The heat equation on $\mathbb{R} \times \mathbb{R}^{d}$.

In this section, we solve the heat equation on $\mathbb{R} \times \mathbb{R}^{d}$ :

$$
\left\{\begin{array}{l}
\partial_{t} u=\Delta u+g  \tag{5}\\
u=0 \text { at infinity }
\end{array}\right.
$$

where $g=f \in E_{p, q, \beta}$ or in $F_{p, q, \beta}$ with $2<\beta<\frac{2}{p}+\frac{d}{q}$ or $g=\sigma(D) \operatorname{div} \mathbb{F}$ where $\mathbb{F} \in E_{p, q, \beta}$ or in $F_{p, q, \beta}$ with $1<\beta<\frac{2}{p}+\frac{d}{q}$. The solution $u$ of equation (5) is given by the Duhamel formula

$$
u=\int_{-\infty}^{t} e^{(t-s) \Delta} g(s, .) d s
$$

In order to estimate $u$ and its derivatives, we need some estimates on the size of the kernel of $e^{t \Delta}$ and its derivatives, or on the derivatives of $\sigma(D) e^{t \Delta}$.

Lemma 3. Let $\psi \in \mathcal{S}\left(\mathbb{R}^{d}\right)$ and, for $\theta>0, \psi_{\theta}(x)=\frac{1}{\theta^{d}} \psi\left(\frac{x}{\theta}\right)$. Let $\sigma(D)$ be a Fourier multiplier (in the space variable) such that $\sigma(\xi)=\sigma_{0}\left(\frac{\xi}{|\xi|}\right)$ where $\sigma_{0}$ is a smooth function on the sphere $\mathcal{S}^{d-1}$. Then, for $\alpha \in \mathbb{N}^{d}$,

$$
\left|\partial_{\alpha} \sigma(D) \psi_{\theta}(x)\right| \leq C_{\alpha, \psi, \sigma} \frac{1}{(\theta+|x|)^{d+|\alpha|}}
$$

Proof. We have

$$
\left\|\partial_{\alpha} \sigma(D) \psi_{\theta}\right\|_{\infty}=\theta^{-d-|\alpha|}\left\|\partial_{\alpha} \sigma(D) \psi\right\|_{\infty}
$$

and

$$
\left\||x|^{d+|\alpha|} \partial_{\alpha} \sigma(D) \psi_{\theta}\right\|_{\infty}=\left\||x|^{d+|\alpha|} \partial_{\alpha} \sigma(D) \psi\right\|_{\infty}
$$

Thus, we may assume $\theta=1$. We have

$$
\left|\partial_{\alpha} \sigma(D) \psi_{\theta}(x)\right| \leq \frac{1}{(2 \pi)^{d}}\left\|\sigma_{0}\right\|_{\infty} \int|\xi|^{|\alpha|}|\hat{\psi}(\xi)| d x
$$

On the other hand, taking a smooth function $\phi$ such that $\phi(\xi)=1$ for $|\xi|<1$ and $\phi(\xi)=0$ for $|\xi|>2$, we have for every $R>0$, for $1 \leq k \leq d$,

$$
\left|x_{k}\right|^{d+|\alpha|}\left|\partial_{\alpha} \phi\left(\frac{D}{R}\right) \sigma(D) \psi_{\theta}(x)\right| \leq C(R|x|)^{d+\alpha}\left\|\sigma_{0}\right\|_{\infty}\|\hat{\psi}\|_{\infty}
$$

and

$$
\begin{aligned}
&|x|^{2}\left|x_{k}\right|^{d+|\alpha|}\left|\partial_{\alpha}\left(1-\phi\left(\frac{D}{R}\right)\right) \sigma(D) \psi_{\theta}(x)\right| \\
& \leq \frac{1}{(2 \pi)^{d}} \int\left|\Delta \partial_{k}^{d+|\alpha|}\left(\left(1-\phi\left(\frac{\xi}{R}\right)\right) \xi^{\alpha} \sigma(\xi) \hat{\psi}(\xi)\right)\right| d \xi \\
& \leq C \int_{|\xi|>R} \frac{d \xi}{|\xi|^{d+2}}=C^{\prime} \frac{1}{R^{2}}
\end{aligned}
$$

$\left.\left(\right.$ as $\left|\partial^{\beta}(\hat{\psi}(\xi))\right| \leq C_{\beta, \psi}|\xi|^{-|\beta|},\left|\partial^{\beta}\left(\xi^{\alpha} \sigma(\xi)\right)\right| \leq C_{\alpha, \beta, \sigma}|\xi|^{|\alpha|-|\beta|}$ and $\left.\left\lvert\, \partial^{\beta}\left(1-\phi\left(\frac{\xi}{R}\right)\right)\right.\right) \right\rvert\, \leq$ $\left.C_{\beta, \phi}|\xi|^{-|\beta|}\right)$. Taking $R=\frac{1}{|x|}$, we get $x_{k}^{d+|\alpha|} \partial^{\alpha} \sigma(D) \psi \in L^{\infty}$.

A useful result on the heat kernel is its maximal regularity in $L_{t}^{p} L_{x}^{q}$ or in $L_{x}^{q} L_{t}^{p}$ :

Proposition 5. Let $1<p, q<+\infty$. Let $\sigma(D)$ be a Fourier multiplier (in the space variable) such that $\sigma(\xi)=\sigma_{0}\left(\frac{\xi}{|\xi|}\right)$ where $\sigma_{0}$ is a smooth function on the sphere $\mathcal{S}^{d-1}$.
a) If $h \in L_{t}^{p} L_{x}^{q}$, then, for $1 \leq i, j \leq d$,

$$
\left\|\int_{-\infty}^{t} e^{(t-s) \Delta} \sigma(D) \partial_{i} \partial_{j} h d s\right\|_{L_{t}^{p} L_{x}^{q}} \leq C\|h\|_{L_{t}^{p} L_{x}^{q}}
$$

a) If $h \in L_{x}^{q} L_{t}^{p}$, then, for $1 \leq i, j \leq d$,

$$
\left\|\int_{\infty}^{t} e^{(t-s) \Delta} \sigma(D) \partial_{i} \partial_{j} h d s\right\|_{L_{x}^{q} L_{t}^{p}} \leq C\|h\|_{L_{x}^{q} L_{t}^{p}} .
$$

Proof. This is a classical result, obtained through the theory of vector valued singular integrals [Bene62]. We sketch the proof given in [Lema02]. Let $W(x)=\frac{1}{(4 \pi)^{d / 2}} e^{-\frac{|x|^{2}}{4}}$ and let

$$
\Omega(t, x)=\frac{1}{t^{\frac{d+2}{2}}}\left(\sigma(D) \partial_{i} \partial_{j} W\right)\left(\frac{x}{\sqrt{t}}\right) \text { for } t>0, \quad=0 \text { for } t<0 .
$$

We then consider the operator

$$
\begin{equation*}
T(g)(t, x)=\int_{\mathbb{R}} \int_{\mathbb{R}^{d}} \Omega(t-s, x-y) g(s, y) d s d y . \tag{6}
\end{equation*}
$$

We have

$$
\left(\partial_{t}-\Delta\right) T(g)=\sigma(D) \partial_{i} \partial_{j} g
$$

and, taking the Fourier transform,

$$
\widehat{T(g)}(\tau, \xi)=-\frac{\xi_{i} \xi_{j}}{i \tau+|\xi|^{2}} \sigma(\xi) \hat{g}(\tau, \xi)
$$

Thus, $T$ is bounded on $L^{2}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$. $T$ can be seen as Calderón-Zygmund operator on the parabolic space $\mathbb{R} \times \mathbb{R}^{d}$ (for the parabolic distance): from Lemma 3, we see that $|\Omega(t, x)| \leq C \frac{1}{(\sqrt{|t|}+|x|)^{d+2}},\left|\partial_{i} \Omega(t, x)\right| \leq C \frac{1}{(\sqrt{|t|}+|x|)^{d+3}}$, and $\left|\partial_{t} \Omega(t, x)\right|=|\Delta \Omega(t, x)| \leq C \frac{1}{(\sqrt{|t|}+|x|)^{d+4}}$. Thus, we get that $T$ is bounded on $L^{p}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$ for $1<p<+\infty$. Let $T_{t}$ be the operator

$$
T_{t}(v)=\int_{\mathbb{R}^{d}} \frac{1}{t} \Omega(t, x-y) v(y) d y
$$

and $T_{x}$ be the operator

$$
T_{x}(w)=\int_{\mathbb{R}} \frac{1}{t-s} \Omega(t-s, x) w(s) d s
$$

We have

$$
\partial_{t} T_{t}(v)=\int_{\mathbb{R}^{d}} \frac{1}{t} \Delta \Omega(t, x-y) v(y) d y
$$

and

$$
\partial_{k} T_{x}(w)=\int_{\mathbb{R}} \frac{1}{t-s} \partial_{k} \Omega(t-s, x) w(s) d s
$$

From Lemma 3, we find

$$
\left\|T_{t}\right\|_{L_{x}^{a} \mapsto L_{x}^{q}} \leq C \frac{1}{t} \text { and }\left\|\partial_{t} T_{t}\right\|_{L_{x}^{q} \mapsto L_{x}^{q}} \leq C \frac{1}{t^{2}}
$$

so that the continuity $L_{t}^{q}\left(L_{x}^{q}\right) \mapsto L_{t}^{q}\left(L_{x}^{q}\right)$ of $T$ can be extended to the continuity $L_{t}^{p}\left(L_{x}^{q}\right) \mapsto L_{t}^{p}\left(L_{x}^{q}\right)$. Similarly, we have

$$
\left\|T_{x}\right\|_{L_{t}^{p} \mapsto L_{t}^{p}} \leq C \frac{1}{|x|^{d}} \text { and }\left\|\partial_{k} T_{x}\right\|_{L_{t}^{p} \mapsto L_{t}^{p}} \leq C \frac{1}{|x|^{d+1}}
$$

and the continuity $L_{x}^{p}\left(L_{t}^{p}\right) \mapsto L_{x}^{p}\left(L_{t}^{p}\right)$ of $T$ can be extended to the continuity $L_{x}^{q}\left(L_{t}^{p}\right) \mapsto L_{x}^{q}\left(L_{t}^{p}\right)$.

Similar estimates hold for Krylov spaces:
Proposition 6. Let $1<p, q<+\infty$ and $0<\beta<\frac{2}{p}+\frac{d}{q}$. Let $\sigma(D)$ be a Fourier multiplier (in the space variable) such that $\sigma(\xi)=\sigma_{0}\left(\frac{\xi}{|\xi|}\right)$ where $\sigma_{0}$ is a smooth function on the sphere $\mathcal{S}^{d-1}$.
a) If $h \in E_{p, q, \beta}$, then, for $1 \leq i, j \leq d$,

$$
\left\|\int_{-\infty}^{t} e^{(t-s) \Delta} \sigma(D) \partial_{i} \partial_{j} h d s\right\|_{E_{p, q, \beta}} \leq C\|h\|_{E_{p, q, \beta}}
$$

a) If $h \in F_{p, q, \beta}$, then, for $1 \leq i, j \leq d$,

$$
\left\|\int_{-\infty}^{t} e^{(t-s) \Delta} \sigma(D) \partial_{i} \partial_{j} h d s\right\|_{F_{p, q, \beta}} \leq C\|h\|_{F_{p, q, \beta}}
$$

Proof. We consider only the case of $E_{p, q, \beta}$, as the proof for $F_{p, q, \beta}$ is similar. Let us estimate $T(h)$ on a cylinder $C_{r}(t, x)$ (where $T$ is the operator given by (6)). We have $T(h)=T\left(h_{1}\right)+T\left(h_{2}\right)$, where $h_{1}=\mathbb{1}_{C_{4 r}(t, x)} h$ and $h_{2}=h-h_{1}$. By Proposition 5, we know that

$$
\left\|h_{1}\right\|_{L_{t}^{p} L_{x}^{q}} \leq C\left\|h_{1}\right\|_{L_{t}^{p} L_{x}^{q}} \leq C^{\prime}\|h\|_{E_{p, q, \beta}} r^{\frac{2}{p}+\frac{d}{q}-\beta} .
$$

On the other hand, for $(s, z) \in C_{r}(t, x) \subset B_{2 r}(t, x)$, since $B_{4 r}(t, x) \subset$ $C_{4 r}(t, x)$,

$$
\begin{aligned}
\left|h_{2}(s, z)\right| & \leq C \iint_{\rho((\sigma, y),(t, x))>4 r} \frac{1}{(\sqrt{|\tau-s|}+|z-y|)^{d+2}}|h(\tau, y)| d \tau d y \\
& \leq C^{\prime} \iint_{\rho((\sigma, y),(t, x))>4 r} \frac{1}{(\sqrt{|\tau-t|}+|x-y|)^{d+2}}|h(\tau, y)| d \tau d y \\
& \leq C^{\prime \prime} \sum_{j=0}^{+\infty} \frac{1}{\left(4^{j} r\right)^{d+2}} \iint_{C_{4 j} j+1_{r}}|h(\tau, y)| d \tau d y \\
& \leq C^{\prime \prime \prime}\|h\|_{E_{p, q, \beta}} r^{-\beta}
\end{aligned}
$$

so that

$$
\left\|\mathbb{1}_{C_{r}(t, x)} h_{2}\right\|_{L_{t}^{p} L_{x}^{q}} \leq C\| \|_{E_{p, q, \beta}}{ }^{\frac{2}{p}+\frac{d}{q}-\beta} .
$$

We may now easily prove Theorems 3 and 4, Corollary 1 and Proposition 1. Again, we shall consider only the case of $E_{p, q, \beta}$, as the proofs for $F_{p, q, \beta}$ are similar.

## Proof of Theorem 3

Proof. The solution $u$ of equation $\partial_{t} u=\Delta u+f$ is given by $u=\int_{-\infty}^{t} e^{t-s) \Delta} f(s,) d$.$s .$ By proposition (6), we already know that

$$
\left\|D_{x}^{2} u\right\|_{E_{p / 3, q / 3, \beta+2}} \leq C\|f\|_{E_{p / 3, q / 3, \beta+2}} .
$$

On the other hand, from Lemma 3, we see that

$$
\left|D_{x} u(t, x)\right| \leq C \iint \frac{1}{(\sqrt{|t-s|}+|x-y|)^{d+1}}|f(s, y)| d s d y=C \mathcal{I}_{1}(|f|)(t, x)
$$

and

$$
|u(t, x)| \leq C \iint \frac{1}{(\sqrt{|t-s|}+|x-y|)^{d}}|f(s, y)| d s d y=C \mathcal{I}_{2}(|f|)(t, x)
$$

We then apply Proposition 4 to get

$$
\left\|D_{x} u\right\|_{E_{p / 2, q / 2, \beta+1}} \leq C\|f\|_{E_{p / 3, q / 3, \beta+2}}
$$

and

$$
\|u\|_{E_{p, q, \beta}} \leq C\|f\|_{E_{p / 3, q / 3, \beta+2}} .
$$

## Proof of Theorem 4

Proof. The solution $u$ of equation $\partial_{t} u=\Delta u+\sigma(D) \operatorname{div} \mathbb{F}$ is given by $u=$ $\int_{-\infty}^{t} e^{t-s) \Delta} \sigma(D) \operatorname{div} \mathbb{F}(s,) d$.$s . By proposition (6), we already know that$

$$
\mid D_{x} u\left\|_{E_{p / 2, q / 2, \beta+1}} \leq C_{0}\right\| \mathbb{F} \|_{E_{p / 2, q / 2, \beta+1}} .
$$

On the other hand, from Lemma 3, we see that

$$
|u(t, x)| \leq C \iint \frac{1}{(\sqrt{|t-s|}+|x-y|)^{d+1}}|\mathbb{F}(s, y)| d s d y=C \mathcal{I}_{1}(|\mathbb{F}|)(t, x)
$$

We then apply Proposition 4 to get

$$
\|u\|_{E_{p, q, \beta}} \leq C\|\mathbb{F}\|_{E_{p / 2, q / 2, \beta+1}} .
$$

## Proof of Corollary 1

Proof. We just write $\partial_{t} u-\Delta u=f$ with $f=\partial_{t} u-\Delta u$. By Theorem 3, we have
$\|u\|_{E_{p, q, \beta}}+\left\|D_{x} u\right\|_{E_{p / 2, q / 2, \beta+1}}+\left\|D_{x}^{2} u\right\|_{E_{p / 3, q / 3, \beta+2}} \leq C_{0}\left(\left\|\partial_{t} u\right\|_{E_{p / 3, q / 3, \beta+2}}+\|\Delta u\|_{E_{p / 3, q / 3, \beta+2}}\right)$

## Proof of Proposition 1

Proof. Let $X=\left\{u \in E_{p, q, \beta} / D_{x} u \in E_{p / 2, q / 2, \beta+1}, D_{x}^{2} u \in E_{p / 3, q / 3, \beta+2}\right\}$, normed with

$$
\|u\|_{X}=\|u\|_{E_{p, q, \beta}}+\left\|D_{x} u\right\|_{E_{p / 2, q / 2, \beta+1}}+\left\|D_{x}^{2} u\right\|_{E_{p / 3, q / 3, \beta+2}} .
$$

We are looking for a solution in $X$ of the equation

$$
u=T(f)+T(\vec{b} \cdot \vec{\nabla} u)+T(c u)
$$

, where $T(f)=\int_{-\infty}^{t} e^{(t-s) \Delta} f(s,) d$.$s . By Theorem 3, we have$

$$
\begin{gathered}
\|T(f)\|_{X} \leq C_{1}\|f\|_{E_{p / 3 /, q / 3, \beta+2},} \\
\|T(\vec{b} \cdot \vec{\nabla} u)\|_{X} \leq C_{2}\|\vec{b} \cdot \vec{\nabla} u\|_{E_{p / 3 / q / 3 /, \beta+2}} \leq C_{2}\|\vec{b}\|_{E_{p, q, 1}}\left\|D_{x} u\right\|_{E_{p / 2, q / 2, \beta+1}},
\end{gathered}
$$

and

$$
\|T(c u)\|_{X} \leq C_{3}\|c u\|_{E_{p / 3, q / 3, \beta+2}} \leq C_{3}\|c\|_{E_{p / 2, q / 2,2}}\|u\|_{p, q, \beta} .
$$

For $C_{2}\|\vec{b}\|_{E_{p, q, 1}}+C_{3}\|c\|_{E_{p / 2, q / 2,2}}<\frac{1}{2}$, the operator $S(u)=u-T(\vec{b} \cdot \vec{\nabla} u)-T(c u)$ is an isomorphism of $X$, with $\left\|S^{-1}\right\|_{X \mapsto X} \leq 2$. The solution $u$ is then given by $u=S^{-1}(T(f))$, with $\|u\|_{X} \leq 2 C_{1}\|f\|_{E_{p / 3, q / 3, \beta+2}}$.

## 6 The Navier-Stokes equations.

We prove here Theorem 1. The proof of Theorem 2 is similar. Again, we consider only the case of $E_{p, q, \beta}$.

## Proof of Theorem 1

Proof. The Navier-Stokes equations we study are

$$
\left\{\begin{array}{l}
\partial_{t} \vec{u}=\Delta \vec{u}-\vec{\nabla} p-\vec{u} \cdot \vec{\nabla} \vec{u}+\vec{f}+\operatorname{div} \mathbb{F}  \tag{7}\\
\operatorname{div} \vec{u}=0 \\
\vec{u}(0, .)=0
\end{array}\right.
$$

where $\vec{f} \in E_{p / 3, q / 3,3}$ with div $\vec{f}=0$ and $\mathbb{F} \in E_{p / 2, q / 2,2}$. We rewrite (7) as

\partial_{t} \vec{u}-\Delta \vec{u}=\vec{f}+\left(\operatorname{Id}-\frac{1}{\Delta} \vec{\nabla} \operatorname{div}\right) \operatorname{div}(\mathbb{F}-\vec{u} \otimes \vec{u}) .
$$

$\left(\operatorname{Id}-\frac{1}{\Delta} \vec{\nabla}\right.$ div $=\mathbb{P}$ is the Leray projection operator on solenoidal vector fields.)

Let $X=\left\{\vec{u} \in E_{p, q, 1} / D_{x} \vec{u} \in E_{p / 2, q / 2,2}\right\}$, normed with

$$
\|u\|_{X}=\|\vec{u}\|_{E_{p, q, 1}}+\left\|D_{x} \vec{u}\right\|_{E_{p / 2, q / 2,2}} .
$$

We are looking for a solution in $X$ of the equation

$$
\vec{u}=\vec{T}(\vec{f})+\vec{T}(\mathbb{P} \operatorname{div} \mathbb{F})-\vec{T}(\mathbb{P} \operatorname{div}(\vec{u} \otimes \vec{u}))
$$

where $\vec{T}(\vec{f})=\int_{0}^{t} e^{(t-s) \Delta} \vec{f}(s,) d s.\left(=\int_{-\infty}^{t} e^{(t-s) \Delta} \vec{f}(s,) d\right.$.$s if we extend \vec{f}$ to $(-\infty, 0)$ with $\vec{f}(t, x)=0$ for $t<0)$. By Theorem 3, we have

$$
\|\vec{T}(\vec{f})\|_{X} \leq C_{1}\|\vec{f}\|_{E_{p / 3, q / 3,3}}
$$

By Theorem 4, we have

$$
\|\vec{T}(\mathbb{P} \operatorname{div} \mathbb{F})\|_{X} \leq C_{2}\|\mathbb{F}\|_{E_{p / 2, q / 2,2}}
$$

and

$$
\|\vec{T}(\mathbb{P} \operatorname{div}(\vec{u} \otimes \vec{u}))\|_{X} \leq C_{3}\|\vec{u} \otimes \vec{u}\|_{E_{p / 2, q / 2,2}} \leq C_{3}\|\vec{u}\|_{p, q, 1}^{2} .
$$

For $C_{1}\|\vec{f}\|_{E_{p / 3, q / 3,3}}+C_{2}\|\mathbb{F}\|_{E_{p / 2, q / 2,2}}<\frac{1}{4 C_{3}}$, we find a solution $\vec{u} \in X$ with $\|\vec{u}\|_{X} \leq 2\left(C_{1}\|\vec{f}\|_{E_{p / 3, q / 3,3}}+C_{2}\|\mathbb{F}\|_{E_{p / 2, q / 2,2}}\right)$.

## Appendix 1: Parabolic Besov spaces

In this appendix, we describe some results on the heat equation on parabolic Besov spaces that may shed a new light on many of the inequalities we obtained throughout the paper, which are to be viewed more as regularity assertions than as results on existence of solutions.

For $\delta>0$, let us define the parabolic Besov space $\mathcal{B}_{[2], \infty, \infty}^{-\delta}$ as the space of tempered distributions on $\mathbb{R} \times \mathbb{R}^{d}$ such that

$$
\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}}=\sup _{\theta>0} \theta^{\delta / 2}\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u(t, x)\right\|_{L^{\infty}\left(\mathbb{R} \times \mathbb{R}^{d}\right)}<+\infty .
$$

(In particular, $E_{p, q, \beta} \subset \mathcal{B}_{[2], \infty, \infty}^{-\beta}$ and $F_{p, q, \beta} \subset \mathcal{B}_{[2], \infty, \infty}^{-\beta}$.) [The index [2] indicates the underlying time-space scaling, where $t$ behaves like $|x|^{2}$.]

It is easy to check that $\mathcal{B}_{[2], \infty, \infty}^{-\beta}$ coincides with the (realization of the) homogeneous Besov space defined through the parabolic Littlewood-Paley decomposition (for instance, see Triebel's book [Trie06]). Let $\phi(\tau, \xi)$ be a smooth function equal to 1 when $\sqrt{|\tau|}+|\xi|<1$ and to 0 when $\sqrt{|\tau|}+|\xi|>$ 2. Let $S_{j} f$ be defined as the inverse Fourier transform of $\phi\left(\frac{\tau}{4^{j}}, \frac{\xi}{2 j}\right) \hat{f}(\tau, \xi)$. Then $\mathcal{B}_{[2], \infty, \infty}^{-\beta}$ is the Banach space of tempered distributions $f$ such that $\sup _{j \in \mathbb{Z}} 2^{j \delta}\left\|S_{j} f\right\|_{\infty}<+\infty$.

We have the following Gagliardo-Nirenberg inequality

Proposition 7. Let $\delta>0,1<p, q<+\infty$ and $\beta \in\left(0, \frac{2}{p}+\frac{d}{q}\right)$.
a) If $u \in \mathcal{B}_{[2], \infty, \infty}^{-\delta}$ and $\partial_{t} u, \Delta u \in E_{p, q, \beta}$, then

$$
\left\|D_{x} u\right\|_{E_{2+\delta} \frac{2+\delta}{1+\delta}, \frac{1+\delta}{1+\delta} q, \frac{1+\delta}{2+\delta}} \leq C\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}}^{\frac{1}{2+\delta}}\left(\left\|\partial_{t} u\right\|_{E_{p, q, \beta}}+\|\Delta u\|_{E_{p, q, \beta}}\right)^{\frac{1+\delta}{2+\delta}} .
$$

b) If $u \in \mathcal{B}_{[2], \infty, \infty}^{-\delta}$ and $\partial_{t} u, \Delta u \in F_{p, q, \beta}$, then

$$
\left\|D_{x} u\right\|_{F_{\frac{2+\delta}{} p}^{1+\delta, \frac{2+\delta}{1+\delta} q, \frac{1+\delta}{2+\delta} \beta}} \leq C\|u\|_{\mathcal{B}_{[2], \infty, \infty}}^{\frac{1}{2+\delta}}\left(\left\|\partial_{t} u\right\|_{F_{p, q, \beta}}+\|\Delta u\|_{F_{p, q, \beta}}\right)^{\frac{1+\delta}{2+\delta}} .
$$

Our final resuts extend Corollary 1 and Theorem 3 to parabolic Besov spaces:

Theorem 5. Let $\delta>0$. Let $u=0$ at infinity. Then $u \in \mathcal{B}_{[2], \infty, \infty}^{-\delta}$ if and only if $\partial_{t} u \in \mathcal{B}_{[2], \infty, \infty}^{-\delta-2}$ and $\Delta u \in \mathcal{B}_{[2], \infty, \infty}^{-\delta-2}$ Moreover, the norms $\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}}^{\infty}$ and $\left\|\partial_{t} u\right\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}}+\|\Delta u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}}$ are equivalent.

Theorem 6. Let $\delta>2$. If $f \in \mathcal{B}_{[2], \infty, \infty}^{-\delta}$, then the heat equation

$$
\begin{equation*}
\partial_{t} u=\Delta u+f \tag{8}
\end{equation*}
$$

has a unique solution such that $u=0$ at infinity. Moreover, $u \in \mathcal{B}_{[2], \infty, \infty}^{-\delta+2}$ and

$$
\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta+2}} \leq C\|f\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}} .
$$

Those results are not very new, as they can be recovered from the voluminous literature on anisotropic Besov spaces We present them for sake of completeness.

## Proof of Proposition 7.

Proof. As $u=0$ at infinity, we may write

$$
u=\int_{0}^{\infty}\left(-\partial_{\theta}\right)\left(e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right) d \theta
$$

and

$$
D_{x} u=\int_{0}^{\infty}\left(-\partial_{\theta}\right) D_{x}\left(e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right) d \theta
$$

For $R>0$, we rewrite this as

$$
\begin{aligned}
D_{x} u & =-\int_{0}^{R}\left(2 \theta \partial_{t} e^{\theta^{2} \partial_{t}^{2}} \sqrt{\theta} D_{x} e^{-\theta^{2} \Delta^{2}}\right) \partial_{t} u \frac{d \theta}{\sqrt{\theta}} \\
& -\int_{R}^{\infty}\left(2 \theta^{2} \partial_{t}^{2} e^{\frac{3}{4} \theta^{2} \partial_{t}^{2}} \sqrt{\theta} D_{x} e^{-\frac{3}{4} \theta^{2} \Delta^{2}}\right)\left(e^{\frac{\theta^{2}}{4}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right) \frac{d \theta}{\theta^{3 / 2}} \\
& +\int_{0}^{R}\left(2 e^{\theta^{2} \partial_{t}^{2}} \theta^{3 / 2} D_{x} \Delta e^{-\theta^{2} \Delta^{2}}\right) \Delta u \frac{d \theta}{\sqrt{\theta}} \\
& +\int_{R}^{\infty}\left(2 e^{\frac{3}{4} \theta^{2} \partial_{t}^{2}} \theta^{5 / 2} D_{x} \Delta^{2} e^{-\frac{3}{4} \theta^{2} \Delta^{2}}\right)\left(e^{\frac{\theta^{2}}{4}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right) \frac{d \theta}{\theta^{3 / 2}} \\
& =I+I I+I I I+I V .
\end{aligned}
$$

Recall that $\mathcal{M}_{f}$ designs the parabolic Hardy-Littlewood maximal function. If $\psi \in \mathcal{S}\left(\mathbb{R} \times \mathbb{R}^{d}\right)$, we have, for every $\theta>0$,

$$
\left.\iint \frac{1}{\theta^{\frac{d+2}{2}}}\left|\psi\left(\frac{s}{\theta}, \frac{y}{\sqrt{\theta}}\right)\right| \right\rvert\, f(t-s, x-y) d s d y \leq C_{\psi} \mathcal{M}_{f}(t, x)
$$

and

$$
\iint \frac{1}{\theta^{\frac{d+2}{2}}} \left\lvert\, \psi\left(\frac{s}{\theta}, \frac{y}{\sqrt{\theta}}\right)\|f(t-s, x-y) d s d y \leq\| \psi\left\|_{1}\right\| f\right. \|_{\infty}
$$

Thus, we have

$$
|I| \leq C \sqrt{R} \mathcal{M}_{\partial_{t} u} \text { and }|I I I| \leq C \sqrt{R} \mathcal{M}_{\Delta u}
$$

and

$$
|I I|+|I V| \leq C R^{-\frac{1+\delta}{2}}\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}}
$$

Taking $\sqrt{R}=\left(\frac{\|u\|_{\mathcal{B}_{[2]}^{-\delta}, \infty, \infty}}{\mathcal{M}_{\partial_{t} u}(t, x)+\mathcal{M}_{\Delta u}(t, x)}\right)^{\frac{1}{2+\delta}}$, we get

$$
\left|D_{x} u(t, x)\right| \leq C\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}}^{\frac{1}{2+\delta}}\left(\mathcal{M}_{\partial_{t} u}(t, x)+\mathcal{M}_{\Delta u}(t, x)\right)^{\frac{1+\delta}{2+\delta}}
$$

and we conclude by Proposition 4 a).

## Proof of Theorem 5.

Proof. Writing

e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)}\left(\partial_{t} u\right)=\frac{1}{\theta}\left(\theta \partial_{t} e^{\frac{3}{4} \theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)}\right)\left(e^{\frac{1}{\theta^{2}}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right)
$$

and

$$
e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)}(\Delta u)=\frac{1}{\theta}\left(\theta \Delta e^{\frac{3}{4} \theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)}\right)\left(e^{\frac{1}{4} \theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right)
$$

we find that

\left\|\partial_{t} u\right\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}}+\|\Delta u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}} \leq C\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}, \infty} .
$$

As $u=0$ at infinity, we write

$$
u=\int_{0}^{\infty}\left(-\partial_{\eta}\right)\left(e^{\eta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right) d \eta=2 \int_{0}^{+\infty} \eta\left(\Delta^{2}-\partial_{t}^{2}\right) e^{\eta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u d \eta
$$

We get

$$
\begin{aligned}
e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u= & 2 \int_{0}^{+\infty}\left(\eta \Delta e^{\frac{\eta^{2}}{2}\left(\partial_{t}^{2}-\Delta^{2}\right)}\right)\left(e^{\left(\theta^{2}+\frac{\eta^{2}}{2}\right)\left(\partial_{t}^{2}-\Delta^{2}\right)} \Delta u\right) d \eta \\
& -2 \int_{0}^{+\infty}\left(\eta \partial_{t} e^{\frac{\eta^{2}}{2}\left(\partial_{t}^{2}-\Delta^{2}\right)}\right)\left(e^{\left(\theta^{2}+\frac{\eta^{2}}{2}\right)\left(\partial_{t}^{2}-\Delta^{2}\right)} \partial_{t} u\right) d \eta
\end{aligned}
$$

so that

$$
\begin{aligned}
\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right\|_{\infty} & \leq C \int_{0}^{+\infty}\left\|e^{\left(\theta^{2}+\frac{\eta^{2}}{2}\right)\left(\partial_{t}^{2}-\Delta^{2}\right)} \Delta u\right\|_{\infty}+\left\|e^{\left(\theta^{2}+\frac{\eta^{2}}{2}\right)\left(\partial_{t}^{2}-\Delta^{2}\right)} \partial_{t} u\right\|_{\infty} d \eta \\
& \leq C\left(\left\|\partial_{t} u\right\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}}+\|\Delta u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}}\right) \int_{0}^{+\infty}\left(\theta^{2}+\frac{\eta^{2}}{2}\right)^{-\frac{2+\delta}{4}} d \eta \\
& =C \theta^{-\delta / 2}\left(\left\|\partial_{t} u\right\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}}+\|\Delta u\|_{\left.\mathcal{B}_{-2], \infty, \infty}^{-\delta-2}\right)}\right) \int_{0}^{+\infty}\left(1+\frac{\eta^{2}}{2}\right)^{-\frac{2+\delta}{4}} d \eta
\end{aligned}
$$

and finally

$$
\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}} \leq C\left(\left\|\partial_{t} u\right\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}}+\|\Delta u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}}\right) .
$$

## Proof of Theorem 6.

Proof. We write

f=\int_{0}^{\infty}\left(-\partial_{\eta}\right)\left(e^{\eta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} f\right) d \eta=-2\left(\partial_{t}-\Delta\right) \int_{0}^{+\infty} \eta\left(\Delta+\partial_{t}\right) e^{\eta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} f d \eta
$$

Let

$$
u=-2 \int_{0}^{+\infty} \eta\left(\Delta+\partial_{t}\right) e^{\eta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} f d \eta .
$$

We have

$$
\begin{aligned}
\left\|e^{\theta^{2}\left(\partial_{t}^{2}-\Delta^{2}\right)} u\right\|_{\infty} \leq & 2 \int_{0}^{+\infty}\left\|\left(\eta \Delta e^{\frac{\eta^{2}}{2}\left(\partial_{t}^{2}-\Delta^{2}\right)}\right)\left(e^{\left(\theta^{2}+\frac{\eta^{2}}{2}\right)\left(\partial_{t}^{2}-\Delta^{2}\right)} f\right)\right\|_{\infty} d \eta \\
& +2 \int_{0}^{+\infty}\left\|\left(\eta \partial_{t} e^{\frac{\eta^{2}}{2}\left(\partial_{t}^{2}-\Delta^{2}\right)}\right)\left(e^{\left(\theta^{2}+\frac{\eta^{2}}{2}\right)\left(\partial_{t}^{2}-\Delta^{2}\right)} f\right)\right\|_{\infty} d \eta, \\
\leq & C \int_{0}^{+\infty}\left\|e^{\left(\theta^{2}+\frac{\eta^{2}}{2}\right)\left(\partial_{t}^{2}-\Delta^{2}\right)} f\right\|_{\infty} d \eta \\
\leq & C\|f\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-\infty}} \int_{0}^{+\infty}\left(\theta^{2}+\frac{\eta^{2}}{2}\right)^{-\frac{2+\delta}{4}} d \eta \\
= & C \theta^{-\delta / 2}\|f\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta, 2}} \int_{0}^{+\infty}\left(1+\frac{\eta^{2}}{2}\right)^{-\frac{2+\delta}{4}} d \eta
\end{aligned}
$$

and finally

$$
\|u\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta}} \leq C\|f\|_{\mathcal{B}_{[2], \infty, \infty}^{-\delta-2}} .
$$

## Appendix 2: A remark on the regularity of mild solutions

The reviewer asked the following questions about the regularity of the solution $u$ constructed in Theorem 1: can one expect the constructed solution to be in $L_{l o c}^{1}\left(\mathbb{R}, C^{0,1}\right)$ ? The answer is clearly negative, as the force is not regular enough to grant such a regularity. In this appendix, we give an example of a not so regular solution.

We start from a well-known fact: the map $\mathbb{F} \mapsto \int_{0}^{t} e^{(t-s) \Delta} \mathbb{P} \operatorname{div} \mathbb{F} d s$ maps $L^{\infty}\left((0,+\infty), L^{p_{0}, \infty}\left(\mathbb{R}^{3}\right)\right)$ to $L^{\infty}\left((0,+\infty), L^{p_{1}, \infty}\left(\mathbb{R}^{3}\right)\right)$ for $1<p_{0}<3$ and $\frac{1}{p_{1}}=$ $\frac{1}{p_{0}}-\frac{1}{3}$ (see for instance [Lema02]). Thus, if $\|\mathbb{F}\|_{L^{\infty} L^{3 / 2, \infty}}$ is small enough, the Navier-Stokes problem

$$
\partial_{t} \vec{u}=\Delta \vec{u}+\mathbb{P} \operatorname{div}(\mathbb{F}-\vec{u} \otimes \vec{u})
$$

will have a solution in $L^{\infty}\left((0,+\infty), L^{3, \infty}\left(\mathbb{R}^{3}\right)\right)$. Similarly, if $3 / 2<r<2$ and $\|\mathbb{F}\|_{L^{\infty} L^{3 / 2, \infty}}+\|\mathbb{F}\|_{L^{\infty} L^{r, \infty}}$ is small enough, the Navier-Stokes problem will have a solution $\vec{u}$ in $L^{\infty}\left((0,+\infty), L^{3, \infty}\left(\mathbb{R}^{3}\right)\right) \cap L^{\infty}\left((0,+\infty), L^{\frac{3 r}{3-r}, \infty}\left(\mathbb{R}^{3}\right)\right)$. Moreover, we have

$$
\vec{u}-\int_{0}^{t} e^{(t-s) \Delta} \mathbb{P} \operatorname{div} \mathbb{F} d s=-\int_{0}^{t} e^{(t-s) \Delta} \mathbb{P} \operatorname{div}(\vec{u} \otimes \vec{u}) d s
$$

and we find that $\vec{u}-\int_{0}^{t} e^{(t-s) \Delta} \mathbb{P} \operatorname{div} \mathbb{F} d s$ belongs to $L^{\infty}\left((0,+\infty), L^{\frac{r}{2-r}, \infty}\left(\mathbb{R}^{3}\right)\right)$ (with $\frac{r}{2-r}>\frac{3 r}{3-r}$ ).

We may remark that, if $\mathbb{F} \in L^{\infty} L^{3 / 2, \infty} \cap L^{\infty} L^{r, \infty}$ and $\mathbb{F}$ is supported in $[0,1] \times \mathbb{R}^{3}$, then $\mathbb{F} \in E_{p / 2, q / 2,2}$ for $p>2,3<q<2 r$ and $\frac{2}{p}+\frac{3}{q}>1$. Indeed, we have $\mathbb{F} \in L_{t}^{\infty} L^{q / 2} \cap L_{t}^{p / 2} L_{x}^{q / 2}$, so that

$$
\rho^{2-2 \frac{2}{p}-3 \frac{2}{q}}\left(\int_{|t-s|<\rho^{2}}\left(\int_{|x-y|<\rho}|\mathbb{F}(s, y)|^{q / 2} d y\right)^{\frac{p}{q}} d s\right)^{\frac{2}{p}} \leq C \rho^{2\left(1-\frac{3}{q}\right)}\|\mathbb{F}\|_{L^{\infty} L^{q / 2}}
$$

(which is bounded for $0<\rho \leq 1$ ) and

$$
\rho^{2-2 \frac{2}{p}-3 \frac{2}{q}}\left(\int_{|t-s|<\rho^{2}}\left(\int_{|x-y|<\rho}|\mathbb{F}(s, y)|^{q / 2} d y\right)^{\frac{p}{q}} d s\right)^{\frac{2}{p}} \leq C \rho^{2\left(1-\frac{2}{p}-\frac{3}{q}\right)}\|\mathbb{F}\|_{L^{p / 2} L^{q / 2}}
$$

(which is bounded for $1<\rho$ ).
We now give an example of a mild solution such that $\vec{u}$ is not (locally in time) $L^{1} C^{0,1}$. Let $\varphi \in \mathcal{D}\left(\mathbb{R}^{3}\right)$ be equal to 1 on a neighborhood of 0 and with support in $B(0,1)$, let $0<\epsilon<1 / 2$ and let $\vec{f}(t, x)=\lambda \mathbb{1}_{(0,1)}(t) \Delta \vec{\nabla} \wedge\left(|x|^{\epsilon} \varphi\right)$, with $\lambda>0$ small enough. We have $\operatorname{div} \vec{f}=0$. We write $\vec{f}$ in the divergence form

$$
\vec{f}=\sum_{j=1}^{3} \partial_{j}\left(\lambda \mathbb{1}_{(0,1)}(t) \partial_{j} \vec{\nabla} \wedge\left(|x|^{\epsilon} \varphi\right)\right)=\operatorname{div} \mathbb{F} .
$$

$\mathbb{F}$ is supported in $[0,1] \times \mathbb{R}^{3}$; moreover, $\mathbb{F} \in L^{\infty} L^{\rho, \infty}$ for every $\rho \in\left(1, \frac{3}{2-\epsilon}\right]$, hence $\mathbb{F} \in L^{\infty} L^{3 / 2, \infty} \cap L^{\infty} L^{\frac{3}{2-\epsilon}, \infty}$. If $\lambda$ is small enough, the Navier-Stokes problem have a solution $\vec{u}$ such that

$$
\vec{u} \in L^{\infty}\left((0,+\infty), L^{3, \infty}\left(\mathbb{R}^{3}\right)\right) \cap L^{\infty}\left((0,+\infty), L^{\frac{3}{1-\epsilon}, \infty}\left(\mathbb{R}^{3}\right)\right)
$$

and

$$
\vec{u}-\int_{0}^{t} e^{(t-s) \Delta} \mathbb{P} \operatorname{div} \mathbb{F} d s \in L^{\infty}\left((0,+\infty), L^{\frac{3}{1-2 \epsilon}, \infty}\left(\mathbb{R}^{3}\right)\right)
$$

For $0<t<1$, we have

$$
\int_{0}^{t} e^{(t-s) \Delta} \mathbb{P} \operatorname{div} \mathbb{F} d s=\lambda\left(\vec{\nabla} \wedge\left(|x|^{\epsilon} \varphi\right)-e^{t \Delta}\left(\vec{\nabla} \wedge\left(|x|^{\epsilon} \varphi\right)\right)\right)
$$

If locally $\vec{u}$ were $L^{1} C^{0,1}$, then $\mathbb{1}_{(1 / 2,1)}(t) \mathbb{1}_{B(0,1)}(x) \vec{u}$ would be $L^{1} L^{\frac{3}{1-2 \epsilon}, \infty}$. This would give that $\vec{\nabla} \wedge\left(|x|^{\epsilon} \varphi\right) \in L^{\frac{3}{1-2 \epsilon}, \infty}$. But $\vec{\nabla} \wedge\left(|x|^{\epsilon} \varphi\right) \in L^{r, \infty}$ if and only if $r \leq \frac{3}{1-\epsilon}$.
