# **The effect of the demographic history on the evolution of senescence: a potential new test of the mutation accumulation theory**

**Abstract** : The different evolutionary theories of senescence predict different directions for the correlation between the population size and the intensity of senescence. Using simulations, I highlighted how the effect of the population size on the intensity of senescence could be reinforced by the time since populations have been large or small. I devised a mutation-selection model in which the effect of the mutations was age-specific. Several small populations diverged from a same large population at different points in time. At the end of the simulation, the correlation between the time since the populations had been small and the rate of senescence was positive under the mutation accumulation theory and negative under the antagonistic pleiotropy theory. The phenomenon was strong enough to reverse the usually negative relationship between the intensity of senescence and the generation time. These mutually-exclusive predictions could help broaden the taxonomic support for the mutation accumulation theory of senescence, currently mostly supported in humans and lab invertebrates. I briefly mention a few potential applications in real-life systems.

# **Introduction**

2 In evolutionary theory, the deterioration of biological functions and fitness components when individuals grow older, i.e., senescence, stems in the decline in the strength of selection with age (Charlesworth, 2001; Hamilton, 1966; Rose, 1994). Under that general rule, two main types of senescence-inducing mutations have been considered by theorists. Senescence-inducing mutations can have a deleterious effect that increases with age (Medawar, 1952); or they can have a pleiotropic effect, characterized by a beneficial effect during early life followed by a deleterious effect later on (Kirkwood and Holliday, 1979; Williams, 1957). The first type of mutation corresponds to the mutation accumulation theory of senescence (MA), according to which deleterious alleles with effects restricted to late stages of life equilibrate at higher frequencies at mutation-selection balance than alleles that act earlier (Charlesworth, 2001; Medawar, 1952). The second type of mutation corresponds to the antagonistic pleiotropy theory (AP), according to which alleles with positive effects on performance early in life, but with negative effects due to trade-offs later on, are more likely to be established by selection than alleles with the opposite pattern (Charlesworth, 2001; Williams, 1957).

 Even if AP invokes the notion of life-history strategy and trade-offs (Lemaître et al., 2015; Maklakov and Chapman, 2019) whereas under MA, senescence may be interpreted as a genetic disease (Johnson et al., 2017; Rubinsztein and Carmichael, 2003; Yuan et al., 2024), the two theories yield strikingly similar predictions regarding the variation in the intensity of senescence along the slow/fast continuum of life histories (Jones et al., 2008; Péron et al., 2010), and have overall proven hard to separate empirically. Indeed, even with detailed data on age-specific genotype-phenotype associations, excluding AP can be challenging. For example, Hudson et al. (2023) reported an increase in the rate of actuarial senescence with the rate of inbreeding among European badgers *Meles meles*. This result verified a major prediction of MA (Charlesworth and Hughes, 1996; Escobar et al., 2008; Hughes et al., 2002) and was *a priori* unexpected under AP. However, if inbreeding also had a 26 positive effect on survival during the immature stages, or on fecundity, which the aforementioned 27 authors did not test, then the same dataset would support AP instead of MA (Hudson et al., 2023). In addition, the age-specificity in inbreeding depression was only revealed upon infection with bovine tuberculosis, and thereby the support for MA depended on the occurrence of that pathogen (Hudson et al., 2023).

 As a result of this sort of issue, unambiguous empirical support for MA is currently restricted, to my knowledge, to a handful of species including humans and lab invertebrates. More precisely, a few population genetics studies supported MA, but they often supported AP at the same time (Escobar et

- al., 2008; Hughes et al., 2002; Lohr et al., 2014; Mallet et al., 2011; Promislow et al., 1996); and a few
- genetic associations studies supported MA by identifying genes or alleles that verified the MA
- assumptions (Johnson et al., 2017; Rubinsztein and Carmichael, 2003; Yuan et al., 2024), but without
- ruling out AP for the rest of the genome.
- In this context, I looked into an alternative way to empirically support MA and potentially exclude AP in more species and *in natura*: the correlation between the population size and the intensity of senescence.

# **The predicted direction of the correlation between the population size and the rate of senescence changes depending on the theoretical framework**

- MA involves "nearly neutral" selection (Leroy et al., 2021) on mutations whose effect is expressed
- after most individuals have already died from other causes (Medawar, 1952). The evolution of
- senescence under MA is thus similar to genetic drift (Charlesworth, 2001; Escobar et al., 2008;
- Hughes et al., 2002; Lohr et al., 2014). Genetic drift is faster in small than large populations (Jordan
- and Snell, 2008; Leroy et al., 2021; Lynch et al., 1995). Therefore, under MA, senescence should be
- more intense in small than large populations (Lohr et al., 2014).
- By contrast, under AP, senescence-inducing mutations are under active positive selection because
- they confer early-life benefits (Williams, 1957). Active positive selection is less effective in small than
- large populations (Lanfear et al., 2014), due in part to the relatively larger effect of demographic
- stochasticity on the transmission of genes (Lande and Barrowclough, 1987). Therefore, under AP,
- senescence should be less, not more, intense in small than large populations.
- In summary, the correlation between the population size and the intensity of senescence should go
- into different directions depending on whether MA or AP is contributing the most to the evolution of
- senescence.

#### **Empirical tests can be confounded**

- To test the aforementioned predictions about the effect of the population size on the evolution of
- senescence, the intuitive approach would be to correlate the population size and the intensity of
- senescence across natural populations of different sizes (Lohr et al., 2014). However, such
- comparisons can be confounded by factors that covary with the population size. In Lohr et al. (2014),
- the latitude, the distance to the coast, and the geological substrate covaried with the effective size of
- *Daphnia* populations, and were acknowledged as potentially confounding factors in the correlation
- between the rate of senescence and the effective population size. In island/mainland comparisons,
- many factors covary with the size of populations being compared, such as the lack of predators in
- small islands (Terborgh, 2023). These confounding environmental factors can weaken the inference

 derived from correlations between the population size and the rate of senescence across populations from different locations.

#### **Replacing small/large comparisons with old/young comparisons**

Instead of comparing populations from different places, I propose to compare populations from the

same place, thus exposed to the same environmental factors, but with a different history in that

- place (Péron and Vollot, 2024). More precisely, I focused on small islands and the time since their
- inhabitants have colonized them. Following Fjeldså and Lovett (1997), I used the phrase "species
- age" or "population age" to refer to the time since a population colonized a given island system, and
- thereby the time since the population had been small.
- To illustrate this idea, I simulated the parallel evolution of senescence in four populations according
- to the scenario in Fig. 1. The scenario featured one large source population, and three small island
- populations that diverged from the source at different points in time. The four populations evolved
- throughout the simulation, at a pace that I expected to depend on the population size. At the end of
- the simulation, I expected that the rate of senescence would eventually depend on the time since the
- 81 divergence from the source, i.e., the "population age" as per the above definition. Furthermore, I
- expected that the direction of the correlation between the population age and the rate of
- senescence would depend on whether MA or AP was operating.
- In other words, contrary to previous studies into the relationship between the population size and the evolution of senescence (Charlesworth, 2001; Escobar et al., 2008; Lohr et al., 2014), I did not focus on the mutation-selection balance. Instead I focused on the non-stationary dynamics before the balance is reached, when the effect of the demographic history is still visible. In practice, I used a fully numerical approach. In an *in silica* experiment, I empirically monitored the evolution of allele frequencies and I compared the eventual rates of senescence rates across populations at the end of the simulation (Fig. 1).

# **Material and Methods**

### **Mutation-selection model focusing on non-stationary dynamics**

 The vital rate values were chosen to mimic those of small passerines like the *Zosterops* genus (Knape et al., 2011), which are iteroparous and in which the generations overlap (details of the parameter values in Table 1). In the model, the population size influenced the rate of apparition of new mutations and the transmission of alleles through demographic stochasticity and density- dependence. Precisely, I implemented a binomial survival process in which the annual survival 109 probability  $S(a_i, G_i, N_t)$  depended on the age  $a_i$ , the genotype  $G_i$  and the population size  $N_t$  of individual *i* and year *t*. Upon surviving and if not already in the breeding state, individuals could switch from non-breeding to breeding if one of *K* territories was left vacant by the death of a territory holder, at which point one of the non-breeders was drawn at random to replace it. Further demographic stochasticity occurred through a Poisson breeding process with fecundity rate  $F(a_i, G_i)$ . I ignored on the other hand the effect of the population size on the expression of recessive mutations, and instead assumed that all mutations were dominant. The effect of the population size

- 116 on the rate of homozygosity would likely reinforce the conclusion of this paper by allowing more
- 117 recessive mutations to be expressed in small than large populations (Hartl and Clark, 2007).

120 To simulate MA, each mutation was assigned an age *a* below which the mutation had no effect. The 121 individual genotype functions  $G_i^{(S)}(a)$  and  $G_i^{(F)}(a)$  gave the number of mutations whose deleterious 122 effect on survival and fecundity respectively started at age *a* for individual *i* (and subsequently lasted 123 until death). At each reproduction event, new mutations occurred with rate *U*. Upon the occurrence 124 of a new mutation, the age *a* was drawn at random and the genotype of the resulting offspring was 125 updated using  $G_i^{(\theta)}(a) = 1/2 \left( G_m^{(\theta)}(a) + G_f^{(\theta)}(a) \right) + 1$ , where  $\theta$ =S or *F*, and *m* and *f* denoted the 126 two parents of individual *i*. A proportion *ε* of the mutations had a beneficial effect (Goyal et al., 127 2012), in which case the update was  $G_i^{(\theta)}(a) = 1/2 \Big( G_m^{(\theta)}(a) + G_f^{(\theta)}(a) \Big) - 1$ . Since the mutations 128 were effectively neutral if the individual died before age *a*, the strength of selection decreased with 129 age as per classic models of the evolution of senescence. 130 To simulate AP, I added a beneficial effect of  $G_i^{(\theta)}(a)$  before age  $a$  (Eq. 1), that counteracted the 131 deleterious effect of  $G_i^{(\theta)}(a)$  after age *a*. In other words, senescence-inducing mutations now had a

132 positive effect during early life. That effect was modulated by parameter  $\alpha$ . When  $\alpha$  was near 0, MA

133 dominated, and when  $\alpha$  tended towards large values, AP dominated. The parameter  $\alpha$  itself was not 134 subject to selection, but instead represented an extrinsic constraint on the strength and shape of

135 selection on  $G_i^{(\theta)}(a)$ .

 At time *t*=0, the populations were made of identical individuals that had not accumulated any mutation yet and did not exhibit senescence. I immediately separated two populations: one in the mainland with *K* = 10,000 territories, starting with an initial population size of 10,000 individuals, and one in an island with *K* = 100 territories, starting with an initial population size of 10 individuals (Fig. 1). I then proceeded with the mutation-selection process for *T*=1000 years. At the end of that first period of 1000 years, I seeded a second island population by randomly selecting 10 individuals from the mainland source (Fig. 1), and then I let the mutation-selection process operate for another 1000 years. I did not allow for gene flow between populations other than during the seeding events. I also ignored competition between the island populations, e.g., the number of territories *K* did not depend on the number of island populations. Next, at the end of the second period of 1000 years, I seeded a third and last island population, and let the mutation-selection process operate for a final 1000 years (Fig. 1). At each new seeding event, the populations took less than 30 years to reach their asymptotic population size as determined by the number of available breeding territories *K* and the demographic 149 parameters in Eq. 1. This model thereby also illustrated the difference between the demographic balance (the equilibrium between births and deaths when the population is near carrying capacity) and the mutation-selection balance (the equilibrium between the rate of apparition of new deleterious mutations and the rate at which they are eliminated by natural selection), which indeed happened at different time scales as expected. The script to reproduce the simulation is provided in Appendix S1.

#### 155 **Statistical analysis**

 I compared the rates of senescence across the four populations at the end of the simulation. For this purpose, I used Eq. 1 to compute the age-specific survival and fecundity rates of all the individuals that were alive at the end of the simulation. Then I fitted the Gompertz's model of survival and a log- linear model of fecundity for each individual (results were qualitatively similar if using the Weibull's model instead of Gompertz's) (Ricklefs, 1998). From these models, I obtained the Gompertz' rates of actuarial senescence and the log-linear rates of reproductive senescence. I applied generalized linear models with the individual rates of senescence as dependent variable, and the population age and 163 parameter  $\alpha$  as predictor variables.

#### 164 **Ranking on the pace of life continuum**

- The generation time, the average age difference between mothers and daughters (Charlesworth,
- 1994) correlates negatively with the intensity of senescence across vertebrates (Jones et al., 2008;
- Péron et al., 2010, and references therein). Slow-breeding, long-lived species usually exhibit slow and
- delayed senescence, whereas fast-breeding, short-lived species exhibit fast and early senescence.
- For each individual at the end of my simulation, I computed its theoretical generation time as the
- average age difference between mothers and daughters in a population made entirely of the
- genotype of the focal individual. I then looked for any departure from the general rule that the
- generation time should correlate negatively with the rate of senescence.

# **Results and Discussion**

### **Actuarial senescence at the end of the simulation**

 As predicted, at the end of the simulation, the rate of actuarial (survival) senescence covaried with the population age (the time since the populations had been small) across populations. Furthermore, also as predicted, the direction of that correlation changed between the mutation accumulation theory (MA) and the antagonistic pleiotropy theory (AP) (Fig. 2). Under MA (blue curves in Fig. 2), old island populations (populations that had been small for a long time) exhibited more senescence than young island populations (populations that had been small for a short time), and than the source population. Under AP (red curves), old populations exhibited less senescence than young populations, and than the source population. Therefore, this simulation exercise confirmed that, everything else being equal, the demographic history predicted the contemporary rate of senescence 184 and could be used to test evolutionary theories of senescence. The difference between the populations was however small (Fig. 2; Table 2a), which I attributed to the design of the experiment, and especially the fact that, to save on computing time, the populations had only 3000 years to evolve.

200 These results build on previous studies in two major ways. First, previous authors documented the

201 role of the population size under MA (Lohr et al., 2014 and references therein), but did not fully

202 articulate its role under AP. Thus the fact that MA and AP lead to mutually exclusive predictions was

203 not explicit in previous works. Second, previous works assumed mutation-selection balance, and did

204 not address the potential effect of the demographic history, i.e., the time since populations have

- 205 been small and large. By relaxing the equilibrium assumption using a fully numerical approach, I
- opened a new avenue for empirical tests based on the variation in demographic history across
- sympatric populations, when at least one of the populations can be assumed to not have reached the
- mutation-selection balance yet (e.g., recent introduction).

#### **Ranking on the pace of life continuum**

210 The generation time at the end of the simulation increased with the parameter  $\alpha$  (Fig. 3). This result

- 211 stemmed in the model formulation; when  $\alpha$  was low, evolution could only yield a decrease in
- 212 lifespan, whereas when  $\alpha$  was high, the lifespan instead increased when mutations accumulated (Eq.
- 213 1) (Péron et al., 2019). However, irrespective of the parameter  $\alpha$ , the generation time always
- decreased across populations with the population age at the end of the simulation (the time since
- they had been small; Fig. 3b). This was because, under both MA and AP, the selection on early life
- 216 performance and fecundity was more efficient in large than small populations. Overall, the
- 217 parameter  $\alpha$  thus empirically mediated a negative correlation between the generation time and the
- rate of senescence (Fig. 3a). This result corroborated the general pattern observed in comparative
- analyses across vertebrate species (Jones et al., 2008; Péron et al., 2010).
- 220 By contrast, for a large  $\alpha$ , the correlation between the generation time and the rate of senescence across populations of different population ages became positive instead of negative (red curves in Fig. 3a). In other words, I generated a departure from the expectation that slow species should exhibit slow senescence. If observed in empirical data, such a departure would constitute evidence for AP. In addition, this result indicated that in order to use the demographic history as a basis for empirical tests of evolutionary theories of senescence, researchers will first need to account for the 226 variation in the generation time. Lastly, this result helped explain the residual variance in the aforementioned comparative analyses. Indeed, the relative contribution of MA and AP to the evolution of senescence could be species-specific, and different species also expectedly have experienced different demographic histories.

#### 237 **Asynchronous senescence**

 The rate of reproductive senescence did not verify the prediction (Fig. 4; Table 2b). This result could have been expected under the theory of asynchronous or asymmetric senescence (Moorad and Ravindran, 2022). Indeed, individuals needed to wait and survive several years before they reached breeding status, thereby maintaining a strong selection on late-life fecundity and in other words 242 preventing the strength of selection on fecundity to decline with age as fast as it did for survival. This aspect of the model mimicked the delayed access to reproduction in some island species, such as the Seychelles warbler *Acrocephalus sechellensis* (Komdeur, 1992). This mechanism explained why reproductive senescence was eventually weak (less than 10% decline in fecundity at age 10) and why 246 the rate of reproductive senescence did not verify the prediction. This aspect of the model was 247 unlikely to correspond to the general case, as indeed even the Seychelles warbler does not exhibit the level of asynchronous senescence that my model predicted (Brown et al., 2022).

## **Conclusion**

 I provided the first piece of *in silica* support for the use of the demographic history as a basis for empirical tests of the evolutionary theories of senescence, making it possible to decipher the mutation accumulation theory of senescence (MA) from the antagonistic pleiotropy theory (AP). 258 Precisely, I predicted that the correlation between the time since a population had been small and its rate of senescence should be positive under MA and negative under AP. In practice, such comparisons could be performed in island systems that have been colonized multiple times by the same lineage, yielding sets of populations of different "population age" as defined above. One could 262 also use the now widely available sequentially Markovian coalescent methods (Drummond et al., 2005) to estimate the demographic history from genomic data in sympatric species (Cornetti et al., 2015). One of the advantages of such a framework is that the alternative of comparing populations from different locations is more likely to be confounded by environmental factors (Péron and Vollot, 2024).

 Importantly, in order for the predictions of the present study to hold, at least one of the populations being compared must not have reached the mutation-selection balance yet. There are at least two real-life systems in which this condition could be verified. First, the island of São Tomé in the Gulf of Guinea harbors three species in the bird genus *Ploceus*, one of them a recent man-assisted introduction from the African mainland (Winkler et al., 2020). Second, the island of Lifou in New Caledonia was colonized three independent times by the bird genus *Zosterops*, the last time about

- 0.5Ma ago (Cornetti et al., 2015). A particular feature of Lifou compared to the typical small island system is the abundance of avian predators; on Lifou, "extrinsic mortality" factors could be similar to
- those on the mainland.
- Other tests of MA require either cross-breeding experiments with age-specific fitness monitoring
- (Escobar et al., 2008; Hughes et al., 2002), which would be challenging to implement in long-lived
- species outside of the lab; or the systematic identification of genes or alleles with an age-specific
- 279 effect that matches the assumption of MA and contradicts the assumptions of AP, which has only
- ever been unambiguously achieved in humans to my knowledge (Johnson et al., 2017; Rubinsztein
- and Carmichael, 2003; but see Yuan et al., 2024). Thus, the framework being proposed in the present
- study represents an opportunity to test the contribution of MA to the evolution of senescence in a
- wider variety of taxa across the tree of life than currently possible.
