# 6. The Contribution of the Palmyra Portrait Project to Research on the Epigraphy of Palmyra

**JEAN-BAPTISTE YON** (CNRS, Laboratoire Hisoma, Université de Lyon) is a historian and epigraphist, working on the Roman and early Byzantine Near East.

**ABSTRACT** This paper presents a review of recent publications on Palmyrene epigraphy. First, it gives examples of Greek and mostly Aramaic inscriptions from Palmyra discovered before 2010, or preserved in museums around the world, some never published before. Second, it underlines the contribution of the Palmyra Portrait Project to epigraphy. Initially dedicated to the study of portraits and funerary sculptures, the project has proved to be an important tool for our knowledge of the epigraphy of ancient Palmyra. For instance, it could lead in the coming years to breakthroughs in the research on the palaeography of the inscriptions of Palmyra.

## Introduction

Some years ago, in Warsaw at a conference organized in memory of Khaled As<sup>6</sup>ad, I presented the projects relating to the epigraphy of Palmyra at a moment when fieldwork had been impossible for five years — and unfortunately the possibility of fieldwork is still very remote.<sup>1</sup> At that time, the Palmyra Portrait Project was at its beginning. Now that several volumes related to the project (most prominently Harald Ingholt's diaries and his archives)<sup>2</sup> have been published and that the corpus itself will soon be published, this conference is a welcome opportunity to review what has been done on the epigraphy of Palmyra in the last years. I will thus summarize recent research on epigraphy,<sup>3</sup> drawing attention to some key facts and issues, before presenting with a few details the contribution of the publications made in relation to the Palmyra Portrait Project.

To follow up on the questions presented in the conference invitation, some topics and lines of enquiry which deserve future research must be underlined as well. One example that springs to mind could be the necessity to improve our knowledge of palaeography. New research on this area, possibly expanded to other regions of the Near East, could help to grasp the chronology of Palmyrene epigraphy in a better way and thus have an impact on prosopography or social history.

## Summary of Recent Research on Epigraphy

### New Texts from Palmyra and Excavations

In the last ten years or so, most new texts have been published in the context of the publication of earlier excavations, as is the case of the results of Syrian excavations around 2010,<sup>4</sup> the survey of the Palmyrene excavation by the Norwegian team,<sup>5</sup> or again of the survey for the *IGLS* XVII.2 (Palmyrene territory). During this last survey, very few new documents have been found. As an example, one can include a late inscription, close to a quarry on the outskirts of Palmyra. The reading is clear enough, with three crosses followed only by the personal name Nouvog (Fig. 6.1).<sup>6</sup>

The inscription is carved on a flat limestone surface, not far from which signs of the exploitation of the quarry in (Late?) Antiquity were still visible, with traces of extracting instruments. The region is situated east of the quarries investigated by Andreas Schmidt-Colinet, north-east of the city, and north of the modern road going to Sukhne.<sup>7</sup> The lesson to be learned from this is that the Palmyrene territory, too, has evidence of the Christian era, and although there were still potential sites there, they were already in grave risk before the war. A neighbouring quarry was being worked on by excavation equipment at the time the Nonnos inscription was found, and a rock at the entrance to the quarry had Palmyrene Aramaic and Safaitic texts engraved on it.

One of the major publications of the works done before 2010 was indeed the volume written by Michał Gawlikowski on the Polish excavations of the Temple of Allat, with an important chapter on epigraphy which includes all the inscriptions discovered in the area.<sup>8</sup>

Likewise, some new Greek and Aramaic inscriptions were discovered by the Italian team during their excavations in the western part of the city, between the Great Colonnade and the wadi.<sup>9</sup> They deserve mention, particularly for a new attestation of an *epimeletes* of the spring, in relation with the god Iaribôles/Yarḥibôl.<sup>10</sup> Two altars were discovered as well, but only one of them was sufficiently preserved to be read: it was dedicated to 'the one who is blessed forever' by a Palmyrene called Bôlmâ son of Yarḥaî.<sup>11</sup>

Due to the situation in Syria, the Direction générale des antiquités et des musées de Syrie (DGAMS) has often published on its website information on confiscated material, among which Palmyrene sculptures and inscriptions figured prominently. They were not publications in the proper sense, but they gave evidence of plundering made on the site after 2010 and of the thriving trade in Palmyrene sculptures.<sup>12</sup>

Trade in Palmyrene antiques has roots in the nineteenth and twentieth centuries, with pieces scattered in numerous collections around the world, from Syria to Europe and the Americas. Among them, quite a surprising number are still unpublished, as evidenced by recent publications. I shall give only a few examples.

#### The Question of Antiquities Trade

This ubiquity of Palmyrene culture raises the issue of looting and of unpublished objects smuggled out of Syria in recent years. This can be rather problematic in some cases, and this question has been dealt with by Jeremy Hutton when he published reliefs destroyed by ISIS in Mambij. His very clear position must be compared with that of papyrologists.<sup>13</sup>

Situations are very diverse: in the case of the small collection published by Gaby Abou Samra in 2015, the Palmyrene reliefs and inscriptions, some of them bilingual, were part of a private collection acquired before 2010, which was already in Lebanon in 2005, and was recently in the Nabu Art Museum in Ras Chekka el Herri near Tripoli.<sup>14</sup> No information is available on the provenance or the condition of discovery.

The situation is different for a stela with a standing young man now in the Adana Archaeology Museum in Turkey.<sup>15</sup> Thanks to the Ingholt Archive, it is possible to show that the sculpture was already in Adana Archaeology Museum at an early date, probably in the 1970s (if not earlier), as evidenced by the reference on Ingholt's sheet to the book of Stark published in 1971.<sup>16</sup> Likewise, the collection of the Kunsthistorisches Museum in Vienna has already known reliefs, as well as pieces published for the first time in 2010 by G. Plattner, which came to the museum in 1895. They mostly escaped notice, except from Ingholt.<sup>17</sup> Even Ingholt did not know about three busts in the Picardie Museum despite their arrival in the collection in 1927,<sup>18</sup> nor about a bust in the Vatican Museums, where it was already in 1937.<sup>19</sup> In the same manner, a female bust in the Pushkin State Museum in Moscow entered the collection in 1929; it was not noticed until 1990, when Klaus Parlasca published a photograph, but the inscription itself was only put in print in 2018.<sup>20</sup>

The description is sometimes less precise, as in the case of a bust with an inscription acquired in 2011 from a German auction house, which acquired it itself from

But often a history of provenance is given, as in the case of a bust donated to the museum in Bilbao by a collector who had bought it in 1996 from an earlier collection acquired in 1972 at an auction in New York with references to an earlier collection again, in Minneapolis.<sup>23</sup> There is no reason to doubt this, but it is nevertheless interesting to note that as often the earliest secure provenance is around 1970, that is prior to 24 April 1972, the date of entry into force of the 1970 UNESCO Convention on the Means of Prohibiting and Preventing the Illicit Import, Export, and Transfer of Ownership of Cultural Property.<sup>24</sup> In any case, thanks to the Palmyra Portrait project database, it is possible to confirm this background as the bust was already in Minneapolis before 1928, the date of Ingholt's book.<sup>25</sup>

In the case of a double bust from Kansas City in the permanent collections of the Nelson-Atkins Museum of Art,<sup>26</sup> the date of acquisition is later than 1972. Nevertheless, it seems the piece had already been removed from Syria and purchased in the United States around 1965.<sup>27</sup>

Due to greater attention to this kind of issue, most of the recently published Palmyrene inscriptions are unproblematic, with often well-known history. The two busts published by Fred C. Albertson have been in American collections for a little less than a century.<sup>28</sup>

It is the same for the three busts published by Eleonora Cussini and others in 2018. Accession numbers with 1894 and 1902 refer presumably to the date when the reliefs were bought by the Harvard Art Museums.<sup>29</sup> Related to the American collections are two stelae with representations of standing women in the archaeological study collection of the American Academy in Rome.<sup>30</sup>

In addition to the artefacts originating from Palmyra and present in various museums, an important source on the epigraphy of the city is constituted by the documents kept in the archives. The first that comes to mind is the extensive archive of Ingholt, but other collections are important too, like the large collection of squeezes held by the IGLS programme in Lyon. It includes among other things a squeeze of a late antique Greek funerary inscription found in 1961 west of the Palmyra municipality, near the post office (north-west of the archaeological museum). It was not in the Palmyra Museum's storerooms between 1990 and 2000, when the IGLS volume was being elaborated (Fig. 6.2).<sup>31</sup>

Other unpublished inscriptions can be found in different collections of archives, in the French Institute at Beirut (archive of Cantineau) and Damascus (photographic archive), or in the Académie des inscriptions et belles-lettres in Paris (Cabinet du corpus).

#### New Studies of Previously Known Documents

Since 2010, if publications of new inscriptions have been rare, studies of previously published texts have been more numerous. First mention should be made of the major new book by Aleksandra Kubiak-Schneider based mostly on epigraphic material. *Dédicaces sans théonymes* gives a very interesting corpus of religious inscriptions with a com-

plete commentary.<sup>32</sup> Another small corpus is the paper of Constantin Klein on the inscriptions of the AUB.<sup>33</sup> It ranks well with other, more scattered publications of small collections in different museums. The goal of the major project headed by Jeremy Hutton, the Wisconsin Palmyrene Aramaic Inscription Project (WPAIP), is to recollate the corpus of Palmyrene Aramaic inscriptions, providing detailed photographic records and new editions, in addition to the publication of new

inscriptions. This collective work has had impressive results, with various collaborations on inscriptions in the North American museums, but also in Durham,<sup>34</sup> or even inscriptions from Palmyrenes outside of Palmyra (i.e. Romania),<sup>35</sup> and has been materialized by a flow of publications.

Other projects have dealt with Palmyrene epigraphy; one of the most useful is undoubtedly the translation from Russian of Shifman's edition of the Tariff thanks to the work of John Healey.<sup>36</sup> The recent book on the famous painted 'Tombeau des trois frères' presents a new edition of already published inscriptions, and a mention of barely readable texts on the mythological paintings.<sup>37</sup> Last, but not least, the textbook of Eleonora Cussini, Tadmorena, is a welcome addition.<sup>38</sup> This very commendable contribution offers an anthology of thirty representative inscriptions, of all types, with translation, and a synthesis on the epigraphy of the city in its various aspects.

As is clear now, the new material from Palmyra has remained rare, and a great deal of the new discoveries and of the studies of material previously known has focused on funerary sculpture, in public or private collections, because the busts have been easy to export since the nineteenth century, in the most surprising locations sometimes.<sup>39</sup>

## The Contribution of the Palmyra Portrait Project (PPP)

The Palmyra Portrait Project has been part of this trend, but also, in more than one way, a driving force for this renewed interest for funerary sculpture and for Palmyra. I can only present here an assessment of the epigraphic results, now available in the two volumes of the edition of Ingholt's notebooks and in the four volumes of Ingholt's archive.

#### The Diaries

Since the *estampages* (squeezes) and photographs he mentioned in the diaries had not been located at the time of publication,<sup>40</sup> we are often at a loss to understand the texts. It may be useful here to remember that the 2021 edition is based almost only on hand copies of inconsistent quality. Mistakes may simply be due to errors made by Ingholt, who was often working under difficult conditions in underground tombs. The recent (re)discovery of some of the squeezes in the 'Cabinet du *Corpus inscriptionum semiticarum*' at the French Academy 'des inscriptions et belles-lettres' will soon

offer ample opportunity to improve the reading and the interpretation of these inscriptions.<sup>41</sup>

The documentation made by Ingholt was in a preliminary state. He surely intended to publish all the inscriptions, but due to insufficient documentation or a lack of time some of the texts were simply left aside. The countless additions in Ingholt's hand, particularly the references to Stark (a book which was published in 1971), show that he kept on working on the diaries until late in his career — as he did on his archive too.

The diaries were notes taken by the author for his own use; for some inscriptions Ingholt had up to three copies spread across the different diaries, sometime very sketchy and tentative. This might explain why sometimes it has been difficult to recognize the text of an already published inscription.<sup>42</sup> In the edition of the diaries published last year, these different readings helped to reconstruct the original inscriptions which were not preserved. All in all, there is quite a big number of new texts. Despite the lack of pictures and other illustrations, our documentation can be supplemented from other sources, first and foremost from the archive of Ingholt himself. A photograph of graffiti in the Tomb of Dionysos matches the copy in the diaries: the three graffiti are related to the family of one Zebîdâ son of Mattanaî. The note 'ph.' does indeed refer to an actual document.43

It happens that some of the photographs in the archive of Ifpo relate to the same excavations, as I have had the surprise to discover recently while perusing the files of thousands of digitalized photographs from this institution. Whether they are simply copies of Ingholt's photographs or were made by members of the department of antiquities in the same period is not documented. For instance, a photograph of two graffiti from the archive of the Institut français du Proche-Orient must have been taken in the same Tomb of Dionysos, as is clear thanks to the diaries (Fig. 6.3).

The two graffiti, one Greek and one Aramaic, have been copied by Ingholt and are found in Diary 1 page 101 and 5 pages 17–18 (Fig. 6.4).

The Aramaic text is a declaration of ownership for the niche next to it, for an individual called Bassâ son of Zebîdâ Mattanaî.<sup>44</sup> He is a son of the same Zebîdâ son of Mattanaî, who appears in the graffiti cited above. The second graffito which appears on the photograph is an apparently later Greek inscription, difficult to read, for which we had only two different and contradictory copies by Ingholt. He gives in both cases a proposal of Franz Cumont for the first line, which could stand for Θεὸς βοήθει 'God help'. I must admit that despite this new discovery the meaning is not clear at the moment.<sup>45</sup>

Sometimes, the inscriptions have indeed been published, but never with a photograph. Such is the case for a bust from the 'Dépôt des antiquités': only the inscrip-

tion was published by Jean Cantineau in 1936, with a drawing.<sup>46</sup> The photograph in the archive of Ingholt (Fig. 6.5) is the first illustration of the bust and the first photograph of the text.<sup>47</sup>

In other cases, the bust had been published, but not the inscriptions: an object now in the National Museum of Damascus, in the reconstruction of the Tomb of Yarhai, originally had an inscription which has been broken as shown on the plate of Tanabe's book. An earlier photograph is preserved in the Ifpo archive (Fig. 6.6), which once again can complement Ingholt's archive. Actually, another and different print of the same photograph (where the inscription is less clear) is found in Ingholt's archive.<sup>48</sup> Jean-Baptiste Yon

This male bust depicts a bearded man holding in his left hand an instrument that H. Ingholt and F. C. Albertson recognized as the grip of a sword on other busts and a whip with braided hair in his right hand. Zebidâ, however, did not dress in a 'military' uniform; instead, he wears a cloak that covers a tunic. The left hand simply presses one side of the coat against the body. The bust is included here out of palaeographic curiosity. Resh are dotted as is usual in texts after the second half of the second century, but in l. 2, the D appears to be dotted below, which seems extremely rare, and prefigures the use of Syriac.

The reverse happens as well, in that some of the documents published with the diaries have no counterparts in Ingholt's text.<sup>49</sup> While the diaries were mostly related to excavations in the necropolis, some religious inscriptions coming from other places were shown to Ingholt as well, mostly altars to the so-called 'anonymous god'. Some have been published since then, some were copied so badly that they could not be recognized.<sup>50</sup>

Obviously, funerary inscriptions are the majority in the diaries, mostly busts as in the examples seen above; longer texts more often concern cessions of tombs than foundations. These cession inscriptions form quite a large number of texts, which are sometimes challenging and difficult to interpret.

#### The Archives

The archive gathered by Ingholt during his life for his work on Palmyrene portraiture provides rich information on epigraphy.<sup>51</sup> Many of the portraits were inscribed and Ingholt had a good philological background. His interest in epigraphy is mirrored in the transcription of the inscriptions found on Ingholt's documentation; they are very systematic and frequently include lexicographic and philological comments. The various colours and media (pencil, ink, etc.) employed on the sheets make it clear that these comments reflect multiple layers. In a

few rare cases, a direct facsimile of Palmyrene Aramaic was drawn (Fig. 6.4, top left corner; Fig. 6.7).

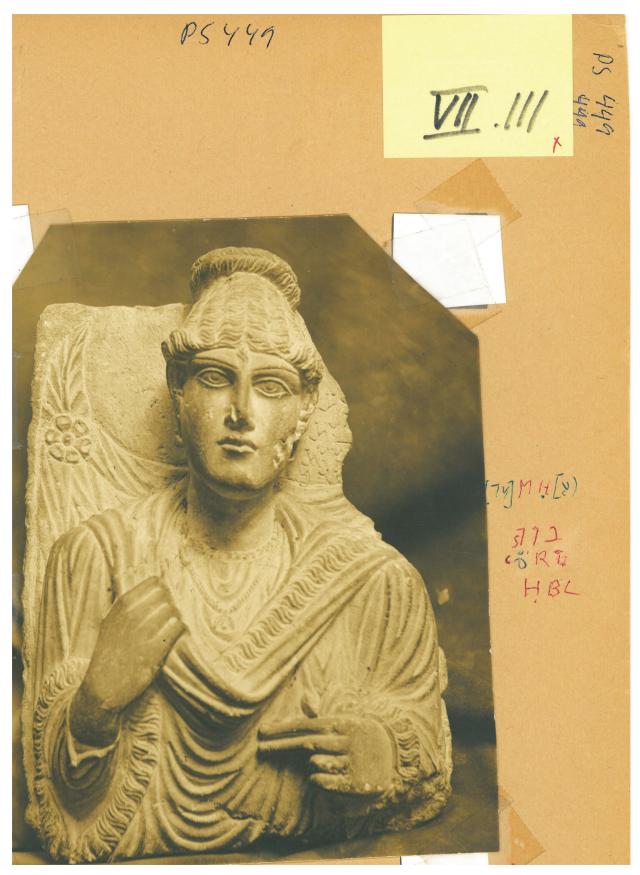


Figure 6.8. Archive sheet for PS 449 (*PAT* no. 0960), with copy of the inscription by Ingholt (© Palmyra Portrait Project, Ingholt Archive at Ny Carlsberg Glyptotek, PS 449).

Hebrew script was frequently utilized in transcriptions of Palmyrene Aramaic, as was customary among Semitists in the 1920s and 1930s. But, after the Second World War, Roman script began to replace Hebrew more and more, often when writing down other Semitic languages. Ingholt embraced this change, albeit he occasionally combined the two transcribing styles. For instance, the first line on the page for PS 449 reads [TY]MḤ[X] whereas in the second line (ברת) is followed by DRT | HBL (Fig. 6.8).

The sheets are informal notes written for personal use. Taking this into account, and despite these limitations, the Ingholt Archive has a lot to offer from the perspective of epigraphy and can provide both new and previously studied material. Here, we can only give a few examples.

Ingholt had only released a Danish translation of PS 377 in his 1928 book. Stark then provided a partial text (basically guesswork) based on the translation, which was subsequently duplicated in PAT no. 1778 (but without line division).<sup>52</sup> The edition included in the archive book might be considered the first one. Likewise, PS 451 had never been published with an illustration. The last publication in the IGLS volume of this relief from the Istanbul Archaeological Museums presented a dubious reading. Thanks to a photograph in Ingholt's archive, it is possible to be certain of the personal name, which remains unexplained, although it should be compared with Baddaç or Baddyloç at Dura-Europos.53 The photograph for PS 1026 (PAT no. 1327) is the first published for this relief in the 'Dépôt des antiquités de Palmyre' in the 1930s, as is the photograph for PS 841 (PAT no. 1279), with a completed reading by Ingholt.<sup>54</sup>

In his extensive survey of documentation, Ingholt had identified new sculptures, almost unknown previously. PS 757 and 817 seem to have been put on sale by the art dealer Asfar and Sarkis in Damascus (in the 1930s?). They have not reappeared in the antique trade since then.<sup>55</sup> PS 278 and 460, now in the Detroit Institute of Arts Museum, had only been published with photographs in a local art magazine with short mentions in Ingholt's *Palmyrener Skulptur*.<sup>56</sup> As exemplified by the two reliefs from Detroit, Ingholt's work on the text was not always successful, due to the poor condition of some reliefs. It explains, too, why some of the readings must be corrected,<sup>57</sup> as can be done by working on the

material itself. Autopsy of the stones by J. Hutton in the Fitzwilliam Museum in Cambridge has permitted the improvement of some readings.<sup>58</sup>

Another aspect underlined in the notes of Harald Ingholt was the question of family relations enlightened by the inscriptions. Beyond the prosopographical interest for social history, Ingholt was right to point out the interest of such relations for art history. For instance, on the sheet for PS 518 (*PAT* no. 0485), he commented 'Grandfather floruit 95', thus giving an approximate date for the portrait. He could then compare this date to the one he had obtained through his typological analysis. He used the typology of the Palmyrene script as well, and its evolution, to specify dates, in addition to stylistic analysis.

As a last point on the contribution of the archive, it must be underlined that the documentation gives precious insights into private collections of the time, especially at Beirut and Damascus (people such as Ziade or Asfar and Sarkis). On the sheet, we often have the name of the dealer in antiquities, whereas in the published version in *Berytus*, Ingholt has only 'in two private collections in Beirut', without proper names.<sup>59</sup> Ingholt's expertise, like Henri Seyrig's, as was his presence in Beirut in the 1930s, certainly made him an asset for local art traders, and he could, in turn, use it for his own research.

#### The Corpus

All the reliefs with portraits are now compiled in the database and will be part of the corpus of funerary portraits which is now in preparation. Others can talk much more accurately on the form it will take, with a multi-

volume edition planned for the next years. The portraits with inscriptions, whatever their origin, will be included, and unpublished texts are numerous. However, it must be added that the database, which also serves as an archive, will not be published extensively, as in the case of unprovenanced material, without the consent of the rightful owners.

## What's Next? As a Conclusion

This rapid overview of the different projects on the epigraphy of Palmyra has left aside some new and ongoing projects, such as the work in progress on the tesserae. This project initiated by Rubina Raja in 2019 intends to collect tesserae, from private and public collections around the world, focusing on material not included in the *RTP*. This last volume published in 1955 needs revision. Even though the focus of the new project is rather on new tesserae, *RTP* is obviously the starting point. Other members of the team are more involved in this project, but I would like here only to draw attention once again to the archive of the Institut français du Proche-Orient where the original photographs used for the publication of 1955 are available.

As I have tried to show when dealing with the relations between the tesserae and prosopography,<sup>60</sup> one major shortcoming is the way to assign a date to these small objects. Among other methods, palaeography is certainly to be considered. The publication of the corpus with its lavish illustration, like the work on the tesserae could allow for renewed research on the evolution of the Palmyrene script. Every kind of inscriptions must be considered, and especially graffiti, which often use a very specific script, or the tesserae, which have some simplified letter shapes.

The PPP has opened new avenues of research on epigraphy, which can be fruitful for the years to come. In a way, its completion is only a beginning — for epigraphy, but for many other topics too.

Ingholt allows a correction of the reading: QWQH, which is better attested. PS 1316 as presented in Bobou and others 2022, 1358, must be corrected. Read 'QM' BT | BWLYD' 'G' 'HH | HBL (Aqmê daughter of Bôlîada'. 'Oggâ, her brother, alas!) with l. 3 'HH instead of 'T<T>H (his wife). Likewise, the reading of l. 1 of the Greek version of PS 254 must be corrected (Naσpaλ- with final  $\Lambda$ , as in *IGLS* XVII.1, 522; the letter is visible in the photograph published in *IGLS*).
