Orthotropi c organization of a cellulos e nanocrysta l suspension realized vi a th e combined action of fronta l ultrafiltratio n an d ultrasound as revealed by *in situ* SAXS

ABSTRACT

Hypothesis: Rodlike cellulose nanocrystals (CNCs) exhibit significant potential as building blocks for creating uniform, sustainable materials. However, a critical hurdle lies in the need to enhance existing or devise novel processin g that pr ovide s improved co ntrol over th e alig nment an d arrang ement of CNCs across a wide sp atial range. Specifically, the challenge is to achieve orthotropic organization in a single-step processing, which entails creatin g no n -unifor m CN C or ientation s to ge nerat e sp atial vari ation s in anisotropy .

Experiments: A novel processing method combining frontal ultrafiltration (FU) and ultrasound (US) has been developed. A dedicated channel-cell was designed to simultaneously generate (1) a vertical acoustic force thanks to a vibrating blade at the top and (2) a transmembrane pressure force at the bottom. Time-resolved *in* situ small-angle X-ray scattering permitted to probe the dynamical structural organization/orientation of CNCs du rin g th e pr ocessing.

Findings: For the first time, a typical three-layer orthotropic structure that resembles the articular cartilage organization was achieved in one step during the FU/US process: a first layer composed of CNCs having their director aligned parallel to the horizontal membrane surface, a second intermediate isotropic layer, and a third layer of CNCs with their director vertically oriented along the direction of US wave propagation direction.

rice, Samuel Panish, and Correlation and Ce llulose nanocrystals (CNCs) ar e biosourced nanorods exhibi tin g a larg e variet y of inte res tin g intrinsi c properties such as tu nable aspect rati o an d su rface chemistry, exce ptional mechan ica l properties , th e abilit y to self-organize into li qui d crystallin e phases , no n -toxicity , in addition to an abundant an d rene wable or igi n [1 –5] . Thes e pa rticles can also be assembled into various types of controlled architectures usin g di ffe ren t processe s (e xtr usion , coating, deposition , electr ospinning , spin coating, bioprinting, etc.), yielding nanostructured cellulosic compo sites exhibi tin g a wide variet y of functional properties [1 –3, 6 –11] .

For example, materials with specific optical (iridescence), mechanical (stiffness , anti -crac k prop agation) or ba rrier (oxyge n or water) proper ties ca n be designed [\[12\]](#page-10-1) . They coul d then impart a high -adde d valu e to material s in nume rou s appl ication s such as micr oelectronic s fo r pres - sure-sensitive screens [\[13\]](#page-10-2), photonic films [\[14\]](#page-10-3), in packaging for bio-and agroindustries [\[15\]](#page-10-4), or in tissue engineering as stratified multilayered cartilage belonging to three-dimensional porous constructs $[16-18]$.

Although CNCs have a high pote ntial as el eme ntary bricks in biosourced co mpo sites , achievin g optima l pe rfo rmanc e of thei r func tional properties is stil l di fficult . On e cr ucial challeng e is to co ntrol th e

or ientation an d organization of CNCs over a broa d sp atial scale. To achiev e this goal , it is ne cessary to co ntrol , on th e on e hand , th e inte rac tion s betwee n CNCs an d thos e betwee n CNCs an d thei r enviro nment (e.g., aqueou s or polymeri c medium) and, on th e othe r hand , th e exte r na l forces induce d by th e pr ocessing. Th e co ntrol of inte rna l inte raction forces in aqueou s CN C su spe nsion s ha s been exte nsively studie d in th e past , both from th e points of view of ioni c co ntrol an d thei r su rface chemistry (adsorption or grafting) [19–[21](#page-11-1)]. The effect of external solicitations on the structural organization of CNCs has also extensively been studied in the literature: for example, under shear flow [22–[35](#page-11-2)], mag-netic fields [36–[40](#page-11-3)], electric fields [\[41\]](#page-11-4), surface tension in drying processes [42–[45](#page-11-5)], and solvation effect in solvent casting [\[46\]](#page-11-6). Recently, the ability of the ultrafiltration processes to induce well-defined layered structures of anisometric colloidal particles aligned horizontall y alon g th e velo cit y dire ction from nanomete r to microm ete r length scales ha s been demo nstrate d [4 7 –[54](#page-11-7)] . In addition , usin g ultr asoun d (US) waves, th e co ntrol of th e alig nment of an isome tri c CNCs , with their director parallel to the direction of propagation of the ultrasonic wave, was revealed at an unprecedented nanometer scale [\[55\]](#page-11-8). However , to th e best of ou r know ledge , no stud y ha s been reported on frontal ultrafiltration coupled with ultrasound to induce changes in the CN C or ientation at micr o to nanomete r length scales .

Example and the system and the system in anomalous controlled the system and the system and the system of the system and the system and the system of the system and the system and the system and the system and the system In this work, we have used *in situ* time-resolved small-angle X-ray scatte rin g (SAXS) to stud y th e co mbine d effect s of fronta l ultr afi ltr ation (FU) an d ultr asoun d (US) on th e dyna m ica l stru ctura l organization an d or ientation of CNCs in an aqueou s medium , to develo p orthotropi c mu l tilayered cellulosic structures with alternate perpendicular and parallel or ientation s as well as isotropi c organization in each su cce ssive orga nized layer, reminiscent of the organization in the Strombus Gigas conch $[56,57]$ $[56,57]$ and of articular cartilage $[17,18,58]$. In artificial or biolo g ica l materials, such an orthotropi c organization improves th e stiffness and anti-crack propagation properties and confers high traction an d co mpression resi stanc e [59] . Thes e properties ca n be reache d by fu lfillin g tw o co nditions: i) co mbi nin g rigi d an d hard object s like nanocrystals with more flexible polymers, and ii) achieving a hierarchica l stru ctura l organization over a broa d rang e of length scales with an optimize d di str i b ution of crystallin e pa rticles in th e organi c matrix [60, [61](#page-12-1)] . Fo r example, fo r shells su bmi tte d to a mechan ica l load , cracks do not propagate catastrophically through their crossed lamellar structure, increa sin g th e work of fracture an d henc e th e toug hness of th e mate ria l [\[57\]](#page-12-2). Another example is the complex hierarchical structure of articular ca rtilage ti ssu e that is co mpose d of thre e la yer s co nti n uousl y stru cture d from the articulating surface to the subchondral bone and extending over a total thickness of 2 to 4 mm. The first superficial region comprises a densely packed network of thin collagen fibers aligned parallel to the articular surface and extending from 10 to 20 % of the whole cartilage thic kness . In th e se con d mi ddl e transitional region , thicke r co lla ge n fibers ar e organize d obliquely, gi vin g rise to a ra ndo m isotropi c or ganization and corresponding to 40–60 % of the whole cartilage thickness . Th e thir d deep zone , co mpose d of th e larges t co llage n fibers pe r pendicular to the subchondral bone, takes up to 30 % of the entire cartilage thic kness . Thes e di ffe ren t la yer s have di stinc t mechan ica l proper ties imparted by thei r inte rna l organization . Namely , th e supe rficial zone ha s an optimize d capabi lit y to di ssipate shea r forces , th e mi ddl e transitional zone is th e firs t line of resi stanc e to co mpressive forces , an d th e deep zone ha s a high co mpression strength an d inte rfacial resi s tance against shear forces [17,18,58].

To mimic this natural structural architecture and potentially reach co mparabl e mechan ica l properties , a de d icate d channe l -type cell co m - bining FU and US was developed ([Fig.](#page-3-0) 1). This cell was designed to simultaneously generate (i) a US pressure wave that induced a vertical acoustic radi ation force, thanks to a vibratin g ultr asoni c blad e inserted at th e to p of th e channe l an d (ii) a tran sme mbran e pressure forc e through a membrane designed for FU and located at the bottom of the channel. Impo rtantly , to fo llo w th e stru ctura l organization within th e cell upon th e appl ication of FU an d US usin g smal l -angl e X -ra y scatte r ing, it wa s impl emented at th e European Sy nchrotron Radi ation Faci lit y on th e ID02 TRUSAX S beamline [\[62\]](#page-12-3) . Th e stru ctura l organization of th e CN C su spe nsion s co nsi dered in this work ha s alread y been characte r - ized in previous works [\[32,53](#page-11-11),55,63]. The initial concentration of the suspension was fixed to $C = 10$ wt%, *i.e*. within the biphasic region of th e phas e di agram co mpose d of isotro p icall y di stributed CNCs (isotropic phase) coexis tin g with th e anisotropi c ch ira l nemati c (chole s teric) phas e at a vo lum e fraction of li qui d crystallin e phas e $\phi_{LC} = 38 \text{ vol\%}.$

Thanks to SAXS, the space and time dependence of the concentration of CNCs an d thei r stru ctura l organization within th e channe l have been characterized as a function of the vertical distance z from the membrane surface to the ultrasonic blade, in the center of the 100 mmlong channe l unde r co mbine d ultr afi ltr ation an d ultr asound, hereafte r referred to as FU-US processing. The 35-µm vertical size of the X-ray beam (full-width at half maximum, FWHM) allowed for accurate scans of th e stru ctura l organization alon g th e ve rtica l dire ction du rin g FU -US pr ocessing. Th e time -dependen t ev olution of th e 2D SAXS pa ttern s wa s an alyze d usin g a mode l -free principa l co mponent anal ysi s [\[64\]](#page-12-4) , whic h allowed us to describe both the degree of orientation and the direction of th e alig nment of th e CN C dire cto r accurately as a function of *z* du rin g FU -US pr ocessin g in a time -resolved ma nner.

2 . Experimental sectio n

2. 1 . Materials. Preparatio n of th e CN C suspensions

CNCs were pu rchased from UMaine Deve lopment Ce nte r (Unive r sity of Maine, Orono, ME) as an aqueou s su spe nsion with a stoc k co n ce ntr ation C = 12.2 wt%. Th e su spe nsion s were pr epare d by dilution in deionized water and 0.01 mol.L-1 NaCl, followed by 2 h of vigorous stirring. They were then sonicated using a Branson Digital sonifier (Marshall Scientific, Hampton, NH) with a maximum power output of 25 0 W. A vo lum e of 25 0 mL of su spe nsion wa s so n icate d by appl yin g a 30 % duty cycle and output power of 0.5 W.cm⁻² under magnetic stir-ring. Following the procedure given by Taurozzi et al. [\[65\]](#page-12-5), and the normalization by the concentration and volume of the suspension describe d in [\[66,67](#page-12-6)] , th e no rma lized energy dose of so n ication pe r lite r of suspension is 43.7 kJ.L−1. The morphology of the CNCs considered in this work an d thei r phas e di agram in aqueou s su spe nsion have been studied in detail in previous work [\[63\]](#page-12-7). In particular, SAXS data from dilute su spe nsion s at rest , assu min g a pa rallelepipeda l shap e fo r th e sonicated CNCs, gave average dimensions of $121 \times 20 \times 5$ nm³ [\[32,](#page-11-11) 53] . In this work , th e co nce ntr ation of CN C su spe nsion s fi ltere d wa s fixe d at 10 wt % (6.2 5 vol%).

2. 2 . Experimental methods

2.2. 1 . Fronta l ultrafiltratio n -ultrasound -SAXS cell

An FU -US -SAXS cell wa s deve loped to mo n ito r *in situ* th e change s in th e dyna m ica l stru ctura l organization throug h time -resolved SAXS [\[50,](#page-11-12) 68]. As shown in [Fig.](#page-3-0) 1, the cell was made of transparent polycarbonate with a pa rallelepipeda l channe l with a 4 mm widt h alon g *x* , an 8 mm depth along *z* and a 100 mm length along *y*. A 3 mm-wide and 100 mmlong titanium vibrating blade was immersed from the upper part of the channel to a z distance $= 5600 \mu m$ from the ultrafiltration membrane su rface , defi nin g th e dept h of th e region wher e th e su spe nsion wa s stru cture d by FU -US pr ocessing. In orde r to appl y an acoustic radi ation force along the vertical direction *z*, this blade was connected to a sonotrod e (Sodev a TDS, Méry , France) co nsistin g of a piez oelectric tran sduce r attached to a meta l rod, whic h ge nerates ultr asoni c wave s at a frequency $f_{\text{US}} = 20$ kHz with an amplitude a_{US} [\[50,68](#page-11-12),69]. This amplitude was measured to $a_{\text{US}} = 1.6 \mu \text{m}$ using a vibrometry device consistin g of a se nso r head (OFV 353, Polytec, Waldbronn, Ge rmany), a ve -

locity decoder (OFV3001, Polytec) and an oscilloscope (DPO 3014, Te ktronix , Beaverton, OR).

In order to apply the FU-US protocol described in more details below, the feed suspension, referred to as the retentate, was pumped with a syring e from a tank co ntainin g th e CN C su spe nsion an d used to fill up th e whol e channel. An inle t vane an d an ou tle t vane were positioned at th e entrance an d exit of th e channel, respectively . A *T*-junction an d a pressure gaug e (F P 11 0 FG P Se nsors & Instrument) were placed be tween the outlet vane and the outlet of the filtration cell. The upper part of th e *T*-junction wa s co nnected to co mpresse d ai r an d th e pressure vane was used to protect the air circuit from the suspension during the fillin g of th e channel. Th e pe rmeat e wa s reco vered in a smal l tank an d the permeate flux *J* was monitored by measuring the mass variation of this tank rese rvoir ever y 10 s with an accuracy of 0.00 1 g usin g a pr eci sion scal e (Precisa 40 0 M Ba lance).

2.2. 2 . In situ Smal l -Angl e X-ray Scattering (SAXS) during FU-US processing.

SAXS me asurement s were pe rformed at th e TRUSAX S ID02 beam - line (ESRF, Grenoble) [\[62\]](#page-12-3). Measurements were performed at room temperature with a sample-to-detector distance of 10 m and an X-ray energy of $E = 12.230 \text{ keV}$ (wavelength $\lambda = 0.1014 \text{ nm}$), covering a range of scattering wave vector magnitude, *q*, of 0.005−0.7 nm−1, where $q = (4\pi/\lambda) \sin(\theta/2)$ with θ the scattering angle. The correspondin g no m ina l length scal e *l* (∼ 2 π / *q*) rang e wa s ca . 10 nm ≤ *l* ≤ 1200 nm . Thanks to the pinhole collimation setup available at ID02, all the measurement s were pe rformed usin g a beam cros s -sectio n (FWHM) at th e sample position of about 35 \upmu m vertically and 150 \upmu m horizontally. The incident beam passed throug h th e sa mpl e in th e FU -US -SAXS cell an d th e tw o -dimensiona l scattere d inte nsity pa ttern s were recorded on a high-resolution pixel array detector (Eiger2-4 M, Dectris) ([Fig.](#page-3-0) 1). Measured scattering patterns were normalized to absolute scale following th e standard pr ocedure [\[62\]](#page-12-3) . Du rin g th e expe r iments, th e X -ra y beam was directed along the *x*-direction perpendicular to the walls of the cell, through a window of 3 mm \times 5.5 mm \times 0.3 mm (width \times height \times thickness) positioned in the middle of the channel (*y* = 50 mm). A rotational stag e mounte d on th e sa mpl e tabl e wa s used to align the incident beam parallel to the membrane surface. A vertical tran slation tabl e wa s used to prob e th e stru cture at di ffe ren t z -position s abov e th e me mbran e su rface .

are the constant of the constant of the corresponding appropagation and the constant of the c Th e anal ysi s of th e no rma lized SAXS pa ttern s recorded in th e FU - US -SAXS cell wa s th e same as that alread y describe d in pr eviou s work s [\[51,52](#page-11-13),68,70]. Four regions were defined by measuring the transmitted X-ray signal as a function of the distance z through the FU-US-SAXS cell. This analysis has allowed defining the minimal distance *z* above which th e pe rmeat e channe l an d me mbran e scatte rin g di d no t infl uence th e scattered intensity. We defined this z_0 position as the origin $(z = 0)$. Th e mi n ima l di stanc e abov e whic h th e SAXS data were usable wa s then $z = 100 \mu m$ (determined by the planarity and roughness of the membrane). Systematic vertical scans along *z* were performed during FU-US processing, with SAXS pattern acquisitions every 50 μm from $$ to 500 μm and every 100 μm from $z = 500$ to 5600 μm. The onedimensional scattered intensity profile *I*(*q*) was obtained by azimuthally averaging the normalized scattering patterns. Before the FU-US expe r iment s with CN C su spe nsions, th e cell wa s filled with de miner alized water and the normalized background scattering of the cell was recorded. This background scattering of the cell filled with water was sy ste mat icall y su btracte d from th e scatte rin g of th e CN C su spe nsions. The azimuthal averages of the scattering patterns were calculated after patc hin g th e gaps betwee n th e dete cto r mo dules usin g th e SA XSuti l ities software [\[71\]](#page-12-8). Annular averages were also calculated using the SAXSutilities software over a *q*-range from 0.34 to 0.40 nm⁻¹ to define the scatte rin g inte nsity as a function of th e azimutha l scatte rin g angl e *ψ* in the plane of the two-dimensional 2D SAXS patterns to quantify the degree of or ientation as well as it s angula r vari ation . Th e anisotropy anal ysi s wa s pe rformed from th e 2D pa ttern s usin g th e MA TLA B -base d Smal l -Angl e Scatte rin g Eval u ation Tool (SASET) software [64] . Specifi cally, the model-free Principal Component Analysis (PCA) method was ch osen, whic h pr ovide s va lue s fo r th e anisotropy rangin g from 0 fo r isotropi c su spe nsion s to 1 fo r full y aligne d sy stems , and, dependin g on th e sy stem, whic h is quantitatively co mparabl e to th e co mmonl y used order parameter [64]. The anisotropy and the direction of maximum scattering ψ_0 were calculated via PCA in the (0.071–0.368) nm⁻¹ q range. Thes e ca lculation s allowe d us to quantify th e re l ative effect of FU an d US on th e degree of anisotropy referred to as *PCA anisotropy* an d on the orientation [maximum scattering direction (ψ_o)] of the CNCs during FU-US processing as a function of time *t* and distance *z* from the me mbran e su rface .

2.2. 3 . Structure factor an d calibratio n of cellulos e nanocrysta l scattering intensity.

In orde r to me asure th e CN C co nce ntr ation pr ofile as a function of fi ltr ation time s an d di stanc e *z* from th e me mbran e su rface , th e same anal ysi s as describe d in ou r pr eviou s work ha s been applie d [53] . First, a ca l ibr ation curv e wa s esta blished . To this aim, se veral CN C sa mples at di ffe ren t know n CN C co nce ntr ation s were me asure d by SAXS in st ati c co ndition s in a flow -throug h cell with a diam ete r of 2 mm . From th e scattering intensities $[I(q)]$ and the calculated form factor $[P(q)]$ (Fig. **S1**) [\[53\]](#page-11-14), the corresponding apparent structure factor, $S(q) \propto I(q)/P(q)$ was calculated for each known CNC concentration ([Fig.](#page-5-0) 2 **a,b**). As previousl y di scussed , in an effe ctive hard -cylinder mode l (a s an approx i mation of a repulsive potential), the q-value corresponding to the peak of *S*(*q*), denoted as q_{peak} in the following, is related to the average interparticle distance *d* via the relation $d = 2\pi/q_{peak}$. Using this relationship, the known CNC concentration was related to the average interparticle distance *d* inferred from the peak of *S*(*q*). As shown in [Fig.](#page-5-0) 2c, a powerla w fi t of thes e data gave access to th e relationship betwee n th e mass co nce ntr ation *C* an d *d* :

d = 84.08C^{-0.5} \text{ or, equivalently, } C = 8041d^{-2} \tag{1}

Second, from the scattered intensity *I(q)* measured at a given position in th e FU -US cell , th e appa ren t stru cture fa ctor, *S(q)* wa s ca lculate d at each time *t* an d di stanc e *z* from th e me mbran e su rface . From thes e *S (q)* the corresponding average interparticle distances $d = 2π/q_{peak}$ at each time *t* and distance *z* from the membrane surface were evaluated. Finally, using Eq. (1), the corresponding local mass concentration *C*(*z*,*t*) wa s ca lculated.

Another structural characteristic of these CNC suspensions is the organization in the cholesteric phase above a certain concentration threshold. Such a structural organization has been studied in detail at rest and under shear by small-angle light scattering in our previous works, which allowed measuring a pitch distance of about 5 µm at a concentration $C = 10$ wt% $[32]$. The helical pitch P corresponds to the di stanc e needed fo r a 360° rotation of th e dire cto r of on e nanocrysta l in the cholesteric phase, and *P* was reported to decrease with increasing co nce ntr ation [24,32 ,72 –74] . At th e co nce ntr ation studie d here , th e ch ole steri c phas e exists as microdomains , or ta ctoids, di stributed within the isotropic phase [75]. The volume fraction occupied by cholesteric tactoids at equilibrium was shown to be $\phi_{LC} = 38$ vol% in the present suspension at $C = 10$ wt% $[32,63]$ $[32,63]$.

2.2. 4 . Experimental protocol

Th e FU -US pr ocessin g co nsisted of th e fo llo win g pr ocedure . First, the cell was filled with the CNC suspension with an initial concentration $C = 10$ wt%. To this aim, the inlet and outlet valves were opened at the extrem ities of th e channel, th e pressure valv e wa s closed , an d th e su s pension was pumped from the tank with the syringe to fill up the whole channel. Th e inle t an d ou tle t valves were then closed an d th e pressure valv e wa s opened so that co mpresse d ai r wa s injected from th e T junc tion, allowing FU to start at time $t = 0$. Simultaneously, the US was activated.

Fo r al l th e me asurement s pr esented in this work , only on e acoustic radi ation forc e wa s applie d with a fixe d acoustic ampl itude a_{US} = 1.6 μ m. This corresponded to an acoustic pressure 30 0 kP a an d an acoustic powe r 6 W.cm⁻², where $ρ = 1000$ kg.m⁻³ is the water density and $\nu = 1480 \text{ m.s}^{-1}$ is the speed of sound in water. No cavitation was observed . Th e tran sme mbran e pressure wa s kept co nstan t an d equa l to $\Delta P = 1.2$ 10⁵ Pa. FU-US processing was applied for a total duration of 90 min. Meanwhile, th e ev olution of th e 2D SAXS pa ttern wa s mo n i tored and the corresponding permeation flux *J* was simultaneously recorded as a function of time *t* ([Fig.](#page-6-0) 3). As di splayed in [Fig.](#page-6-0) 3 , a fe w seconds after applying the transmembrane pressure ΔP , a rapid increase of the permeation flux J up to 20 L.h⁻¹·m⁻² was detected within abou t 1 s, fo llowe d by a steady decrease . Afte r 30 min, *J*, reache d an equilibrium at about 1 L.h−1⋅m−2, which is related to the well-known foulin g ph eno m eno n induce d by th e accumulation of CNCs near th e me mbran e su rface . As alread y reported in ou r pr eviou s works, th e ce l lulose nanoparticles are retained at the membrane surface inducing a concentration gradient and a resistance to mass transfer [50–[53](#page-11-12)].

3 . Result s an d discussion

3. 1 . Cartilage -like structural organization at equilibriu m unde r FU-US processing at time t = 88 mi n

Th e no rma lized *in situ* 2D SAXS pa ttern s me asure d across th e FU -US cell at time $t = 88$ min are shown in [Fig.](#page-6-1) 4. The SAXS patterns are presented fo r di stances *z* increa sin g from left to righ t an d from bo tto m to top. For clarity, the corresponding *z* distances in micrometers are indicated in each 2D SAXS pattern. Remarkably, the intensity level and the

or ientation of th e SAXS pa ttern s strongly depended on th e di stanc e *z* from th e me mbran e su rface . Four regions, hereafte r denote d as *Z1* to Z4, corresponding to different features of the 2D SAXS patterns in terms of dire ction degree of or ientation of th e CNCs have been identified .

(i) In th e supe rficial region *Z1* , whic h extend s from th e me mbran e surface $z = 0$ until up to about $z = 1000$ μ m, the pattern was anisotropi c an d elongate d alon g th e ve rtica l dire ction . Unde r th e effect of the transmembrane pressure, as previously observed [50–[53](#page-11-12)], a regular orientation of the CNCs with their long axis parallel to the membran e su rface (y -direction) is observed . (ii) In th e se con d region *Z2* ex tending from $z = 1000$ to 1400 μ m, the SAXS patterns evolved from slightly anisotropic, elongate d alon g th e ve rtica l dire ction $(z = 1000 \mu m)$, to perfectly isotropic $(z = 1200 \mu m)$ and finally to slightly anisotropic, an d elongate d in th e ho r izo nta l dire ction $(z = 1400 \mu m)$. This intermediate region corresponds to a transition wher e th e US an d tran sme mbran e pressure forces ba lance each other, which gives rise to an isotropic organization in the middle of this region . (iii) In th e thir d region *Z3* extendin g from *z* = 1400 to 5000 µm , the SAXS patterns were elongated in the horizontal direction and revealed an or ientation of th e CNCs with thei r dire cto r ve rticall y or iente d along the direction of US wave propagation (*z*-direction), *i.e.*, oriented pe rpe ndi c ula r to th e me mbran e su rface . In th e *Z1* , *Z2* , an d *Z3* regions, the SAXS patterns are stationary and only slightly fluctuated with time, showing a stabilization of the mean orientation direction of the CNCs, as confirmed in Figure S2 in the middle of *Z3* region. (iv) In the fourth region *Z4* denote d as a *boun dary laye r* clos e to th e su rface of th e US blade, which extends from $z = 5000$ to 5600 μ m, significant fluctuations of the 2D SAXS patterns at short time scales, below 1 s, were observed (**Figure S3**).

Th e azimuthall y averaged *I(q),* an d co rrespon din g *S(q)* of th e 2D SAXS patterns recorded at time $t = 88$ min in the channel as a function of the distance *z* from the membrane surface are plotted in Fig. 5. The general features of *I(q)* correspond well to the scattering of individualized CNCs at different concentrations, when compared to the scattering inte nsities of CN C su spe nsion s at a fixe d co nce ntr ation me asure d in a capillary [\(Fig.](#page-7-0) 2). In particular, *S(q)* (Fig. 5b) exhibits a maximum at a specific *q*-value, *q*_{peak}, which reveals a well-defined average interparticle distance *d*, as in [Fig.](#page-5-0) 2. This allowed us to confirm that the CNCs were well di stributed withou t bein g br oke n down or aggr egate d unde r th e effect of FU -US pr ocessing.

For each *z* position, the determination of *q*_{peak} from *S(q)* allowed us to calculate the concentration level reached in the different layers using **Eq . (1)** . Th e firs t acce ssibl e poin t me asure d closes t to th e me mbran e surface and calculated from the structure factor $(z = 150 \mu m)$, corresponds to an interparticle distance $d = 11.7$ nm, and a CNC mass fraction of $C = 59$ wt%. From $z = 150$ to 1200 µm, the peak position q_{peak} strongly shifte d to lowe r q -values , whic h implie s a su bstantial decrease of th e co nce ntr ation across th e supe rficial region , as show n in [Fig.](#page-7-0) 6 (see filled blue symbols), *i.e.*, a pronounced vertical concentration gradient. This effect co rresponds to th e co nce ntr ation pola riz ation laye r in membrane ultrafiltration processes [50–52[,68](#page-11-12)]. This deposit layer extends from $z = 150$ μ m with $C = 59$ wt% to $z = 1200$ μ m with $C = 16$ wt%, as depicted in Figs. 5 and 6.

Above $z = 1200 \mu m$ and up to the surface of the US blade at *z* = 5600 µm , th e peak position *q Peak* remain s unchange d an d yields an inte rpa rticl e di stanc e *d* = 22.6 nm , co rrespon din g to a un iform $C = 16$ wt% concentration. It is worth noting that this concentration is significantly larger than the concentration $C = 10$ wt% of the initial su spe nsion , whic h show s that th e FU -US proces s allowe d us no t only to concentrate the CNCs near the membrane surface as in a usual filtration process but also to concentrate the suspension in the whole bulk of the rete ntate , by th e effect of US . Th e la tte r ph eno m eno n is ce rtainly du e to a pe rmeatio n flux enhanced by th e loca l ag itation induce d by th e US force, as di scussed in pr eviou s work s [\[50,68](#page-11-12)] .

appa ren t stru cture fa ctor, *S(q)* of th e 2D saxs pa ttern s recorded at time t = 88 min under FU-US processing and different positions *z* from the membrane surface in a CNC suspension with initial concentration $C = 10$ wt% and 0.01 mol.L⁻¹ NaCl. The color code corresponds to the position *z*. $\Delta P = 1.2 \times 10^5 \text{ Pa}, f_{\text{US}} = 20 \text{ kHz}, \text{ and } a_{\text{US}} = 1.6 \text{ µm}.$

The very high concentration $C = 59$ wt% reached near the membrane surface, as well as the homogeneous increase from the initial concentration $C = 10$ wt% up to a constant value of $C = 16$ wt% from $z = 1200$ to 5600 \upmu m, show the ability of the FU-US process to concentrat e th e co lloidal su spe nsion . This ne w stru ctu rin g proces s coul d be an excellent way to design highly concentrated CNC-based materials. Indeed , othe r processe s allo win g fo r such a co nce ntr ation level, e.g. , high spee d ce ntrifugation or osmoti c pressure , woul d requir e pr ocessin g time s longer than th e 90 mi n FU -US pr ocessin g used in this work .

3. 2 . Time evolutio n of th e structural organization unde r FU-US processing (concentration an d orientatio n features)

In orde r to describe more quantitatively th e stru ctura l organization achieved unde r FU -US pr ocessing, we sy ste mat icall y pe rformed a Prin cipa l Co mponent Anal ysi s of th e anisotropy (*PCA anisotropy*) an d dete r mined the direction of maximum scattering ψ ₀ on the 2D SAXS patterns as a function of position z and time t [\[53,64](#page-11-14)]. Furthermore, the evolu-

tion of th e azimuthall y averaged scatte rin g inte nsity an d th e co rre sponding calculated structure factors *S(q)* have also been analyzed near th e me mbran e su rface to deduce th e co nce ntr ation pr ofile as a function of position *z* an d time *t* .

3.2. 1 . Time evolutio n of th e CN C concentratio n near th e membrane surfac e in th e superficia l region Z1

[Fig.](#page-7-0) 6 displays the time evolution of the concentration profiles *C* (*z*, *t*) computed from the characteristic q_{peak} value of the corresponding S *(q)* ca lculate d from azimuthall y averaged SAXS pa ttern s usin g **Eq . [\(1](#page-4-0))** . After *t* = 6 min of FU-US processing, an impressive 800 µm-thick conce ntrated layer, reac hin g a co nce ntr ation of abou t 43 wt % at $z\,=\,100$ μm, was already formed. Such a high concentration, reached within a rather shor t fronta l ultr afi ltr ation time unde r US , is most likely relate d to th e huge decrease of th e pe rmeatio n flux *J* from 20 to 1 L.h^{−1}.m^{−2} ([Fig.](#page-6-0) 3). In particular, as already discussed in previous studie s [\[50,68](#page-11-12)] , it coul d be associated with an effect of th e ag itation near th e me mbran e su rface induce d by th e US acoustic radi ation force. Afte r this in itial deposition , th e supe rficial laye r increase d in thic kness an d co nce ntr ation , unti l reac hin g a co nstan t thic kness of abou t 1200 µm after 36 min. This increase in deposit volume is due to the pressure gradient, which leads to the advection of the CNCs from the less concentrated layers far away from the membrane toward deeper concentrated layers in the direction of the membrane. This suggests that, in the presence of US, the concentration phenomenon is not an accumulation of indepe ndent la yers, as in a se d ime ntation process, bu t rather result s from the advection of all the particles from the top of the deposit toward s th e me mbran e su rface . Du rin g th e whol e FU -US pr ocessing, th e co nce ntr ation at th e to p of th e supe rficial region co nti n uousl y in creased from the initial concentration $C = 10$ wt% up to 16 wt%, yet without reaching a complete steady state. This phenomenon is expected from fronta l ultr afi ltr ation , sinc e th e fi ltr ation is pe rformed from an in itial fixe d vo lum e withou t an y fu rther su spe nsion feeding. Indeed , th e vo lum e of wate r (permeate) that goes throug h th e me m bran e implie s an increase in th e co nce ntr ation in th e rete ntate . Still, the increase of the total concentration in the retentate channel gets slower and slower due to slower advection as the concentration increases. This allowe d us to define a pseudo -steady state, fo r whic h th e time -dependen t co nce ntr ation an d or ientation ph eno men a were mostly stabilized at $t = 88$ min (see next section).

3.2. 2 . Time evolutio n of th e anisotropy an d orientatio n degree of CNCs from th e membrane to th e US blad e

[Fig.](#page-8-0) 7 show s th e time ev olution s of th e *PCA anisotropy* an d of th e di rection of maximum scattering ψ ₀ as a function of *z* for the four regions *Z1* to *Z4* identified an d describe d pr eviously.

To fu rther inve stigate this time -dependen t process, radial averages were calculated over a *q*-range from 0.34 to 0.40 nm−1 to define the scattering intensity *I* as a function of the azimuthal scattering angle ψ in the plane of the 2D SAXS patterns in order to quantify the degree of orientation as well as it s angula r vari ation .

3.2.2. 1 . Supe rficial region Z1 of anisotropi c co nce ntrated pola rized layer. A surprising phenomenon was detected in the superficial region *Z1* corresponding to the concentration polarization layer near

th e me mbran e su rface . Accordin g to ou r pr eviou s work s on th e same CNC system [51–[53](#page-11-13)], an increase in concentration toward the membrane was related to a continuous rise in anisotropy: the more conce ntrated th e sy stem, th e higher th e degree of anisotropy . Here , ho w ever , we report a no n -monotoni c ev olution of th e *PCA anisotropy* across region *Z1* : as depicted in [Fig.](#page-8-1) 8 , th e *PCA anisotropy* goes through a maximum at a particular distance *z* that depends on the FU -US pr ocessin g time . This " b ifu rcation " poin t is locate d at larger di stances from th e me mbran e su rface s as th e pr ocessin g time in creases, which is consistent with a thicker and thicker concentrated pola riz ation layer. Th e pr ogression of this effect is as fo llows : from $z = 1200$ μ m distance down to the membrane surface at $z = 0$, the anisotropy firs t increases, an d fo llows th e increase of co nce ntr ation , which is consistent with our previous works $[51-53]$ $[51-53]$ $[51-53]$ until the "bifurcation " point, wher e th e anisotropy starts to decrease down to th e me mbran e su rface . Anothe r wa y to chec k fo r such a proces s in th e opposite direction, *i.e.*, looking from the membrane surface towards increasing z distances, is presented in Figure S4, where the annular averages of scatte rin g inte nsities were ca lculate d over a *q* -rang e from 0.34 to 0.40 nm⁻¹ at time $t = 88$ min. The results confirmed the anisotropy increase fo r increa sin g di stances *z* from th e me mbran e surface until the "bifurcation" point at $z = 800 \mu m$ for this particular processing time. Above *z* = 800 μm, the anisotropy decreased with increa sin g di stances z from th e me mbran e su rface , unti l th e scatte rin g inte nsity *I* (*ψ*) showed a nearly flat pr ofile at *z* = 1200 µm (**Figure S5**).

Th e usua l increase of anisotropy at increa sin g co nce ntr ation is in duced by a nematic-like arrangement of the CNCs with all their directors aligne d alon g th e ho r izo nta l dire ction an d mostly around th e same angula r dire ction in th e (*x, y*) plane. Scanning electron microscopy (SEM) images of deposits have co nfirmed such an arrang ement afte r drying in the two perpendicular planes (x,y) and (x,z) [\[53\]](#page-11-14).

On e po ssibl e expl anation fo r th e decrease of th e anisotropy belo w th e " b ifu rcation " poin t toward s th e me mbran e su rface woul d be th e presence of a cholesteric organization in the layers close to the membrane. Indeed, in such a cholesteric arrangement, the CNC director would continuously change in direction in the (*x*,*y*) plane while describing the helix of the cholesteric organization oriented with its helical axis along the *z*-axis. The pitch of these chiral nematic CNC suspension s is know n to be of th e orde r of a fe w microm eters (aroun d 5 µm at $C = 10$ wt%, and lower for higher concentrations) [\[32\]](#page-11-11). Since the extent of the X-ray beam in the vertical direction is collimated to 35 μm (FHWM) , an d co nsi derin g that th e heli x axes ar e mostly aligne d alon g th e ve rtica l dire ction , th e scatte rin g inte nsity recorded at a position *z* would thus be representative of an average of the director orientations over se veral pitches, (i n agre ement with th e ho r izo nta l or ientation of

the CNC director, confirmed by the mean value of maximum scattering direction ψ_0 around 90° from $z = 0$ to 1200 μ m, see [Fig.](#page-8-0) 7b.

become spectral interaction and 18 methods are considered to the methods and the methods are considered to the consideration and interaction in the methods are considered to the methods are considered to the consider and This continuous variation of the CNC director orientation in the volum e probed by th e X -ra y beam induce s a decrease of th e anisotropy , co mpare d to th e si t u ation wher e a nemati c -like arrang ement is pr esent with a single mean CNC director orientation in the (*x*,*y*) plane. Considerin g th e high co nce ntr ation s reache d in thes e la yers, on e ca n infe r that th e stru ctura l organization goes from th e nemati c arrang ement us ually observed in thes e accumulate d la yer s in th e presence of shea r forces to a ch ole steri c organization abov e a pa rti c ula r co nce ntr ation [\[42,47](#page-11-5) –49] . Unde r th e co mbine d tran sme mbran e pressure an d US acoustic radi a tion force, it is very likely that this concentration limit evolves towards co nce ntr ation s larger than th e limi t of appearance of th e ch ole steri c or ganization in the equilibrium phase diagram $(C_i \sim 7.5 \text{ wt})$ and larger than th e se con d crit ica l co nce ntr ation co rrespon din g to th e onse t of th e fully anisotropic cholesteric phase ($C_{\alpha} \sim 13.3$ wt%). Indeed, the interparticle forces responsible for the cholesteric formation would compete with th e shea rin g forces induce d by th e flow of li qui d around th e CN C generated by the permeation flux and the US agitation. Consequently, a larger concentration is probably mandatory to nucleate a cholesteric arrang ement unde r FU -US pr ocessing. Future work should also chec k whethe r ta ctoid s form firs t an d whethe r thei r co nti n uou s increase in vo lum e fraction finall y result s in a co mplet e ch ole steri c organization as in equili brium co nditions. On e coul d also wo nde r whethe r th e transi tion mech anism from nemati c to ch ole steri c arrang ement fo llows th e same co nce ntr ation rang e unde r FU -US pr ocessin g as in equili brium co nditions, or as upon ce ssation of a high shea r flow [31] .

Anothe r fe ature su pportin g this hypoth esi s of a pr ogressively stronger cholesteric organization in the polarization layer is that for increasing processing times, the "bifurcation" point appears at larger and larger distances from the membrane surface and that the maximum *PCA anisotropy* at this "bifurcation" point increases linearly with the di stanc e from th e bifu rcation poin t to th e me mbran e su rface (Fig. 8). This supports the fact that when the formation of a cholesteric arrangement is reache d at th e " b ifu rcation " point, an increase of co nce ntr ation toward s th e me mbran e induce s more an d more ch ole steri c arrang e ments, *i.e.*, an increase of the volume fraction of the cholesteric arrangement relative to the nematic-like order. This would decrease the global orientation of the CNC director along a common direction, leadin g to th e redu ction of th e *PCA anisotropy* toward s th e me mbran e su r face .

3.2.2. 2 . Inte rmediate region Z2 of isotropi c orientation . In th e inte rmedi at e laye r from *z* = 1000 to 1400 µm , th e *PCA anisotropy* remained low and showed a minimum for $z \sim 1200$ μ m, *i.e.*, in the middle of region *Z2* (Fig. 7a). Concomitantly, the direction of maximum scattering ψ ⁰ evolved from 90 to 180° (Fig. 7b). The annular average of the scattering intensity confirms this reversal of orientation from $z = 800$ to 1400 μ m with a decrease of anisotropy until $z = 1200 \mu$ m (nearly flat pr ofile) fo llowe d by an increase of anisotropy at larger z di stances (**Figure S5**).

3.2.2. 3 . Deep region Z3 of anisotropi c orientation . As show n in Fig. 7a, in region *Z3* , th e *PCA anisotropy* steadily increase d from it s lo wes t level at *z* = 1200 μm until reaching a maximum value of 0.28 at z = 3600 \upmu m and further decreasing weakly towards the vibrating blade up to $z = 5000$ μ m, where another "bifurcation" signals the transition to the fourth region *Z4*. The corresponding annular average of th e scatte rin g inte nsity show s that th e anisotropy indeed increase s at th e begi nning of region *Z3* (**Figure S6**) an d then decrease s from *z* = 3600 to 5000 µm at th e to p of region *Z3* (**Figure S7).** Th e anisotropy in region Z3 corresponds to a well-oriented SAXS pattern elongated in the horizontal direction as confirmed by the value of ψ_0 180°, which confirms the vertical orientation of the CNC director in th e deep region .

3.2.2. 4 . Boun dary laye r region Z4 of decreasing anisotropi c orientation near th e US blade. In th e fourth region *Z4* extendin g from *z* = 5000 to 5600 µm , both th e anisotropy an d th e or ientation of th e 2D SAXS pa t tern s fluctuat e over a characte risti c time scal e belo w 1 s (**Figure S4**). This induces a decrease in the *PCA anisotropy* from about 0.2 to about 0.1, whic h is co nfirmed by th e change in th e ampl itude an d shap e of th e annula r averaged scatte rin g inte nsity (**Figure S7**).

Finally, it is worth noticing that the PCA *anisotropy* and the angle ψ _{*ι*} fo llo w si m ila r time ev olution s throug hou t region s *Z2* , *Z3* , an d *Z4* [\(Fig.](#page-8-0) 7), whic h implie s that th e co mplex stru cturation induce d by tran sme m bran e pressure in region *Z1* does no t si gni ficantly alte r th e effect of US in the upper regions, where the US acoustic force drives the orientation of CNCs .

3. 3 . Origin of th e orientatio n of CNCs induce d by th e US acoustic radiatio n forc e

As discussed in our previous work [\[55\]](#page-11-8), the question of the physical origin of the orientation of colloidal objects or molecules induced by US forc e ha s been addresse d by se veral authors. Th e main mech anism s have been summarized by Vitoriano [\[76\]](#page-12-5). Two mechanisms have been pr oposed. Fo r th e firs t mech anism , th e mo l e c ula r or ientation coul d re sult from acoustic streaming arising from convective stresses. The secon d mech anism is of elasti c nature an d linked to th e anisotropy of soun d absorption by li qui d crystals , which, accordin g to Pr igogi n ' s principle, must lead to the alignment of long nematic molecules in the direction of acoustic wave propagation [\[76\]](#page-12-5). From our initial analysis usin g th e same US equi pment ye t in th e absenc e of FU [\[55\]](#page-11-8) , th e most prob abl e expl anation is that th e firs t mech anism of acoustic streamin g woul d induce th e CN C or ientation unde r US ag itation .

Th e argument in favo r of this hypoth esi s is that th e time -dependen t evolution of anisotropy relaxation after cessation of US is of the order of a fe w mi nutes an d fo llows a stretche d expone ntial beha vio r associated with a co mplex stru ctura l change , involvin g se veral mech anisms, whic h does no t agre e with th e se con d mech anism associated to a faster elasti c proces s induce d by th e anisotropy of soun d absorption .

Anothe r argument in favo r of this expl anation base d on th e firs t mech anism of acoustic streamin g come s from th e fluctu ation of anisotropy detected near the surface of the US blade. In particular, it is well know n that th e US vibr ation induce s th e presence of a region with steady vorticity in a viscous boundary layer of thickness $\delta = (2\nu / \omega)^{0.5}$ close to the vibrating surface, where *ν* is the kinematic viscosity and *ω* th e angula r fr equency of th e acoustic wave . Such an " i nne r boun dar y layer streaming", also known as "Schlichting streaming", goes along with a counter-rotating streaming vortex within the bulk of the fluid, referred to as ''outer boundary layer streaming'' or ''Rayleigh streamin g " [\[77\]](#page-12-9) . Th e th eor y implie s that th e appearance of th e Rayleigh streaming phenomenon requires specific boundary conditions and confine d flow , si m ila r to th e ones in ou r sy stem. More pr ecisely , Schlicht ing or Rayleigh streaming is promoted when $\lambda \gg h \gg \delta_v$, where λ is the acoustic wavelength an d *h* is th e characte risti c length scal e of th e flui d chambe r [\[77\]](#page-12-9) . Fo r ou r expe r ime nta l setup, thes e co ndition s ar e indeed satisfied since ($λ_0 = 7.5$ cm) $\gg h = (3800 \text{ μm to } 5600 \text{ μm}) \gg δ_0 = (40$ to 126 μ m) when taking into account the range of variation of the viscosity of the CNC suspension ($\nu = 10^{-3}$ to 10⁻⁴ Pa.s). Furthermore, Tang and Hu [\[78\]](#page-12-10) have performed finite-element simulations of the acoustic streamin g fiel d ge nerated in a 2D re cta ngula r wate r chambe r by a vibrating source. An operating frequency of 20 kHz with amplitude of 10 0 nm , *i.e.* , th e same fr equency as in th e pr esent work ye t with an amplitude about 16 times lower than the amplitude $a_{_{US}} = 1.6 \, \mu \text{m}$ of our device. The simulations by Tang and Hu [\[78\]](#page-12-10) revealed that the acoustic streaming field is constituted of two kinds of vortices: (i) vortices distributed symmetrically on the right and left of the vibration source and confined near the vibrating source, *i.e.*, within the inner boundary layer vorticity, and (ii) counter-rotating streaming vortices within th e bulk of th e chambe r co rrespon din g to Rayleigh streamin g vo rtices. Co nsi derin g th e fluctu ation of anisotropy detected near th e su rface of th e US blad e (**Figure S4**), on e ca n infe r that th e co rrespon d ing region Z4 should pertain to the inner boundary layer, where a fast rotation of the CNC director is expected in agreement with the fluctuation s of anisotropy observed in region *Z4* . We ma y also hypoth esize that Rayleigh streaming vortices are developed in the bulk of the cell, so that th e co rrespon din g streamline s induce an alig nment of th e CNCs alon g the velocity field, *i.e.*, along the vertical direction, in agreement with the preferential vertical orientation observed in region *Z3*.

Ther efore , al l th e fe ature s di scussed here su ggest that Rayleigh streaming constitutes the physical origin of the orientation of CNCs induce d by th e US waves. Ne verth eless , deeper inve stigation s woul d be helpfu l to full y assess this hypoth esis, such as *in situ* me asurement s of th e velo cit y fiel d du rin g FU -US pr ocessing. This coul d be achieved by mean s of pa rticl e imag e velocimetr y (PIV).

4 . Conclusion s

An original combined frontal ultrafiltration (FU) and ultrasound (US) set-up compatible with *in situ* SAXS observations has allowed to reveal for the first time a multilayer orthotropic structuring of CNC suspe nsions, that mi mic s th e organization of arti c ula r ca rtilage . Thanks to mode l -free principa l co mponent anal ysi s an d annula r averaged scatte r ing intensities, we have accurately described both the degree of orientation and the direction of the alignment of the CNC director in the bulk of th e channel, from th e me mbran e su rface up to th e US blad e du rin g FU -US pr ocessin g in a time -resolved ma nner.

We have interpreted our observations, in particular the length scales and time scales involved in the spectacular alignment of the CNCs along th e ultr asoni c wave prop agation dire ction in term s of Rayleigh acoustic streaming initiated by the viscous attenuation of the acoustic waves ge nerated by th e vibratin g blade. This inte rpr etation remain s to be full y confirmed. *In situ* micro-PIV measurements could be a good way to assess th e vali dit y of th e Rayleigh streamin g sc enari o in future work . Fi nally, th e su ccessfu l co ntrol over th e averag e or ientation of CNCs by co mbine d FU an d US open s a ne w wa y fo r th e design of nove l ce llulosi c orthotropi c bi omimeti c material s with tu nable stru ctura l organization fo r ti ssu e engineerin g appl ications.
