## Complex chemical cocktail, containing insecticides diazinon and permethrin, drives acute toxicity to crustaceans in mountain lakes

#### 3 Abstract:

4 Mountain lakes have long been perceived as pristine environments. However, atmospheric 5 deposition of persistent organic pollutants (POPs) have been shown to expose these sensitive ecosystems to chemical pollution. Little is known on how this pollution impacts 6 aquatic ecosystems at high altitudes. We combined passive sampling with liquid and gas 7 8 chromatography high resolution mass spectrometry (LC- and GC-HRMS) to screen the water of eight lakes in three different regions of the French Pyrenees. In total, we screened for 479 9 organic chemicals including POPs, polycyclic aromatic hydrocarbons (PAHs), legacy and 10 current-use pesticides, biocides, and musk fragrances. We detected a complex cocktail of 11 151 individual chemicals and used their toxic unit summation ( $\Sigma TU$ ) to assess toxicity for 12 crustaceans and algae. While risks for algae never reached chronic risks, this was always 13 the case for crustaceans. Acute toxic risk thresholds for crustaceans were even exceeded in 14 15 several of our sites. At sites with acute toxic risk levels (> 0.1  $\Sigma TU$ ) crustaceans were 16 completely absent or showed a low abundance. We conclude that crustaceans were at least partly impacted by the high toxic risks driven by the insecticides diazinon and permethrin. 17 These drugs are widely used to protect livestock from blue tongue disease transmitted by 18 19 sucking insects, suggesting free roaming livestock as local source. Our results provide important evidence on toxic chemical pollution in relatively remote mountain areas, with 20 21 important consequences for aquatic mountain ecosystems.

## **1. Introduction**

Due to their remoteness, mountains and their lakes are perceived as pristine, healthy 27 28 environments. This perception has been proven wrong by a number of studies on chemical pollution in remote mountain environments. Persistent organic pollutants (POPs) have been 29 30 found to undergo atmospheric long-range transport and accumulate in remote polar regions (Wania and Mackay, 1996), but may also impact remote montane lakes (Daly and Wania, 31 2005; Fernandez and Grimalt, 2003). Polycyclic aromatic hydrocarbons (PAHs) were among 32 the first pollutants to be found in European mountain lakes. However, other substances, 33 hexachlorocyclohexanes hexachlorobenzene 34 such as (HCHs), (HCB), 35 dichlorodiphenyltrichloroethane (DDT) and polychlorinated biphenyls (PCBs), have been frequently detected in mountain lakes of the Alps, Pyrenees and Caledonia (Vilanova et al., 36 2001). The number of substances detected in mountain lakes has continued to grow and 37 38 now also includes brominated flame retardants, synthetic musks (Schmid et al., 2007), and 39 some current-use agricultural pesticides such as terbuthylazine, chlorpyrifos and pendimethalin (Ferrario et al., 2017; Santolaria et al., 2015). Long- and medium-range 40 atmospheric transport have been intensively investigated to understand pollution pathways in 41 remote areas (Wania and Westgate, 2008). In contrast, knowledge on the role of local 42 43 activities, such as traffic (Blumer et al., 1977), tourism, and pastoralism (Gassner et al., 1997; Weissinger et al., 2018), have been little studied as pollution sources in mountains. 44 Although impacts of pollution on mountain organisms have been investigated (Garcia-Revero 45 et al., 2005; Quirós et al., 2007; Sparling and Fellers, 2009), the contamination of mountain 46 47 lakes with organic micropollutants, pollution sources, and resulting toxic risks remain little understood. 48

Mountain lake ecosystems may be particularly sensitive to adverse effects of chemical pollution, as living conditions at high altitudes are extreme (Catalan et al., 2006), causing environmental stress to aquatic organisms. Due to this strong selective pressure, aquatic communities in mountain lakes, are often simple and consist primarily of microorganisms,

phyto- and zooplankton, macroinvertebrates, and a few amphibian species (Sánchez-53 Hernández et al., 2015). These species show life-history traits particular to mountain 54 55 organisms, i.e. increased fatty tissue and lifespan, which make them prone to accumulate organic pollutants. In combination with the increased sensitivity due to the high level of 56 prevailing environmental stress and the potential funnelling of organic pollutants in mountain 57 lakes (Daly and Wania, 2005; Kallenborn, 2006; Liess et al., 2016), mountain lake 58 ecosystems are particularly vulnerable to adverse effects of chemical pollution. While toxicity 59 60 at lower altitudes is known to be an important limiting factor of aquatic ecosystem quality (Machate et al., 2021; Posthuma et al., 2020), little is known about the extent and impact of 61 pollution induced toxicity in mountain lakes (Schmeller et al., 2018). 62

In this study, we provide a first overview on the exposure of mountain lakes of the French Pyrenees to a broad range of chemicals and related toxic risks. We combined passive sampling with liquid and gas chromatography high resolution mass spectrometry (LC- and GC-HRMS) to screen for 479 different compounds. These compounds include those known to undergo atmospheric transport and substances that might be introduced via local sources. We report potential impacts on freshwater plankton communities using a toxic unit (TU) approach.

## 72 **2. Material and Methods**

#### 73 2.1 Study area

Eight permanent mountain lakes of the French Pyrenees in three regions, (1) Lescun, (2) Neouvielle, and (3) Bethmale, were investigated (figure 1, table 1). Target lakes were selected to cover a wide geographic range to include different altitudes and contamination sources (tourism, pastoralism, and atmospheric deposition (table 1)). All lakes are positioned at altitudes ranging from 1714 to 2400 m and are not directly adjacent to urban areas or field 79 crops. We therefore assume that the direct input of organic micropollutants from domestic wastewater, industry, and field crops was negligible. In general, however, all lakes are freely 80 accessible to livestock and tourists, but to retrieve exact data on tourist numbers and 81 82 livestock is difficult, as tourists do not pay an entrance fee and most livestock flocks roam freely, even across the Franco-Spanish border. The lakes are often the only source of water 83 for livestock, which may stay close to the lakes. Livestock can move from one lake to another 84 and their activity radius is difficult to assess or map. We developed indices for tourism and 85 86 pastoralism as proxies for exposure pressure, as exact numbers of livestock or tourists are not available for our sites (table 1). The tourism index was calculated considering the 87 following factors: (a) proximity of the GR10, the most popular hiking trail in the Pyrenees, 88 does not lead to the sample site = 0 points, GR 10 leads to the sample site = 1 point, (b) 89 proximity of secondary hiking trails to the lakes (0 = absence, 1 = presence), (c) the distance 90 to the closest parking lot (distance >7.1km = 1 point, 5.1 to 7km = 2 points, 3.1 to 5km = 3 91 points, 1.1 to 3 km = 4 points, between 0 and 1 km = 5 points), (e) the presence or signs of 92 93 camping material and/or tents close to the lakes (absence = 0, presence = 1 point), observed 94 during the sampling.

The pastoralism index simply considers the complete absence of either horses, sheep or cattle (0 points), presence of one of the species (1 point), two of the species (2 points) or all three species (3 points).

#### 99 2.2 Passive sampling

100 Silicone rubber passive sampling devices (PSDs) were used to investigate the pollution 101 status of the lakes to avoid shortcomings of traditional whole water grab sampling. These 102 include the lack of representativeness in time, logistic challenges and limitations in pre-103 concentration of hydrophobic chemicals such as pyrethroids (Brack et al., 2017). PSDs are 104 light in weight, accumulate pollutants from the water phase and allow for a time-integrated 105 sampling (Booij et al., 2016; Schulze et al., 2011). Therefore, PSDs are the ideal sampling
106 technique when investigating the pollution of mountain lakes.

107 The PSDs were derived from translucent AlteSil<sup>™</sup> silicone sheets, with a size of 30 x 30 cm and a thickness of 5 mm, obtained from Altec Products Ltd., Victoria/UK. They were 108 prepared for sampling as described by Smedes and Booij (2012). Briefly, using a template, 109 the silicon sheets were cut into smaller silicon stripes of the size of 5.5 x 9 cm<sup>2</sup> and pre-110 cleaned via Soxhlet extraction with ethyl acetate. To ensure a sufficient removal of oligomers 111 112 and other impurities, each sheet was extracted for at least 40 h in total. Consecutively, the sheets were stored in methanol until spiking with performance reference compounds (PRCs) 113 (supplementary item (SI) 1). For spiking we equilibrated the silicon rubber in a methanol-114 water mixture for one week (Chepchirchir et al., 2017). The spiked membranes were dried 115 with lint-free tissue. They were subsequently placed on a polypropylene rope used for the 116 deployment in the field. For transport, they were wrapped in aluminium foil, vacuum packed 117 in a plastic bag, stored in a freezer at -20°C until deployment and transported on dry ice to 118 the respective mountain lake. 119

To cover potential temporal differences in pollutant exposure the PSDs were deployed in the 120 lakes at a depth of 0.3 to 1 m from late June to August (period 1) and August to September 121 (period 2) of 2018 (SI 2). The two sampling periods represent mountain summer and autumn, 122 respectively. They were chosen to cover most of the extent of the ice-free season, during 123 124 which pollutant input from the surrounding environment is possible. Exposure times varied between 38 and 49 days. Given the difficult logistics, no standard cage was used to deploy 125 the PSDs. The PSDs were attached in equidistant spacing on a polypropylene rope 126 (Chepchirchir et al., 2017). The rope was stretched between two stainless steel rods that 127 128 could be anchored into the embankment of the lake to keep the PSDs immersed in water during the sampling period. Before placing the PSDs back into their respective transportation 129 box and on dry ice, they were carefully rinsed with lake water to remove excess fouling and 130 debris. In the lab, the samplers were stored at -20°C until extraction. 131

#### 133 **2.3 Extraction of passive samplers**

Two silicon sheets per site were extracted twice at room temperature with 100 mL of 134 135 methanol for 24 h. This mild extraction procedure was chosen to avoid the loss of compounds due to volatilisation and extraction of oligomers (Brockmeyer et al., 2015). The 136 extracts were concentrated to approximately 2 mL using a rotary evaporator after adding 137 138 nonane as a keeper. Care was taken that the samples did not fall dry. The concentrate was 139 split into two aliquots, one for analysis by LC-HRMS and one for GC-HRMS. A volume of 20 mL ethyl acetate was added to the GC fraction before reducing the volume to approximately 140 2 mL. Finally, both extracts were transferred into evaporation fingers and evaporated under 141 the gentle stream of nitrogen to a volume of 0.5 mL. 142

#### 144 **2.4 Chemical analysis and data evaluation**

The extracts were screened for 479 target compounds using LC- and GC-HRMS. Targets included chemicals known to undergo long-range atmospheric transport (e.g. PCBs, PAHs and legacy pesticides like DDT and HCB). As novelty, we also included compounds assumed to not undergo atmospheric transport. Such compounds have not been investigated in the context of mountain lakes. The latter include current-use agricultural pesticides and biocides, personal care products, and industrial chemicals.

The semi-volatile hydrophobic analytes were comprised mainly of PAHs, PCBs and pyrethroid insecticides (N=142). They were measured using a QExactive GC system (Thermo) equipped with Thermal Desorption Unit (TDU-2; Gerstel, Mulheim/Ruhr, Germany) and a cooled injection system (CIS; Gerstel). The remaining analytes (N=337), primarily including herbicides, fungicides, insecticides and personal care products, were analysed using an UltiMate 3000 LC system (Thermo) coupled to a QExactive Plus MS (Thermo) with a heated electrospray ionization source (SI 3).

A set of method-matched calibration and internal standards, consisting of 9 (GC) and 40 (LC) 158 isotope-labelled compounds (SI 4), were used for quantification. Six levels of calibration 159 standards of concentrations of 2.5, 10, 50, 100, 250, and 1000 ng/mL were prepared. These 160 standards in ethyl-acetate or methanol (GC or LC compound mix, respectively) were spiked 161 on top of two silicon sheets. After letting the compound mixes and sheets equilibrate 162 overnight, the sheets were subjected to the same extraction procedure as the PSD field 163 samples. Target substances were allocated to their respective internal standards based on 164 165 similarity in retention time. Method detection limits (MDLs) were determined based on the lowest measurable concentration of the respective standard compound (Additional file (AF), 166 sheet 1). To check for potential contaminations from storage, transport and handling of the 167 sheets, laboratory and field blanks were prepared and analysed simultaneously. 168

169 LC-HRMS raw data files were converted to mzML data using the ProteoWizard MSConvert tool (v3.0.18265; Chambers et al., 2012). MZmine (v2.40.1) was used for peak detection, 170 sample alignment and target compound annotation (Pluskal et al., 2010) according to 171 Beckers et al. (2020). Finally, a blank correction, calibration and quantification of the 172 annotated target compounds were performed using the in-house R package MZquant 173 (v0.6.1) (SI 5). GC-HRMS-detected compounds were quantified with the software 174 TraceFinder 4.1 (Thermo Scientific). To visualize the data, the ggplot R package v3.2.1 was 175 used (Wickham, 2016). 176

#### 178 **2.5 Calculation of water concentrations and toxicological risk assessment**

The toxic risk to algae and crustaceans was assessed by means of TU summation (Ginebreda et al., 2014; Sprague and Ramsay, 1965). To this end, the measured PSD concentrations were transformed into time-integrated freely dissolved water concentrations based on the uptake rates of the analytes (Smedes and Booij, 2012) (SI 6). Preferably experimentally determined partitioning coefficients between PSD and water ( $K_{PW}$ ) were used (Smedes, 2018; 2019). If these data were not available, the UFZ-LSER database (Ulrich et al., 2017) was used to model missing partitioning coefficients via poly-parameter linear free
energy relationships (pp-LFERs) (AF, sheet 1).

Toxic units were summed up according to the mixture toxicity model of concentration addition (Backhaus and Faust, 2012) for algae ( $\Sigma T U_{Alg}$ ) and crustaceans ( $\Sigma T U_{Crust}$ ) (equation 1):

where  $c_{i,water}$  is the concentration of the analyte in water and  $EC_{x_i}$  is the effect concentration 190 191 (EC) at level x. Lethal and sublethal EC-values for both organism groups were retrieved from 192 the US EPA ECOTOX Knowledgebase (09/12/2020) and used to calculate the 0.05 quantiles (Q<sub>0.05</sub>) for each compound (Busch et al., 2016; Schulze et al., 2021). If no data were 193 available, EC<sub>50</sub>-values for algae and crustaceans were estimated by using baseline ECOSAR 194 1.0 (Mayo-Beana et al., 2009; Nabholz et al., 1998) type model in ChemProp 6.3 (UFZ 195 196 Department of Ecological Chemistry, 2016) (SI 7; AF, sheet 3 & 4). For algae, 33% and for 197 crustaceans 37% of the EC-values were extracted from the ECOTOX Knowledgebase and 67%, respectively 63%, were modeled via ECOSAR. The risk thresholds were set to 0.1 TUs 198 for acute toxic risk to algae and crustaceans, and 0.02 and 0.001 TUs for a chronic toxic risk 199 to algae and crustaceans, respectively (Malaj et al., 2014). 200

#### 202 2.6 Zooplankton abundances

203 Due to their central role in aquatic food webs and their high sensitivity to toxic pressures 204 (Beketov et al., 2013; Wolfram et al., 2021), crustaceans are frequently used as indicators of 205 pollution (Hanazato, 2001). We sampled zooplankton while the passive samplers were 206 retrieved. Two hundred litres of lake water were filtered through a plankton net with a mesh 207 size of 25 µm. The obtained filtrate was transferred into a 50 mL vial and preserved by 208 adding 3 mL of 30% formalin. In the laboratory, the zooplankton was stained with erythrosine, identified and counted under a microscope in a counting wheel. We used counts 209 210 of crustaceans, counts of rotifers and total counts of both species' groups, number of species

(= richness) combined and separate for crustaceans and rotifers to test pollutant impact on
 plankton communities.

#### 214 2.7 Statistical analysis

215 All statistical analyses and data computation were performed in R v3.5.1 (2018-07-02; R Core Team, 2018). As the dataset was relatively small and data were not normally 216 217 distributed, non-parametric tests were used. We used a paired Wilcoxon signed rank test to compare pollutant concentrations between the two sampling periods, and a Kruskal-Wallis 218 219 ANOVA to compare concentrations between regions.  $\Sigma TUs_{Crust}$  was compared between 220 sites with and without cattle using a paired Wilcoxon signed rank test. We used a Spearman rank correlation between *LTUs* (or pollutant concentrations) and the number of crustaceans, 221 222 rotifers observed, and species richness.

#### 224 2.8 Source attribution

To evaluate the contribution of the atmosphere and local activities as the source of pollution, 225 226 especially for the detected insecticides, we grouped the contaminants according to their use classes (AF; sheet 1). POPs (legacy pesticides, PCBs), PAHs, and agricultural plant 227 protection products (current-use herbicides and fungicides) were assumed to be deposited 228 from atmospheric transport. Insecticides used in non-agricultural applications (to treat 229 animals and as insect repellents for human use) were assumed to be introduced via local 230 sources. As huge differences in concentrations between the different pollutant groups 231 occurred, the additive concentrations were normalized to the maximum concentration 232 233 observed within the group, resulting in values between 0 (no detection) to 1 (maximum 234 concentration). Results are displayed in form of a heatmap (R package "ComplexHeatMap"; 235 function "heatmap"; Gu, 2016).

### 237 **3. Results**

#### 238 **3.1 Water contamination**

In total, 151 compounds were detected in the PSDs (AF; sheet 1). For 141 compounds, 239 freely dissolved water concentrations were quantified (AF; sheet 2) (details on excluded 240 241 substances in SI 8). These compounds include: 37 POPs (eleven PCBs, ten legacy pesticides), 16 PAHs, 44 current-use pesticides and biocides (nine insecticides and 242 repellents for human and veterinary use, 24 fungicides and eleven herbicides), and 60 243 244 diverse compounds (e.g. those used in fragrances, cleaning products and personal care 245 products (SI 9). Four compounds were detected in all samples at concentrations higher than 10 ng/L. They include the fungicide azoxystrobin with concentrations of up to 41 ng/L (factor 246 of 15 higher than lowest concentration), the herbicide terbuthylazine with a maximum 247 248 concentration of 12 ng/L (40 times higher than lowest concentration), benzothiazole with its 249 highest concentration of 90 ng/L (70 times higher than lowest concentration) and the insect 250 repellent DEET (chemical name: N,N-diethyl-meta-toluamide) with a maximum concentration 251 of 627 ng/L (900 times higher than lowest concentration). In addition to these ubiquitous compounds, 24 compounds exhibited a detection frequency of more than 70%, including 252 eight fungicides, three herbicides, the insect repellent icaridin, the legacy pesticide HCB, 253 PCB 18, and 10 compounds of diverse use. The highest maximum concentration was found 254 for diphenyl phosphate (19 µg/L), a compound used as an additive in paints and coatings. It 255 was detected in a total of three samples. Higher concentrations were also detected for 256 257 benzenesulfonic acid (6.6 – 10  $\mu$ g/L), used in household products and as a surfactant, and the transformation product terbuthylazine-desethyl-2-hydroxy of the herbicide terbuthylazine 258 (2.1. 3.9 µg/L). Concentrations of the same magnitude were detected in six of the 16 259 samples. Higher concentrations were also found for the phytochemical genistein with 1.7 260  $\mu$ g/L, which is probably of natural origin, and DEET with 627 ng/L. 261

Lakes in the Neouvielle region showed the lowest number of detected pollutants (average number of pollutants detected across lakes: summer = 40; autumn = 47; AF sheet 1). In the regions Lescun (summer = 67; autumn = 64) and Bethmale (summer = 68; autumn = 58) the

number of detected pollutants was consistently higher, corresponding to the higher 265 precipitation in those regions as compared to Neouvielle (table 1). In our summer samples, 266 267 there was a significant difference of pollutant concentrations between regions for PAHs ( $K_{2,7}$ = 5.396, p = 0.025), UV-filters ( $K_{2,7} = 5.000$ , p = 0.037), and compounds classified as other 268  $(K_{2,7} = 6.250, p = 0.005)$ , with the Neouvielle sites being the least polluted, except for 269 270 compounds classified as other. Such differences were not significant for the autumn samples 271 alone. When pooling summer and autumn samples, we observed significant regional differences in the concentrations of PAHs ( $K_{2,15} = 5.867$ , p = 0.023), fungicides used in 272 biocidal applications ( $K_{2,15}$  = 6.870, p = 0.011), veterinary insect repellents ( $K_{2,15}$  = 4.776, p = 273 0.045), and UV-filters ( $K_{2,15} = 6.195$ , p = 0.019). Sites in the Neouvielle region were the least 274 polluted across all our samples from 2018 (AF sheet 1). 275

Concentrations between sampling periods (n = 8) were only significantly different for insect repellents applied on humans (summer: 185 +/- 80 ng/L; autumn: 108 +/- 49 ng/L;  $S_{15}$  = 3416, p = 0.023) and legacy pesticides (summer: 0.72 +/- 0.26 ng/L; autumn: 1.4 +/- 0.3 ng/L;  $S_{15}$  = -18, p = 0.008) with higher concentrations in summer and autumn, respectively.

#### 3.2 Risks to plankton communities

The toxic risk for algae ( $\Sigma TUs_{Alg}$ ) (AF, sheet 3) ranged from 1 x 10<sup>-3</sup> to 0.01  $\Sigma TUs$ . The 282 highest  $\sum TUs_{Alg}$  were observed in Puits (0.01  $\sum TUs_{Alg}$ ) in both periods, followed by Gourg 283 de Rabas (6 x 10<sup>-3</sup>  $\Sigma TUs_{Alg}$ ), and Madamete Bas (summer, 6 x 10<sup>-3</sup>  $\Sigma TUs_{Alg}$ ; autumn, 4 x 10<sup>-</sup> 284 285  $^{3}\Sigma TUs_{Alg}$ ) of the Neouvielle region, and the lakes of the Bethmale region during summer (8 x  $10^{-3} \Sigma T U s_{Alg}$  (figure 2A). Neither the threshold of 0.1  $\Sigma T U s_{Alg}$  for acute toxic effects nor the 286 threshold of 0.02  $\Sigma TUs_{Alg}$  for chronic toxic effects was exceeded. Main drivers of toxicity 287 were the agricultural herbicides terbuthylazine and atrazine, and the fungicides spiroxamine 288 and azoxystrobin. Terbuthylazine and atrazine contributed 0.02  $\Sigma TUs_{Alg}$  and 0.003  $\Sigma TUs_{Alg}$ , 289 respectively, while spiroxamine and azoxystrobin contributed 0.02  $\Sigma TUs_{Alg}$  and 0.01  $\Sigma TUs_{Alg}$ 290

to the overall toxicity for algae. These four compounds accounted for 66.6 +/- 4.4% of  $TUs_{Alg}$ and were present in our lakes at all times.

The toxic risk for crustaceans ( $\Sigma TUs_{crust}$ ) (AF, sheet 4) ranged from 1 x 10<sup>-3</sup> to 0.25  $\Sigma TUs$ 293 and exceeded the threshold for chronic toxic effects of 1 x 10<sup>-3</sup> TUs at all sampling sites in 294 both sampling periods (figure 2A). The threshold of 0.1 TUs for acute toxic risk was 295 296 exceeded four times, twice in Ayes, once in Acherito (summer) and Ansabere (autumn). The 297 two insecticides diazinon and permethrin, which are used to protect livestock from sucking insects, predominated  $\Sigma TUs_{crust}$  ten of our 16 samples. In total, diazinon and permethrin 298 cause 0.37 and 0.44  $\sum TU_{Crust}$ , respectively. When present, permethrin contributes 66.5 +/-299 7.2%, and diazinon 37.1 +/- 9.9% to  $TUs_{Crust}$ . Generally,  $\Sigma TUs_{Crust}$  was about four times 300 higher in sites with cattle present (0.088 +/- 0.096) as compared to sites without (0.017 +/-301  $0.036; U_7 = 50, p = 0.065).$ 302

With increasing  $\Sigma TUs_{Crust}$ , we observed a decreasing count of crustaceans ( $R_{14} = -0.629$ , p = 0.011). The correlation was driven by the concentrations of diazinon ( $R_{14} = -0.745$ , p = 0.001) and permethrin ( $R_{14} = -0.681$ , p = 0.005), but not that of  $\Sigma TUs_{Crust}$  of the other compounds ( $R_{14} = -0.028$ , p > 0.05). The richness of rotifers declined with increasing  $\Sigma TUs_{Alg}$  ( $R_{14} = -0.554$ , p = 0.028) (table 2).

#### 309 **3.3 Indication for atmospheric transport**

Compounds expected to be introduced to the mountain lakes via atmospheric deposition 310 311 (PCBs, PAHs and field crop pesticides) were omnipresent in the mountain lakes under investigation. In contrast, veterinary insecticides, for which an atmospheric input is much less 312 plausible and local sources are available, were only detected in certain lakes (figure 3). 313 314 Similar to atmospheric pollutants, insect repellents used on humans could also be detected in all samples, but higher concentrations were only detected in the lakes Ayes, Acherito, 315 Ansabere and Coueyla Gran. In the same lakes, trace amounts of diazinon and permethrin 316 were detected. Compounds expected to be introduced via atmospheric deposition exhibited 317

a different distribution, with their greatest concentrations in Puits, Ansabere and Gourg deRabas.

## 320 **4. Discussion**

We performed an extensive chemical screening, including more than 400 compounds, in 321 mountain lakes of the French Pyrenees. We found a complex cocktail of 141 chemicals 322 including POPs, pesticides, biocides, and synthetic musk compounds at mostly background 323 levels. Except for POPs and some of the musk compounds, most of the compounds reported 324 325 here were detected for the first time in mountain aquatic ecosystems. In particular, the two 326 veterinary biocides diazinon and permethrin have been found at concentrations expected to 327 cause toxicity to crustaceans. The toxic concentrations of these compounds may have 328 caused substantial changes in zooplankton communities with likely repercussions for the 329 overall functioning of aquatic mountain ecosystems. We also detected a range of biocides 330 toxic to algae, but did not observe chronic toxic risks, suggesting that the risk for primary producers might be low. However, rotifer species richness was negatively correlated to 331 biocides toxic to algae, suggesting an indirect effect through selective algal survival. 332

333 Our results agree with previous observations of the impact of insecticides on the composition 334 of zooplankton communities and food webs (Giddings et al., 2001; Groner and Relyea, 2011; 335 Hanazato, 2001). Larger, probably more sensitive taxa, such as crustaceans, occurred in lower abundances or were absent in lakes with acute toxic risks. In contrast smaller, less 336 337 sensitive plankton taxa, such as algae, rotifers and ciliates, did not show a clear association with  $\Sigma TUs_{Crust}$ . Particularly, diazinon and permethrin seem to play an important role in the 338 toxicity in our study sites. Due to its very high toxicity to crustaceans, diazinon is frequently 339 identified as a driver of invertebrate toxicity in waste and surface waters as soon as 340 concentrations exceed the detection level (Beckers et al., 2018; Kandie et al., 2020; Moschet 341 342 et al., 2014). Since 2007, the EU has banned diazinon, an acetylcholinesterase inhibitor, from plant agricultural use. However, diazinon is still allowed in veterinary applications to 343 treat pets and livestock against a large range of ectoparasites. Similarly, permethrin is not 344

registered for applications in agriculture and forestry in the European Union since 2000, but 345 is still used in veterinary and human medicine against acarian, lice, fleas and mosquitoes 346 347 (Lewis et al., 2016) and can also be found in insect repellents for human use. We suspect an 348 entry to our study lakes by livestock and/or tourists. Atmospheric transport appears unlikely, due to the lack of use for field crop and the deviating spatial distribution of both compounds 349 as compared to compounds introduced via the atmosphere (e.g. current-use plant protection 350 351 products; Ferrario et al., 2017; Santolaria et al., 2015; Silva et al., 2017). Both insecticides are applied directly to livestock, including sheep, cattle, and horses via ear tags or sprays 352 (Bhushan et al., 2017; Reeves et al., 2010), from where they emit into the environment and 353 cause long-lasting contaminations (Gassner et al., 1997). 354

355 An increased use of insect repellents containing diazinon and permethrin for the protection of 356 cattle from sucking insects appears to be likely, linked to outbreaks of the blue tongue disease. Blue tongue disease is a vector-borne viral disease of livestock transmitted via 357 sucking insects, and has occurred in Europe since the early 2000s. Its presence is linked 358 back to climate change, and has caused the death of millions of animals at huge financial 359 costs (Jones et al., 2019). Particularly, at the beginning of the blue tongue panzootic in 360 Europe in 2006, there were no vaccines available against bluetongue virus serotype 8. The 361 strategy followed by France and across the EU was then based on animal movement 362 restrictions and epidemiological surveillance of infected areas, combined with disinsectization 363 364 operations of cattle and stables. In 2021, the blue tongue disease was still a notable disease in the EU (European Parliament, 2016) and cattle must be protected against insect vectors. 365 366 Free roaming livestock therefore are suspected to act as a major source of permethrin and diazinon input into the studied mountain lakes. 367

Our study is the first that detected a wide range of current-use pesticides in mountain lakes. Previous studies reported the presence of the low volatility herbicide terbuthylazine in mountain lakes of the Pyrenees and glaciers in the Italian Alps (Ferrario et al., 2017; Santolaria et al., 2015). The reported concentration levels ranged from 0.32 ng/L (August

2014) to 2.27 ng/L (July 2011) in the water of the Pyrenean lake Sabocos and reached a 372 maximum level of 1.98 ng/L in the melting waters of the Lys Glacier (Italy). These levels are 373 374 similar to those observed in our Pyrenean sites. Here we contribute to increasing evidence that current-use, low volatility pesticides, traditionally deemed unavailable for atmospheric 375 transport (SI 10), may undergo aerial transport from field crops into remote regions (Silva et 376 al., 2017). Atmospheric transport from lower altitudes to our high altitude lakes in the 377 378 Pyrenees seems likely, as the detected pesticide inventory is in agreement with observations 379 in the Ebro River basin (located at the foothills of the Spanish Pyrenees; Ccanccapa et al. 2016), and other waterbodies of Europe (Fang et al., 2019; table 3). . However, peak 380 concentrations in agricultural areas are several orders of magnitude higher than in mountain 381 lakes (Fang et al., 2019). Such peaks in pesticide concentrations occur at times of pesticide 382 application when surface runoff from areas of plant production or peak discharges of 383 wastewater occur. These peaks often dominate risks in agricultural streams at low altitudes 384 (Liess et al., 2021). One may therefore assume that the risk for mountain lakes by field crop 385 386 pesticides is lower than for water bodies at lower altitudes. However, since mountain 387 organisms are likely more sensitive to chemical pollutants than organisms at lower altitudes 388 (Kallenborn, 2006) a detailed impact analysis is needed to better understand changes driven 389 by chemical pollution of mountain lakes.

390 In addition to insecticides from veterinary applications, we also detected the insect repellents 391 DEET and icaridin used in human applications. They have been detected in most of our samples and in highly variable concentrations ranging from 0.7 to 627 ng/L for DEET and 0.4 392 393 to 31 ng/L for icaridin. While icaridin is not well investigated, the measured DEET concentrations extend from background contamination levels to levels similar to those 394 395 observed in surface waters close to urban and field crop regions (Costanzo et al., 2007). The broad distribution in the Pyrenees may hint to a local impact by tourists combined with 396 atmospheric deposition. More detailed studies are needed to better discern between local 397 398 and atmospheric sources of pollution in a mountain context. Our study, however, suggests 399 that the lower diversity of chemical pollutants found in the Neouvielle region as compared to

the other two regions is caused by the different precipitation schemes in the different regions.
This strengthens our notion that chemical pollution in the French Pyrenees is driven by a
combination of local sources and atmospheric transport.

## 403 **5 Conclusion**

Our study demonstrates that remote mountain lakes are not only impacted by the 404 atmospheric transport of POPs, but suffer from a more general introduction of pollutants, 405 including local sources. While overlooked so far, free roaming livestock may introduce 406 407 considerable levels of contaminants such as the two highly toxic insecticides diazinon and permethrin. The introduced quantities are sufficient to cause acute or chronic toxic stress to 408 and are one of the drivers of changes in planktonic communities. Such stress and changes 409 410 may further be enhanced by local pollution sources, such as tourists. In more general terms, 411 the pollution-induced changes in the planktonic community may impact on ecosystem functioning and ecosystem health, with a high potential to also reduce e.g. water quality 412 (Schmeller et al., 2018). More specifically, the observed impact of diazinon and permethrin 413 414 on zooplankton may also harm a known biological barrier to the amphibian pathogenic 415 fungus Batrachochytrium dendrobatidis (Deknock et al., 2020; Schmeller et al., 2014). The 416 changes in the zooplankton community induced by chemical pollution may therefore also 417 allow a deadly pathogen to increase its impact on amphibians, key biological elements in mountain lakes. The high diversity of chemical compounds detected in our study highlights 418 419 the need to consider chemical mixtures as drivers of biological change (Machate et al. 2021; Posthuma et al. 2020) with potentially far reaching risks for animal and human health 420 (Bernardo-Cravo et al., 2020; Schmeller et al., 2020). An improved large-scale environmental 421 monitoring, including remote areas, must be set up to allow better prediction of 422 423 environmental, animal and human health risks.
